## ATTACHMENT TO COLUMN NO.12 OF THE FIRST INFORMATION REPORT IN VIGILANCE AND ANTI CORRUPTION, VELLORE DETACHMENT CRIME NO.12/2020

Sir, Submitted,

A Preliminary Enquiry was conducted against Tr.S.Chinthamani, Assistant Director of Horticulture, Nemili Block, Vellore District, on the allegation of misappropriation of Government funds allotted for the training and tour programme for farmers under Perimetro Vegetable Cluster Development Programme between 27.10.2014 and 15.11.2014 to the tune of Rs.3,85,500/- and caused loss to the Government exchequer.

The Preliminary Enquiry discloses following information.

The accused Tr.S.Chinthamani worked as Assistant Director of Horticulture, Nemili Block, Vellore District from 02.08.2013 to 18.10.2015 and now retired. The accused is a Public servant comes under the purview of 2 (c) of Prevention of Corruption Act 1988.

The Preliminary enquiry reveals that the Tamil Nadu Government implemented a subsidy scheme called Perimetro Vegetable Cluster Development Programme. The objective of the scheme is to increase the productivity of vegetables and enable farmers to sell their products on their own and make vegetables to people at affordable cost. The farmers who cultivate high yielding vegetable would be given 50% subsidy apart from other training.

The programme was being implemented across the state through the Horticulture Department. The members of the Perimetro Vegetable Cluster Development Programme was taken to a training within the state by the Horticulture Department and for that the Tamil Nadu Government sanctioned Rs.1500/- to each participant of the tour programme.

The Commissioner of Horticulture, Chennai had sanctioned Rs.16.46 lakhs to the Deputy Director, Horticulture, Vellore Vide Letter in G.O No.10681/2011 dt. 20.06.2013 towards training and tour programme for the famers. Tr.S.Chinthamani, Assistant Director of Horticulture, Nemili Block, Vellore District was allotted with Rs.13,50,000/- on 23.09.2014 and 26.09.2014 by the Deputy Director of Horticulture, Vellore for arranging two days training and tour programme for 900 farmers under the Perimetro Cluster Development Programme.

Rs.1500/- was sanctioned to each farmer towards two days training and tour programme for the following expenditures, Rs.25/- for refreshment, Rs.100/- for stipend, Rs.250/- for transportation, Rs.100/- for lunch, Rs.125/- for preparation of training material, Rs.50/- for publicity and documentation and Rs.100/- for accommodation for per farmer per day.

The enquiry reveals that the accused Tr.S.Chinthamani, formerly Assistant Director of Horticulture, Nemili Block, Vellore District, now retired while working at Nemili Block conducted tour and training programme for 900 farmers under Perimetro Vegetable Cluster Development Programme for 18 days from 27.10.2014 to 15.11.2014 for a batch of 100 farmers and they were taken to Krish Vigyan Kendra, at Virinchipuram in Vellore District and Thanipadi in Tiruvannmalai District in two buses for the two days training.

The accused Tr.S.Chinthamani, formerly Assistant Director of Horticulture, Nemili Block, Vellore District without actually incurring the expenses towards Tiffin/Tea/Coffee/Snacks, Handbook and Accommodation charges for 900 farmers and without giving Honorarium to the farmers of Thanipadi who attended the training had created forged bogus bills, made false records and fabricated false accounts and misappropriated the amount to the tune of Rs.3,85,500/- among the total amount of Rs.13,50,000/- allotted and caused revenue loss to the Government exchequer, thus the accused officer Tr.S.Chinthamani, formerly Assistant Director of Horticulture, Nemili Block, Vellore District committed offence punishable u/s. 167, 420, 467, 468, 471, 477 (A), 409 IPC and 13 (2) r/w 13 (1) (c) of Prevention of Corruption Act 1988.

The prior permission for registration of a Regular Case against the Accused officer is obtained from the concerned Head of Department.

Hence, I register a case in Vigilance and Anti-Corruption, Vellore Detachment in Cr.No.12 / 2020 against Tr. S.Chinthamani, formerly Assistant Director of Horticulture, Nemili Block, Vellore District now retired, u/s.167,420,467,468,471,477(A), 409 IPC and 13 (2) r/w 13(1)(c) of Prevention of Corruption Act.1988 on 03.11.2020 at 11.45 hours. The original FIR is submitted before the Hon'ble Chief Judicial Magistrate and Special Judge, Vellore and the copies are sent to the concerned officers.
