Chandrasekar, Taluk Excise Officer cum Deputy Inspection cell officer, I was directed by ADSP, CSU III. a case in V&AC Cr.no: 14/AC/2020/CC- II was registered on 16.12.2020 at about 06:00 hrs. The content of the complaint runs as follows: A joint surprise check was conducted on 15.12.2020 on the credible information that the officials of the TASMAC Imported Liquor Shop No.441, indulged in mal practices in sale transactions. This joint surprise check was conducted by Tr.T.Chandrasekharan, Taluk Excise officer cum Deputy Inspection Cell Officer, Perambur Taluk, Chennai -11 and Vigilance officials headed by Tr. Srinivasaperumal, ADSP, CSU-III. The joint surprise check was commenced at 21.45 hrs at Tasmac Shop No.441 located at Alsa mall basement of No.4, Montienth Road, Egmore, Chennai. The following are the components of the joined surprise check team.

The Tasmac shop no 441 was at the Northeastern side of the basement measuring to the extent of 930 Sq.ft at Alsa Mall complex and its godown is situated at South western side of the Alsa mall building. Rishab Jewellers shop and Rainbow Gems and Jewellery were found adjacent to the Tasmac shop.

During the Joint Surprise check the sales man Tr.Shanmugam and Assistant sales man Tr.K.Meganathan are present. The supervisors

Tr.C. Krishnan and Tr.Mayilvaganan who were supposed to be present were not seen. Tr.J. Shanmugam. Asst Salesman. stated that the 208 Liquor case box and 180 Beer Case box to the MRP value of Rs.25,00,920/- were stocked today (15.12.2020) as opening balance and yesterday's(14.12.2020) sales amount of Rs.2,00,150/ cash- was remitted to ICICI Bank, Chetpet Branch vide S. No. 10940495 and Rs.1,87,660/- was remitted through Card transaction and closing balance on 14.12.2020.

2.14,986/- was handed over to Tr J Shanmugam and directed to deposit the cash in the concerned bank immediately

During this surprise check statement of witnesses viz namely Tr Shanmugam and Tr. Meganathan reveals about paying daily bribe of Rs 5000/- to District Manager Tmt Jeyanthi, Supervisor C.Krishnan of Rs 1500/-. Additional supervisor Tr. Mayilvaganan of Rs.1500/- and for himself Rs 1200/-Assistant sales man Tr.K.Meganathan of Rs.800/-, Salesman Tr.Gnanasekar of Rs.1200/- and Tr. S. Muthu, helper a private individual of Rs. 300/- and their statements were recorded. Sales man Shanmugam further stated that some amount may be taken by the supervisor Tr. C. Krishnan when he came to Tasmac shop in the afternoon on 15 12.2020 when he has gone outside
