

The following information was gathered during the collection of information against the Accused noted in the margin. A-1 Tr.S.Libendar Babu worked as Assistant at the office of the Sub Registrar, Katpadi, Vellore District. He joined in the Government Service on compassionate ground on 29.07.2011 as Junior Assistant at the office of the Sub Registrar, Ambur and worked till 07 09 2016

- 2. Further he was transferred to office of the Sub Registrar, Vaniyambadi on 07.09.2016 and got promotion as Assistant on 30.12.2016. On 26.11.2018 he was transferred to Katpadi and worked till 30.01.2020 and then on deputation basis he was transferred to office of the Sub Registrar, K.V.Kuppam. During the commission of offence from 01.04.2016 to 31.03.2019 he worked at the office of Sub Registrar, Vaniyambadi and Katpadi.
- 3. The Accused -2 Tmt.G.Amsaveni W/o Libendar Babu is presently serving as Secondary Grade Assistant in Panchayat Union Primary School, Kizh Krishnavaram Village, Anaicut Taluk, Vellore District. She joined on 14.12.2009 in the Government Service at Chinthagamanipenda Panchayat Union Middle School, Natrampalli and worked till 21.09.2011 after that she was transferred to Panchayat Union Primary School, Kizh Krishnavaram Village, Anaicult Taluk, Vellore District.
- 4. A-1 Tr.S.Libendar Babu, Assistant, O/o the Sub-Registrar, Katpadi, Vellore District and A-2 Tmt.G.Amsaveni, Secondary Grade Assistant, Panchayat Union Primary School, Kizh Krishnavaram, Anaicut Taluk, Vellore District are public servants as defined us 2(c) of the Prevention of Corruption Act 1988 during the period of commission of offence.

- 5. Collection of sources reveals that the Accused Officer-1 Tr.S.Libendar Babu hails from a middle class family. He is a native of Katpadi, Vellore District. The Accused-2 Tmt.G.Amsaveni W/o Libendar Babu is a native of Sedhuvalai Village in Anaicut Taluk, Vellore District. She also hails from middle class family and they are gifted with two children.
- 6. It is gathered that the Accused-1 Tr.S.Libendar Babu intentionally enriches himself illicitly, in the name of his wife Tmt.G.Amsaveni during the period of his office in various places. Most of the acquisitive activities of Accused-1 Tr.S.Libendar Babu and Accused-2 Tmt.G.Amsaveni falls between 01.04.2016 and 31.03.2019 and hence it was chosen as tentative check period and the Accused-1 Tr.S.Libendar Babu and Accused-2 Tmt.G.Amsaveni W/o Libendar Babu were found in possession of assets as detailed below.

- 7. The available information makes out a prima facie case against Accused-1 Tr.S.Libendar Babu and his wife Accused-2 Tmt.G.Amsaveni W/o Libendar Babu that they were in possession of pecuniary resources and properties to the tune of Rs.18,51,421/- during the check period which is disproportionate to the known sources of income and the percentage of Disproportionate assets worked out to 101%. Thereby the Accused-1 Tr.S.Libendar Babu and his wife Accused-2 Tmt.G.Amsaveni W/o Libendar Babu had committed the offences of Criminal Misconduct by intentionally enriching themselves illicitly during the period of his office and his wife Accused-2 Tmt.G.Amsaveni had abetted him to commit the offence by acquiring the assets through the resources of Accused-1 Tr.S.LibendarBabu.
- 8. Therefore today 30.11.2020 at 16.00 hrs, I registered a case in Vellore Vigilance and Anti Corruption Cr.No.17/2020 against Accused-1 Tr.S.Libendar Babu and his wife Accused-2 Tmt.G.Amsaveni W/o Libendar Babu for commission of offences u/s 13(2) r/w 13(1)(b) and 12 of Prevention of Corruption Act 1988 as amended by Prevention of Corruption (Amendment) Act 2018.

The original First Information Report is submitted to the Hon'ble Chief Judicial Magistrate and Special Judge, Vellore and copy of the First Information Report is sent to the Superintendent of Police, Vigilance and Anti Corruption, Western Range, for issuing order u/s 17 of Prevention of Corruption Act 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of Accused-1 Tr.S.Libendar Babu and his wife Accused-2 Tmt.G.Amsaveni W/o Libendar Babu.
