A.O-1 K.Prabahar was working as Executive Engineer (MGNREGS), District Rural Development Agency, Virudhachalam division, Cuddalore District from 22.09.2016. Prior to that, he worked as a Executive Engineer, District Rural Development Agency, Cuddalore division, Cuddalore District from 14.03.2012 to 20.06.2016 during the period of commission of offence. AO-1 K.Prabahar is a public servant as defined u/s 2(c) of the Prevention of Corruption Act 1988 during the period of commission of offence. AO-2 G.Shakila is the wife of AO-1. Collection of sources reveals that A.O-1 K.Prabahar hails from a middle class family. He is native of Chinna Salem, Kallakurichi District. AO-2 G.Shakila has been working

It is gathered that A.O-1 K.Prabahar intentionally enriches himself illicitly in his name and in the name of his wife A.O-2 G.Shakila, during the period of his office in various places. Most of the acquisitive activities of A.O-1 falls between 01.04.2012 and 31.03.2016 and hence it was chosen as tentative check period and during that period the A.O-1 and his family members were found in possession of assets as detailed below.

The available information makes out a prima facie case against A.O-1 K.Prabahar and AO-2 G.Shakila that they were in possession of pecuniary resources and properties to the tune of Rs.92,04,731.39 (percent of disproportionate asset is 139.1%) during the check period, which is disproportionate to their known sources of income. Thereby, A.O-1 had committed the offence of Criminal Misconduct by intentionally enriching himself illicitly during the period of his office and A.O-2 G.Shakila had abetted him to commit the said offence by acquiring the assets through the resources of A.O-1. Therefore, today 12.01.2021 at 1600 hrs, I registered a case in Cuddalore Vigilance and Anti-Corruption Detachment in Cr.No.2/2021 against A.O-1 K.Prabahar for commission of the offence u/s 13(2) r/w 13(1)(e) of Prevention of Corruption Act 1988 and AO-2 G.Shakila for commission of the offence u/s 13(2) r/w 109 IPC.

The original First Information Report is submitted to the Hon'ble court of the Special Judge cum Chief Judicial Magistrate, Cuddalore District and a copy of the First Information Report is sent to the Superintendent of Police, Vigilance and Anti-Corruption, Western Range issuing order u/s 17 of the Prevention of Corruption Act 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of A.O-1 K.Prabahar and AO-2 G.Shakila.
