Based on the sources collected during the Preliminary Enquiry, it disclosed the facts that the marginally noted AO-1, amassed wealth in his name and in his wife A2's name and in the name of his 3 daughters namely Tmt.Chinthiya, Selvi.Sowmiya and Selvi.Madhumitha... which are disproportionate to the known sources of his income during the check period from 01.01.2013 to 31.03.2018

Action taken. Since the above report reveals commission of offence(s) u/s as mentioned at item No.2 registered the case and took up the investigation / directed / Rank Rank up the Investigation / Refused Investigation / transferred to PS......on point of jurisdiction.

Tmt. R. Karthikeswari age 56/2020

W/o. M. Ravichandran, No. HIG-II, No. 398, Tamil University Quarters, Thanjavur. The AO-1 Tr.M.Ravichandran, was worked as District Fire Officer, Fire and Rescue Services Department, Thanjavur District from 12.01.2013 to 07.11.2017 and from 01.06.2018 to 31.08.2018 (not allowed to retire from service on 31.08.2018). Hence, he was a public servant within the meaning of section 2(c) of the Prevention of Corruption Act, 1988 and the A2 is the house wife of the AO-1 and she is a private individual.

Based on the sources collected during the Preliminary Enquiry the AO-1 Tr.Ravichandran had entered into Government Service as Station Fire Officer, Fire and Rescue Services Department, Mayiladuthurai in the year 1987 and he had served in Mayiladuthurai (1988-90), and then served at Sirkali (1990-92), Thiruchirapalli (1992-96), Trichy Navalpattu (1996-97), Thanjavur (1997-2004), Papanasam (2004-2005), Pattukkottai (2005-2006), Thanjavur (2006-2007) and Karur (2007-2009) as Station Fire Officer. He was promoted as Assistant District Fire Officer, Fire and Rescue Services Department and Posted to Chennai Athippattu (2009) and then served at Cuddalore (2009-2010) and Karur (2010-2011). After that, he was promoted as District Fire Officer, Fire and Rescue Services Department and posted at Nagapattinam District and served during the period between 01.01.2013 and 11.01.2013 and he is transferred to Thanjavur District and he had served at Thanjavur during the period between 12.01.2013 and 06.11.2017 after that he was transferred to Salem District during the period between 07.11.2017 and 31.05.2018 after that he transferred again to Thanjavur and served during the period between 01.06.2018 and 31.08.2018 and not allowed to retire from service on 31.08.2018.

He was married one Tmt. Karthikeswari, D/o. Sabapathy of Sangenthi Sambakottam, Thiruthuraipoondi Taluk, Thiruvarur District in the year

1990 and she is a house wife and he also having 3 female children namely (1) Tmt.Chinthiya aged 29/2020, W/o. Tr. P.Raja and working as a Assistant, Presidency Girls Higher Secondary School, Egmore, Chennai and she was married Tr.P.Raja, (Assistant, IB, Ministry of Home Affairs Govt. of India), Kumbakonam District and her marriage was conducted on 19.02.2018 at PK Mahal, Thanjavur, (2) Selvi. Sowmiya aged 26/2020 and she was completed BE., ECE in the year 2016 at Nehru Engineering College, Coimbatore and (3) Selvi. Madhumitha aged 20/2020 and she is studying M.B.B.S., in Abroad. They are also dependent of the AO-1. His mother Tmt.Gandhimathi also dependent of the AO-1 and his mother is staying lonely at Sangenthi Village. His younger brother namely Tr. M.Kesavan and he is working as a Conductor, in TNSTC, in Chennai, and one younger sister namely Tmt. Sumathy was married at Trichy. He has ancestral property at Sambakottam to the extent of 4.38 acres and a house at Sambakottam in Thiruvarur District.

During the period between 01.01.2013 and 31.03.2018 the AO-1 had acquired movable and immovable properties pecuniary resources which are disproportionate to the known source of his income.

Movable Properties

Accused – 1 Purchased a Car TN-49 AQ 4484 Maruthi Suzuki (Ertiga) on 11.07.2013 in the name of his wife Karthigeswari, total Value of Rs. 8,33,620/- and purchased a two wheeler Honda Activa TN-49 BM 7925 on 07.03.2018 in the name of his Daughter Chinthiya, total Value of Rs. 70,000/-

Immovable Properties

The AO-1 had purchased 3 Houses in Thanjavur, Tamil University Quarters in the name of HIG II 398 in the year 2013, HIG II 327 in the year 2016, HIG II 347 in the year 2017 total value of Rs. 49,82,400/- and also constructed one house in Ammakulam at Thanjavur in the year 2017, total Value Rs. 50,00,000/- and also purchased 6 plots in Thanjavur and Pudukkottai Districts to the extent of 17074.5 Sq. Ft. during the period

From 01.01.2013 to 31.03.2018. Hence the check period was fixed from 01.01.2013 to 31.03.2018.

Based on the information and documents collected through sources, statements I to VI are prepared and calculated the quantum of disproportionate assets acquired by the Accused Officer in his name and in his wife and daughters name during the check period from 01.01.2013 to 31.03.2018.

It is learnt from the Preliminary Enquiry, the following properties were acquired by the A1 in his name and in his wife Karthikeswari name and daughters 1) Tmt.Chinthiya, 2) Selvi.Sowmiya and 3) Selvi.Madhumitha names during the check period from 01.01.2013 to 31.03.2018 and tabulated hereunder;-

The details of Statement-I to Statement-VII are enclosed herewith.

It is learnt that the AO-1 has acquired and possessed properties and pecuniary resources in his name and in his wife Karthigeswari name and daughters 1) Chinthiya, 2) Sowmiya and 3) Madhumitha name to the tune of Rs.1,83,67,752.19, which are disproportionate to his known sources of income during the check period from 01.01.2013 to 31.03.2018.

The A-2 abetted AO-1 to acquire wealth disproportionate to his known sources of income, by instigating him to acquire properties.

The above information discloses in her name. The commission of the acts of the AO-1, which constitutes cognizable offence of criminal misconduct by a public servant u/s 13(1)(e) r/w 13(2) of the Prevention of Corruption Act, 1988 r/w 109 IPC and there is prima facie material available for taking investigation against Accused 1 & 2.

Hence as per the order of the Director, Directorate of Vigilance and Anti Corruption, Chennai-16 Memorandum in PE 424/2017/FS/TH dt: 13.01.2021, I am registering a case in Thanjavur V&AC Cr.No.2/2021 for the above said offences u/s 13(1)(e) r/w 13(2) of the Prevention of Corruption Act, 1988 r/w 109 IPC against above said A1 and A2.

The original FIR is submitted to the Hon'ble Chief Judicial Magistrate-cum-Special Judge, Thanjavur @ Kumbakonam and a copy of the same is sent to the Superintendent of Police, Southern Range, Directorate of Vigilance and Anti Corruption, Chennai for issuing authorization u/s 17, 18 of Prevention of Corruption Act, 1988 to take up the further investigation of this case.
