

Tr.D.Gopi (55/2021), S/o.Tr.Devarajan, Assistant Director, Audit, Rural Development Department, Kanchipuram. Kanchipuram District. A Vigilance Report was initiated against the A.O. noted in the margin. A.O Tr.D.Gopi, S/o. Tr.Devarajan, formerly worked as Block Development Officer in various places in Vellore District from 01.04.2014 to 31.03.2019, during the period of commission of offence.

A.O. was a public servant as defined u/s 2(c)(i) of the Prevention of Corruption Act 1988 during the period of commission of offence.

Collection of sources reveals that Tr.D.Gopi, S/o. Tr.Devarajan hails from a middle class family. He is residing at Arakkonam in Ranipet District, formerly Vellore District. His spouse is a Government School Teacher.

It is gathered that Tr.D.Gopi, S/o. Tr.Devarajan, intentionally enriched himself illicitly in his name and in his wife Tmt.Jayanthi's name. Most of the acquisitive activities of A.O., falls between 01.04.2014 to 31.03.2019 and hence it was chosen as tentative check period and during that period the A.O. had acquired movable and immovable assets. Hence, A.O. was found in possession of assets as detailed below.

Assets found in the name of A.O. and his wife Tmt.Jayanthi in the form of house sites at the commencement of the check period i.e. as on 01.04.2014.

Rs.11,85,820/-

Assets found in the name of A.O. and his wife Tmt.Jayanthi in the form of house sites at the end of the check period i.e. as on 31.03.2019.

Rs.69,51,675/-

Income of A.O. and his wife from known sources in form of their monthly salary etc during the check period between 01.04.2014 to 31.03.2019

Rs.45,03,650/-

Expenditure incurred by A.O. during the check period between 01.04.2014 to 31.03.2019.

Rs.72,67,071/-

Value of the assets acquired by A.O. during the check period between 01.04.2014 to 31.03.2019.

Rs.57,65,855/-

Excess of expenditure over income incurred by the A.O. Tr.D.Gopi during the check period between 01.04.2014 to 31.03.2019.

Rs.27,63,421 /-

Disproportionate assets acquired by the A.O. during the check period between 01.04.2014 to 31.03.2019.

Rs.85,29,276/-

The available information makes out a prima facie case against A.O. Tr.D.Gopi, S/o. Tr.Devarajan that he was in possession of pecuniary resources and properties to the worth of Rs.85,29,276/- during the check period, which is disproportionate to his known sources of income to the tune of 189%. Thereby, Tr.D.Gopi (55/2021), S/o.Tr.Devarajan, Assistant Director, Audit, Rural Development Department, Kanchipuram, Kanchipuram District had committed the offence of Criminal Misconduct by intentionally enriching himself illicitly during the period of his office.

Therefore, today 29.01.2021 at 15.30 hrs, I registered a case in Vellore V&AC Cr.No.2/2021 against A.O. Tr.D.Gopi (55/2021), S/o.Tr.Devarajan, Assistant Director, Audit, Rural Development Department, Kanchipuram, Kanchipuram District for commission of the offence u/s 13(1)(b) of Prevention of Corruption (Amendment) Act 2018.

The original F.I.R. is submitted to the Hon'ble Court of Chief Judicial Magistrate / Special Judge, Vellore, Vellore District and a copy of FIR is sent to the Superintendent of Police, Western Range, Vigilance and Anti-Corruption, Chennai for issuing order u/s 17 of the Prevention of Corruption Act 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of A.O. Tr.D.Gopi (55/2021),S/o.Tr.Devarajan, Assistant Director, Audit, Rural Development Department, Kanchipuram, Kanchipuram District and others.
