A2) Tmt.M.Sridevi, age-35 yrs W/o M.Rajasekaran, No.72, Periyasamy Nagar, Gondu Upplavadi, Cuddalore District.

The following information was gathered during the preliminary enquiry against the AOs noted in the margin. AO1 Tr.M.Rajasekaran is working as Assistant Commissioner, Social Security Scheme, Cuddalore District since 28.02.2019. Prior to that, he worked as Assistant Inspector of Labour, Nagapattinam from 18.08.2008 to 21.08.2012, Assistant Inspector of Labour, 1st Circle, Coimbatore from 22.08.2012 to 09.02.2014 Deputy Inspector of Labour, Pollachi, Coimbatore District from 10.02.2014 to 27.07.2018 i.e.. during the period of commission of offence.

A1 is a public servant as defined u/s 2(c) of the Prevention of Corruption Act 1988 during the period of commission of offences. A2 Tmt.M.Sridevi is the wife of A1 and she is a homemaker as well as non-earning person.

The Preliminary Enquiry reveals that the A1 hails from a middle class family. He is native of Gondu Upplavadi village, Cuddalore District.

It is revealed that the A1 intentionally enriches himself illicitly in his name and in the name of his wife Tmt.M.Sridevi (A2) during the period of

his office in Coimbatore and Cuddalore District. Most of the acquisitive activities of A1 and his wife Tmt.M.Sridevi (A2) falls between 01.11.2010 and 31.01.2017 and hence it was chosen as tentative check period and the during that period the A1 and his wife (A2) was found in possession of assets as detailed below.

Income of A1 from known sources in form of monthly salary and a loan from Tamil Nadu Labours and Factories Department Employees Co-operative Thrift and Credit Society Limited, Chennai during the check period between 01.11.2010 and 31.01.2017.	Rs.23,88,144/-
Expenditure incurred by A1 during the check period between 01.11.2010 and 31.01.2017.	Rs.15,72,037/-
Value of the assets acquired by A1 in his name and in the name of his wife (A2) during the check period between 01.11.2010 and 31.01.2010.	Rs.62,00,870/-
Likely savings of A1 during the check period between 01.11.2010 and 31.01.2017.	Rs.8,16,107/-

The available information makes out a prima facie case against A1 Tr.M.Rajasekaran and his wife (A2) that they were in possession of pecuniary resources and properties to the tune of Rs.53,84,763/- during the check period, which is disproportionate to their known sources of income.

Thereby, A1 had committed the offence of Criminal Misconduct intentionally enriching himself illicitly during the period of his office and A2 had abetted him to commit the said offence.

Hence, today 23.01.2021 at 11.00 hrs, I have registered a case in Coimbatore V&AC Cr.No.3/2021/AC/CB against A1 Tr.M.Rajasekaran, Formerly Inspector of Labour, Labour Department, Pollachi, Coimbatore District for commission of an offence u/s 13(2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988 and A2 Tmt.M.Sridevi committed an offence punishable u/s 13(2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988 r/w 109 IPC and other copies sent to the officers concerned.

The original FIR is submitted to the Honourable Special Court for Cases Under the Prevention of Corruption Act, Coimbatore and copy of the FIR is sent to the Superintendent of Police, Western Range, Vigilance & Anti Corruption, Chennai for issuing order u/s 17 of the Prevention of Corruption Act, 1988 to investigate the case and authorization u/s 18 of the said act to inspect bankers books in relation to the accounts of A1 and others.
