....Today on 19.11.2021 at 20.00 Hrs, I received the proceedings of the Joint Surprise Check from Tr.N.Soundararajan, District Deputy Inspection Cell Officer, O/o the District Cell Office, Chennai-1 to take appropriate action. Proceedings of the Deputy Inspection Cell Officer O/o the

District Inspection Cell Office, Collectorate, Chennai and the Deputy Superintendent of Police, Vigilance and Anti-Corruption, Chennai City-III conducted Joint Surprise Check at the O/o the District Registrar (Admin) / In the cadre of Assistant Inspector General, Integrated complex, Registration and Commercial Tax Offices, Pearnpet, Nandanam, Chennai-35 on 19.11.2021 between 18.45hrs and 19.30 hrs. On credible information that, Tmt.K.Meenakumari, District Registrar (Admin)/ In the cadre of Assistant Inspector General, Chennai South District, Integrated complex, Registration and Commercial Tax Offices, Nandanam, Pearnpet, Chennai-35 is indulging in corrupt practices and thereby collecting huge amount of bribe from the SRO offices functioning under her. Hence it was proposed to conduct joint Surprise Check on 19.11.2021 at the O/o Tmt.K.Meenakumari, District Registrar (Admin)/ In the cadre of Assistant Inspector General of Registration, Chennai South District, Integrated complex, Registration and Commercial Tax Offices, Pearnpet, Nandanam, Chennai-35. In continuation of this, on the request of the Deputy Superintendent of Police, Vigilance and Anti-Corruption, Chennai City-III, Alandur, Chennai-16, Tr.N.Soundararajan, Deputy Inspection Cell Officer came to office the Deputy Superintendent of Police, Vigilance and Anti-Corruption, Chennai City-III at about 17.30 hrs on 19.11.2021. The joint surprise check team left V&AC office on 19.11.2019 at 17.45 hrs. and reached at the District Registrar (Admin) / In the cadre of Assistant Inspector General of Registration, Integrated complex, Registration and Commercial Tax Offices, Pearnpet, Nandanam, Chennai-35 on 19.11.2021 at 18.40 hrs. The following officials attached to V&AC, CC-III Detachment and District Inspection Cell official are in the team.

The office of the District Registrar, Chennai South Registration District (Admin) (In the cadre of District Assistant Inspector General of Registrar) is situated at R-10, Integrated Complex, Registration and Commercial Tax Offices, Nandanam, Chennai-35. The team entered into the office on 19.11.2021 at 18.45 hrs. and conducted Joint Surprise Check. During the time of Surprise Check Tmt.K.Meenakumari, District Registrar (Admin), Chennai South Registration District, in the cadre of Assistant Inspector General was present. The following officials attached to the District Registrar (Admin), Chennai South Registration District were present at the time of conducting the Joint Surprise Check.

Surprise check was conducted at the office of Tmt. K.Meenakumari including her office Cabin, Visitor's hall and her official vehicle Bolero Jeep having Registration Number TN06G0630. During the surprise check, cash to the tune of Rs.3,61,000/- was found in a light blue colour cloth bag, in which, the amounts were found in several small covers and also wrapped in a newspaper. Apart from this, cash Rs.3,000/- was found in the hand bag of Tmt.K.Meenakumari and Rs.25,000/- and Rs.3,000/- in 2 brown covers found in the Jeep Dash-Board and Rs.7,500 found in possession of the Jeep Driver Tr.T.Santhosh Kumar. The denomination and position of the amounts has been described as under.

During the course of surprise check the above mentioned office staff were examined by the Deputy Inspection Cell Officer and their statements were recorded. Tr.R.Dinakaran S/o K.Radha is a regular staff of Joint-1, SRO Saidapet and doing OD in the office of the DR (Admin)/AIG office. Tr.R.Dinakaran has stated that, while he was present in the office at about 18.15hrs, an unknown individual came to the office and gave a light blue colour cloth bag knotted and asked him to hand it over to Tmt.K.Meenakumari. Tr.R.Dinakaran, after receiving the bag came to Tmt.K.Meenakumari and informed the same. Tmt.K.Meenakumari instructed Tr.R.Dinakaran to keep the bag with him and asked him to give the bag while she leaves office. Accordingly, he kept the bag under the table positioned in the visitor's cabin attached to the office cabin of Tmt.K.Meenakumari. Tr.T.Santhoshkumar, S/o S.Thirunavukarasu, the Driver of Tmt.K.Meenakumari was examined and he has stated that, he is a private person engaged by the previous District Registrar Tr.Ravindranath in 2018 and the Department ID card has been issued by the then District Registrar, Tr.Ravindranath. He has stated that he has been given a monthly salary of Rs.20,000/- by Tr.Ramesh, Camp Clerk of District Registrar (Admn) from the date of appointment since 13.08.2018. He is driving the official vehicle of District Registrar (Admn), Bolero Jeep bearing registration No.TN06G0630. He further stated that today 19.11.2021 morning Tmt.R.Meenakumari made an official visit to Avadi and Pallavaram and back to office in the afternoon. Tr.Ramesh, who is working as Assistant in the office, was already present in the SRO office Pallavaram accompanied Tmt.K.Meenakumari in the vehicle while returning to office. While leaving the SRO Pallavaram, a staff of the SRO came to the vehicle and gave a brown cover to Tr.Ramesh, who was sitting in the front seat of the vehicle. At that point of time Tmt.Meenakumari was sitting in the center seat of the vehicle. Tr.Ramesh kept two brown covers in the dash-board of the vehicle. He also stated that Tr.Ramesh gave Rs.2,000/- to Tr.T.Santhoshkumar for himself. While getting down from the vehicle, Tr.Ramesh instructed to give the two brown cover containing cash to Tmt.Meenakumari. Apart from this, Tr.Santhoshkumar was also found with Rs.5,500/- for which he could not give satisfactorily account. Hence the amounts Rs.25,000/- and Rs.3000/- found in two separate covers and Rs.7500/- found with him were treated as unaccounted amounts. Tmt.K.Meenakumari D/o Kothandam, District Registrar, Chennai South Registration District(Admin)/In the cadre of District Assistant Inspector General of Registrar was examined with respect to the amounts found in her office. She has stated that today 19.11.2021 morning after her visit at

Paleripattu village of Avadi Taluk, she went to Pallavaram SRO in connection with a settlement deed refused by SRO Valechery. The appeal filed by the settlor Mrs.V.Madhini of Sastri Nagar before the District Registrar (Amin.) on 09.11.2021. To verify the original Parent Document, Tmt.K.Meenakumari has visited Pallavaram SRO, where the Parent Document registered. SRO Velachery and SRO Pallavaram are coming under the jurisdiction of Tmt.Meenakumari. After verification, she left for her office at about 13.00 hrs. Tmt.K.Meenakumari has already instructed Tr.Ramesh, Assistant of her office to bring the concerned file to the SRO Pallavaram. Tr.Ramesh accompanied Tmt.Meenapriya to the office. She has stated that she did not notice who had come and what he had given to Ramesh. When asked about the amount Rs.25,000/- found and seized from the vehicle dash-board, she could not give explanation and hence the amount is termed as unaccounted. Tmt.Meenakumari was questioned about the amount of cash Rs.3,61,000/- found in her office, she has stated that the staff in her office are in the habit of collecting bribe from the SRO offices under the control of District Registrar, Chennai South Registration District. She further stated that her predecessor Tr.Ravindranath was in the habit of collecting amounts from the SRO Offices during his tenure. She further stated that she did not demanded any amounts from the SROs and the amounts which was given to the OA Tr.R.Dinakaran is no way connected to her. Hence the amount Rs.3,61,000/- is termed as unaccounted. Tmt.Meenakumari was also found with Rs.3,000/- in her leather hand bag, which is described the foregoing table. She was questioned about the amount found in her bag, she told that she had brought the amount for her personal expenses. The explanation of Tmt.Meenakumari is not acceptable in the light of the fact that she has not entered the same in the Personal Amount Register being maintained in her office and this amount also termed as unaccounted. Therefore the amount Rs.3,61,000/- found in the circumstance, possession, position and the writings found on the covers found inside the cloth bag could have been the ill-gotten amounts collected from the SROs under the control of Tmt.Meenakumari, District Registrar (Admn) / in the cadre of AIG. During the Surprise Check the records viz., 1) Attendance Register, 2) Movement Register, 3) Personal Amount Register, 4) Cash bill for the Bolero Jeep fuel consumption given by Sri Balaji Agencies vide Bill No. 12021 dt. 02.11.2021, for the amount of Rs. 2,000/-, Shyamala & Co., invoice No. 114932 dt. 02.11.2021 for Rs.975.45/- and ASM Abdul Cader and Co., BPCL No.365, Cement Road, Transaction Id No. 1111622163 dt. 16.11.2021 for Rs.3,000/- possessed by the driver Tr.T.Santhoshkumar were perused and attested copies

of the same were seized for the purpose of investigation. The movement register being maintained at the O/o the District Registrar (Admn) was perused. There is no entry for the movement of District Registrar (Admn) / AIG, Tmt.K.Meenalakumari today. The extract of relevant page is seized after getting attestation of District Registrar (Admn)/AIG. During the time of surprise check, an unaccounted amount to the tune of Rs.3,99,500/- was seized as it is, along with the covers, viz, 1) Rs.3,61,000/- in the blue colour cloth bag, 2) Rs.35,500/- seized from Tr.T.Santhoshkumar, Driver and from the dash board of the vehicle and 3) Rs. 3,000/- was seized from the leather hand bag of Tmt.K.Meenalakumari, District Registrar (Admn)/AIG. The following copies of documents, cash bill and ID card were seized.

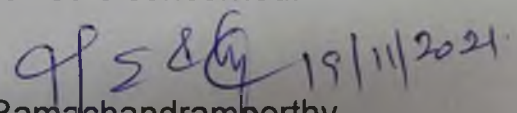
