Hon'ble sir, received the information pertaining to the registration of FIR as per the instruction in Memorandum in No. DE 11/2019/HR&CE/DL, Dated: 18.02.2021 of the Director, Vigilance and Anti-Corruption, Chennai, I have registered a case in Dindigul V&AC Cr.No.03/2021 u/s 13(2) r/w.13(1)(b) of Prevention of Corruption Act 1988 as Amended Act 2018 and 109 IPC on 10.03.2021 at 15.00 hrs and submit as under. The Accused No-1 Tr.M.Muralidharan, native of Palani Town, Dindigul District, joined as Office Assistant on 4.11.1987 in the O/o the Executive Officer/Joint Commissioner, Sri Dhandayuthapani Swamy Thirukovil/Thevesthanam, Palani, which is administered by the Hindu Religious and Charitable Endowment Board Department. The Accused -1 is presently posted as Assistant Manager/Superintendent, at Poombari Murugan Kovil and Kurinji Andavar Kovil, Kodaikonal, under the control of Palani Sri Dhandayuthapani Swamy Thirukovil/ Thevesthanam and as such he is a Public Servant as defined in Section 2 (c) of Prevention of Act-1988 as Amended Act-2018.

The Accused No.2 Tmt.M.Eswari is wife of Accused No.1 Tr. M.Muralidharan and she is a house wife.

The Accused No.1 Tr.M.Muralidharan married Tmt.Eswari on 24.01.1996. They got one son Selvan.M.Harish aged about 25 years. Selvan M.Harish studied his School studies in a private School at Palani and completed +2 standard during the year 2012 to 2014 and studied his Bachelor of Engineering degree by staying at hostel during the year 2014 to 2018 in a private Engineering College, Coimbatore.

On credible information received that A-1 has purchased movable and immovable properties in his name and in the name of his wife A-2 Tmt.Eswari against the known sources of his income. Hence, a Detailed

Enquiry was conducted by the order of the Director, Vigilance and Anti-Corruption, Chennai in DE11/2019/HR &CE/DL, which disclosed that A-1 Tr.M.Muralidharan has no ancestral property in his name and no significant sources of income except his salary income, but he has accumulated large number of properties, which are suspected to be disproportionate to the known sources of his income.

Considering the events, which took place during the course of his service and by taking into account of the transactions of the movable and immovable properties made by the accused, the check period was fixed for the period between 1.7.2013 and 31.7.2018.

Accordingly the assets that stood in the name of A-1 and his wife A-2 at the beginning of the check period i.e on 1.7.2013 are valued as Rs.1,94,882.45/- The assets of movable and immovable properties that stood in the name of A-1 and in the name of his wife A-2 at the end of the check period i.e on 31.7.2018 are valued as Rs.82,63,796.75/- The probable income of A-1 and his wife A-2 during the check period between 1.7.2013 and 31.7.2018 are calculated as Rs.28,12,729/- The probable expenditure during the check period taking in to consideration of the status of the accused and his family members are worked out to Rs. 32,02,505.39/-.

The disproportionate asset for the check period is worked out as follows.

Thus the accused is found in possession of movable and immovable properties during the check period to the extent of Rs.84,58,690.69/- which are disproportionate to his known sources of his income.

Accused No-1 Tr.M.Muralidharan being a Public Servant and holding the post of Assistant Manager/Superintendent, O/o the Joint Commissioner/E.O, Arulmigu Dhandayuthapani Swamy Thirukovil, Palani, Dindigul District, now working as Assistant Manager/Superintendent, at Poombari Murugan Kovil and Kurinji Andavar Kovil, Kodaikonal during the period between 1.7.2013 and 31.7.2018 has abused his position as public servant and also he has

accumulated assets and possessed resources in his name and in the name of his wife A-2 Tmt.M.Eswari and thereby he has committed an offence of criminal misconduct punishable under section 13(2) r/w 13(1)(b) of Prevention of Corruption Act 1988,as Amended Act 2018.

In the course of the same transactions and during the said period, A-2-Tmt.M.Eswari, being the wife of A-1, has holding the properties in her name and also persuaded for the commission of the said offence of criminal misconduct and thereby punishable under section 109 IPC r/w 13(1) (b) of Prevention of Corruption Act 1988, as Amended Act 2018.

Therefore prima facie materials are available on records for taking up investigation against the above mentioned Accused -1 Tr.M.Muralidharan and Accused-2 Tmt.M.Eswari for the offences under section 13(2) r/w 13(1)(b) of Prevention of Corruption Act 1988,as Amended Act 2018 and 109 IPC.

Hence, I am registering a case in Vigilance and Anti-Corruption, Dindigul Detachment Crime No.3/2021, under section 13(2) r/w 13(1)(b) of Prevention of Corruption Act 1988,as Amended Act 2018 and 109 IPC on 10.03.2021 at 15.00 hrs. The F.I.R. (Original) is submitted to the Hon'ble Chief Judicial Magistrate / Special Judge Court, Dindigul and copies of the same were sent to the officials concerned.
