I, T.T.Rema, Inspector of Police, Vigilance and Anti Corruption, Kanyakumari Detachment while on duty on today (05.07.2021) at 16.00 hrs perused the memorandum of Director, Vigilance and Anti-Corruption, Chennai-16 in Confidential No. PE 4/2020/HR&CE/KK dt.10.06.2021 and I registered a case in Kanyakumari Vigilance and

Anti-Corruption Cr.No.4/2021 u/s 13(2) r/w 13(1)(b) of the Prevention of Corruption Act 1988 as amended by Act 16/2018 against the marginally noted Accused Officer Tr.M.Anbumani. During the collection of information against the Accused Officer Tr.M,Anbumani was working as Joint Commissioner cum Executive Officer, Kanyakumari District Temples, Suchindrum, Kanyakumari District from 15.09.2017 to 11.03.2011. Now A.O Tr.M.Anbumani is working as Regional Joint Commissioner, Thoothukudi and Tenkasi Districts hence Accused Officer was a public servant as defined u/s 2(c) of the Prevention of Corruption Act 1988, during the period of commission of offence. Collection of sources disclosed that his native place is Uraiyoor, Tirchy District. He hails from a middle class family. He had completed his Law studies and was working as an advocate. In the year 1991, he married an Advocate Tmt.Hema Prabha in continuation of their love between them. He had entered

into government service on 28.04.1999 in the Hindu Religious and Charitable Endowment as an Assistant Commissioner. He is having two female children by name Selvi.Kurinji Malar and Selvi.Chenbaga Malini. He and his wife Tmt.Hema Prabha had obtained divorce through court in the year 2015 and now living separately. Now A.O Tr.M.Anbumani living with his children. It is gathered that A.O Tr.M.Anbumani intentionally enriched himself illicitly in his name during the period of his office as Joint Commissioner cum Executive Officer, Kanyakumari District Temples, Suchindrum, Kanyakumari District from 15.09.2017 to 11.03.2021. As such the tentative check period was fixed as from 01.10.2017 to 31.12.2019 and during that period A.O Tr.M.Anbumani was found in possession of assets as detailed below.

Assets found in the name of A.O Tr.M.Anbumani at the commencement of the check period i.e as on 01.10.2017.

- Rs.1,49,240.00/-

Assets found in the name of A.O Tr.M.Anbumani in the form of House site & building, Agricultural land, Vehicle, Jewel and bank balances etc. at the end of the check period i.e as on 31.12.2019.

Rs.80,40,141.00/-

Income of A.O Tr.M.Anbumani from known sources in the form of Monthly Salary, GPF, Part Final, Vehicle Loan and Jewel Loan etc. during the check period between 01.10.2017 and 31.12.2019.

- Rs.55,53,435.00/-

Expenditure incurred by A.O Tr.M.Anbumani and his family during the check period between 01.10.2017 and 31.12.2019.

- Rs.17,53,268.00/-

Value of the assets acquired by A.O Tr.M.Anbumani during the check period between 01.10.2017 and 31.12.2019

Rs.78,90,901.00/-

Likely savings of A.O Tr.M.Anbumani during the check period between 01.10.2017 and 31.12.2019

- Rs.38,00,167.00/-

Assets acquired by A.O Tr.M.Anbumani which are disproportionate to his known sources of income during the check period between 01.10.2017 and 31.12.2019.

- Rs.40,90,734.00/-

The available information discloses prima facie case against A.O Tr.M.Anbumani that he enriched himself illicitly and he was in possession of pecuniary resources and properties to the tune of Rs.40,90,734.00/- during the check period, which is disproportionate to his known sources of income. Thereby, A.O Tr.M.Anbumani had committed the offence of Criminal Misconduct by intentionally enriched himself illicitly during the period of his office. Therefore, today 05.07.2021 at 16.00 hrs, I registered a case in Nagercoil V&AC Cr.No.4/2021 against A.O Tr.M.Anbumani for the commission of offences u/s 13(2) r/w 13(1)(b) of the Prevention of Corruption Act 1988, as amended by Act 16/2018.

The original F.I.R is submitted to the Hon'ble court of the Chief Judicial Magistrate cum Special Judge, Kanyakumari District at Nagercoil and a copy of the FIR is sent to higher officials.
