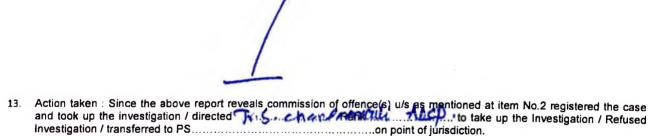

ATTACHMENT TO COLUMN NO.12 OF THE FIRST INFORMATION REPORT IN VIGILANCE AND ANTI-CORRUPTION, SALEM DETACHMENT CRIME NO.4/AC/2021

The following information was gathered during the collection of information against the accused. The accused A-1 Tr.G.Selvakumaran was directly appointed as Assistant Engineer during the year 1997 and he served in various places such as Ariyalur, Perambalur and Viluppuram Districts as Assistant Engineer, Assistant Executive Engineer and Executive Engineer respectively. Now he is working as Executive Engineer (MGNREGS), Rural Development Department, Virudhachalam Division, Cuddalore District from 06.03.2019 to till date.

The accused A-1 is a public servant as defined u/s 2 (c) of the Prevention of Corruption Act, 1988 during the period of commission of offence. The accused A-2 Tmt.Jayanthi is the wife of A-1, and she is a private individual.

Tr.G.Selvakumaran, Executive Engineer, Rural Development Virudhachalam Division, Cuddalore District hails from a poor family. His father Tr.Gopal was an agricultural collie at Alamelupuram Village, Harur Taluk, Dharmapuri District. His Mother Tmt.Vellaiammal was a house wife and both died before 15 years. The accused A-1 Tr.G.Selvakumaran has got only one brother. Brother Tr.G.Vanangamudi was elected as a Councilor (independent candidate) and he completed his tenure during the year between 24.10.11 and 24.10.2016. The accused A-1 Tr.G.Selvakumaran is not having any ancestral property.

The accused A-1 Tr.G.Selvakumaran married one Tmt.R.Jayanthi daughter of Tr.Rangasamy Alamelupuram Village, Harur Taluk, Dharmapuri District. Tr.Rangasamy was an agricultural Collie. Her Mother is a house wife. During their marriage except some jewels and house hold articles no immovable property was given to Tmt.R.Jayanthi by her parents as Sreethana. The accused A-1 Tr.G.Selvakumaran has only two daughters. The 1st daughter Selvi S.Thatchayini was completed her M.E., during the

her M.B.B.S., during the academic year 2018-19. Tmt.R.Jayanthi is a house wife. Thus, except his salary income, the accused A-1 Tr.G.Selvakumaran has no other independent sources of income.

It is gathered that the accused A-1 Tr.G.Selvakumaran, intentionally enriches himself illicitly in his name and in the name of his wife A-2 Tmt.Jayanthi, during the period of his public service in various places. Most of the acquisitive activities of the accused and his family members falls between 01.04.2012 to 31.03.2019 and hence it was chosen as tentative check period and during that period the accused and his dependents / wife were found in possession of assets as detailed below:-

The available information makes out a prima facie case against the accused Tr.G.Selvakumaran, that he was in possession of pecuniary resources and properties in his name and in the name of his wife Tmt.Jayanthi, to the tune of Rs.3,31,79,560/- which comes @ 283.58% (or) 284% during the check period, which is disproportionate to the known sources of income and thereby, the accused had committed the offence of criminal misconduct by intentionally enriching himself illicitly during the period of his duty.

Therefore, today 04.02.2021 at 17.00hrs, I registered a case in Salem V&AC Cr.No.4/AC/2020 against A-1 Tr.G.Selvakumaran for commission of the offence punishable u/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 as amended by u/s 13 (1) (b) of the Prevention of Corruption amendment Act, 2018 and his wife A-2 Tmt.Jayanthi abetted the accused A-1 in enrichment of the property accumulated in her name and in the name of her husband (A-1) for commission of offence punishable u/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 as amended by u/s 13 (1) (b) of the Prevention of Corruption amendment Act, 2018 r/w 109 IPC.

The original FIR is submitted to the Hon'ble Special Judge, Special Court for Trial of Cases under Prevention of Corruption Act, Salem District and a copy of the FIR is submitted to the Superintendent of Police, Vigilance & Anti-Corruption, Western Range, Chennai for issuing order u/s 17 of the Prevention of Corruption Act, 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of A-1 and his family members.
