continuation of Virudhunagar V&AC Cr.No.05/2021 :- The Accused Officer-1 Tr.Murugan is working as Assistant Executive Engineer (Roads & Bridges), District Rural Development Agency (DRDA), Virudhunagar Sub division, Virudhunagar from 15.09.2017 to till date. The Accused Officer-2 Tr.Kathiresan is working as Assistant Engineer, DRDA, Virudhunagar Sub Division, Virudhunagar from 10.08.2007 to till date. The Accused-3 M/s.Mariappan & Co Tr.G.Mariappan is a private individual doing business at 95, Pavali Road, Virudhunagar. The AO-1 Tr.Murugan and AO-2 Tr.Kathiresan both are Public Servants within the ambit and scope of Section 21 of IPC as well as section 2(c)(i) of Prevention of Corruption Act. The Government of Tamilnadu under Tamilnadu Rural Roads Improvement Scheme (TNRRIS) 2018-2019 for upgradation (Strengthening) maintenance of Village Panchayat and Panchayat Union Roads in Virudhunagar District allocated a total estimate of Rs.34.99 Crores vide G.O.(Ms) NO.117 RD & PR (SGS.II) Development Dated 03.09.2018. The District Collector, Virudhunagar accorded Administrative Sanction for the above said scheme in Roc.No.C6/3267/2018, Dt.06.09.2018. The Executive Engineer, DRDA (District Rural Development Agency) has also accorded Technical Sanction (TS) for the above said scheme vide EE (RD) 84/2018-2019 dated 06.09.2018 for upgradation / strengthening of Virudhunagar Panchayat union Roads, Sennelgudi Panchayat, Pottalpatti to Sennelgudi. The total length of road 1.225 kms, after invitation of tender, the lowest bidder of the work the Accused-3 M/s Mariappan & Co was selected and Contract of Agreement was given by the Virudhunagar District Collector in Roc.6/4498/2018 Dt.28.11.2018. The Total Estimate of Contract is Rs.27,12,000/- The Execution of works taken up under "TNRRIS" scheme should be carried out as per the conditions formulated as per the proceedings of the District Collector / Chairman, DRDA, Virudhunagar in Roc.C6/3267/2018, Dt.06.09.2018. The various process of execution of work are 1)Clearing scrub

Jungle without alignment, 2)Picking the existing BT Surface, 3)Providing, Laying, compacting red gravels, 4)Providing and laying, spreading and compacting graded stones aggregate to Wet Mix Macadam (WMM), 5)Applying Emulsion spray over the WMM surface, 6)Applying tack coat spray over the WMM surface, 7)Providing and laying Premix Carpet with Seal Coat (PCSC) of 20 mm thickness, 8)Construction of 2.00 m SPAN slab culvert @ 480 m, 9)Laying hecta metre stone, 10)Provision for caution board, sign board, name board.

Based on Vigilance Report it reveals that misappropriation of funds in Execution of above said road works. As per the work order, the work should be executed, adhering to the standards prescribed in the Estimate, and quality control tests. But the A-3 not executed the work as per the Estimate, i.e. as per the Technical Sanction of the EE, DRDA (District Rural Development Agency), Virudhunagar stated there in out of total distance of 1.255 kms only for 1.000 kms laying and compacting graded stone to Wet Mix Macadam (WMM) work done (deficit approximate .255 kms) in Wet Mixed Macadam (WMM) method laying only 50 mm Jalli and crusher dust mixer instead of 125 mm (deficit 75 mm) in Premix Carpet with Seal Coat (PCSC) method laying only 5 mm height $\frac{1}{4}$ Jalli, $\frac{1}{2}$ inch Jalli Tar mixture instead of 20 mm (deficit height 15 mm) without erecting any caution signal or fluorescent signal claimed Rs.7,85,133.60/- for providing Wet Mix Maendam (WMM) for 1.255 kms whereas Rs.2,50,240/- only was spent, Rs.1,79,620/- only has been spent for applying Emulsion spray over WMM surface whereas Rs.2,25,430.89/- was claimed. Rs.14,004.40/- was claimed for applying tack coat spray whereas Rs.11,158.88/- alone was spent, Rs.1,41,320/- was spent for providing Premix Carpet with Seal Coat (PCSC) but claimed Rs.7,09,432.15/- without erection of any signal board claimed Rs.9,480/-. Thus Accused AO-1 to A3 swindled Rs.11,61,120/- for the work done pertaining to the strengthening the above said

Virudhunagar Panchayat Union, Sennelgudi Panchayat, Pottalpatti to Sennelgudi road without adhering to the estimate and not executed the work as per Estimate by making false entry, boosted measurement in the M.Book as if the work was done as per the agreement.

During the year 2018-2019, the Accused AO-1 to A3 entered into criminal conspiracy with intention to misappropriate the funds allotted under "TNRRIS" scheme for strengthening Pottalpatti to Sennelgudi Road, the AO-2 Tr.Kathiresan created fabricated records i.e. entered boosted measurement with regard to the work in M.Book. The AO-1 Tr.Murugan dishonestly accepts the boosted measurement which is fabricated by AO-2 Tr.Kathiresan without checking the measurement of the said work. The AO-1 Tr.Murugesan, AO-2 Tr.Kathiresan knowingly prepared forged work completion report and dishonestly using such document as genuine for the purpose of cheating and misappropriation of Govt. Fund of Rs.11,61,120/- in the above TNRRIS Scheme. In pursuance of criminal conspiracy the A-3 Mariappan & Co., received the amount on the basis of said false document by illegal means as if the work is done as per the Estimate without actually done the work valuing Rs.11,61,120/-. The AO-1 Tr.Murugan and AO-2 Tr.Kathiresan who are responsible public servant to supervise, inspect the work, submitted false work completion report paved way for the passing bill as if the above said work were executed as per Administrative Sanction (AS), Technical Sanction (TS), Agreement, Estimate, M.Book & Completion Report. The Accused A3 had committed prima-facie cognizable offence by not executing the work as per the Administrative Sanction, Estimate and thereby dishonestly, misappropriated funds of Rs.11,61,120/- allotted under "TNRRIS" Scheme.

The prior approval accorded u/s 17(A)(1) of Prevention of Corruption (Amendment) Act, 2018 to register Regular Case against AO-1 Tr.Murugan and

AO-2 Tr.Kathiresan vide TN.Govt. G.O.(3D) No.4, Dated 19.02.2021 of Rural Development and Panchayat Raj Department and in continuous the Directorate of Vigilance and Anti-Corruption, Chennai instructed to register regular case against the AO-1, AO-2 and A3 vide in VR.No.21074/2020/RDP/VN, Dated 10.03.2021.

The above information disclosed prima-facie commission of cognizable offence of criminal misconduct by public servant u/s 13(1)(a) of Prevention of Corruption (Amendment) Act, 2018 and Sec. 120(B), 409, 465, 468, 471, 477(A) IPC against AO-1 Tr.Murugan and AO-2 Tr.Kathiresan. The A-3 Mariappan & Co., has committed offence punishable u/s 120(b), 406, 465, 468, 471, 477(A) r/w 109 IPC and Sec. 12 r/w 13(1)(a) of Prevention of Corruption (Amendment) Act, 2018.

Hence, I registered a Regular Case in Virudhunagar Vigilance and Anti-Corruption in Cr.No.5/2021 u/s 120(b), 406, 409, 465, 468, 471, 477(A) r/w 109 IPC and section 12, 13(1)(a) of PC (Amendment) Act, 2018 against AO-1 Tr.Murugan, AO-2 Tr.Kathiresan and A-3 Mariappan & Co., today on 22.06.2021 at 9.30 hrs. as per the order of DVAC Chennai vide in VR.No.21074/2020/RDP/VN, Dated 07.05.2021.
