HIG-II, No. 398, Tamil University Quarters, Thanjavur. Based on the sources collected during the Preliminary Enquiry, it disclosed the facts that the marginally noted accused was worked as District Fire Officer, Fire and Rescue Services Department, Thanjavur District from 12.01.2013 to 07.11.2017 and from 01.06.2018 to 31.08.2018 (not allowed to retire from service on 31.08.2018). Hence, he was a public servant within the meaning of section 2(c) of the Prevention of Corruption Act, 1988.

Based on the sources collected during the Preliminary Enquiry the Accused Tr.Ravichandran had entered into Government Service as Station Fire Officer, Fire and Rescue Services Department, Mayiladuthurai in the year 1987 and he had served in Mayiladuthurai (1988-90), and then served at Sirkali (1990-92), Thiruchirapalli (1992-96), Trichy Navalpattu (1996-97), Thanjavur (1997-2004), Papanasam (2004-2005), Pattukkottai (2005-2006), Thanjavur (2006-2007) and Karur (2007-2009) as Station Fire Officer. He was promoted as Assistant District Fire Officer, Fire and Rescue Services Department and Posted to Chennai Athippattu (2009) and then served at Cuddalore (2009-2010) and Karur (2010-2011). After that, he was promoted as District Fire Officer, Fire and Rescue Services Department and posted at Nagapattinam District and served during the period between 01.01.2013 and 11.01.2013 and he is transferred to Thanjavur District and he had served at Thanjavur during the period between 12.01.2013 and 06.11.2017 after that he was transferred to Salem District during the period between 07.11.2017 and 31.05.2018 after that he transferred again to Thanjavur and served during the period between 01.06.2018 and 31.08.2018 and not allowed to retire from service on 31.08.2018.

The accused Tr.Ravichandran, District Officer, Fire and Rescue Services, Thanjavur had issued No Objection Certificates to the schools in Thanjavur District by violating the Government orders, rules and regulations issued by the Directorate of Fire and Rescue Services for his personal gain by obtaining bribe from the applicants during the period between January 2013 to 31.08.2018, though the guidelines clarified that the District Fire Officer would not issue No Objection Certificate to the schools.

The Accused Tr.M.Ravichandran, District Officer, Fire and Rescue Services, Thanjavur violated the Government orders and the Director, Fire and Rescue Services guidelines issued No objection Certificates / Fire Safety Certificates to the lodges, industries, hotels etc., in Thanjavur District by

obtaining bribe from the applicants, without inspecting the spot and scrutinizing the Forms of Annexure-III i.e. details given by the applicants and Annexure-V i.e. inspection report from the Station Fire Officers during the period between 2013 and 2018.

The Accused Tr.M.Ravichandran, District Officer, Fire and Rescue Services, Thanjavur had committed malpractices and irregularities in the booking of rooms for staying of officers on the eve of Mahamaham Festival during the year 2016 and prepared forged bills and claimed two bills in the same name and the same period by forging the signature of the lodge manager and swindled the Govt. fund of Rs.8,580/- for his personal gain during the year 2016.

The Accused Tr.M.Ravichandran, District Officer, Fire and Rescue Services, Thanjavur had committed offences of cheating, forgery, forgery for the purpose of cheating, used the forged documents as genuine u/s 420, 467, 468, 471 IPC and 13(2) r/w 13(1) (c) and 13(1) (d) of PC Act, 1988.

Hence as per the order of the Director, Directorate of Vigilance and Anti Corruption, Chennai-16 Memorandum in PE 424/2017/FS/TH dt: 02.02.2021 and as per the G.O.(2D) No.339 of Home (Police-XVII) Department dt:31.12.2020, I am registering a case in Thanjavur V&AC Cr.No.6/2021 on 11.03.2021 for the above said offences u/s 420, 467, 468, 471 IPC and 13(2) r/w 13(1) (c) and 13(1) (d) of PC Act, 1988 against the accused.

The original FIR is submitted to the Hon'ble Chief Judicial Magistrate-cum-Special Judge, Thanjavur @ Kumbakonam and a copy of the same is sent to the Superintendent of Police, Southern Range, Directorate of Vigilance and Anti Corruption, Chennai.
