The Preliminary enquiry report revealed that, the A.O-1 Tr. A. Ulaganathan, was working as Junior Engineer at Kanchipuram Municipality in Kanchipuram District in year 2012. Prior to that, he worked as Junior Engineer from 2004 to 2011 in Arni Municipality, Tiruvannamalai District and Kanchipuram in 2012 and Nellikuppam in 2013 and then he served as an Engineer from 01.10.2014 to 05.02.2016 in Thiruvathipuram Municipality, Tiruvannamalai District and held additional charge of Municipal Commissioner, Thiruvathipuram Municipality and then worked as Assistant Engineer from 06.02.2016 to 29.02.2016 in Vellore Municipality in Vellore District, during the period of the commission of offence.

AO-1 is a Public Servant as defined u/s 2(c) of the prevention of Corruption Act 1988 during the period of commission of offence. A-2 Tmt. Rajeshwari is the wife of AO-1. She is working in a private concern as a cashier at Kanchi Pallavan Engineering College in Iyyankarkulam Village.

Collection of sources reveals that A.O-1 Tr. A. Ulaganathan hails from a middle class family. He is native of Iyyankarkulam Village, Kanchipuram Taluk and District. A.O-1 and A-2 are blessed with one son and one daughter and they are studying school education.

It is gathered that A.O-1 Tr. A. Ulaganathan amazed wealth in his name and in the name of his wife A-2 Tmt. Rajeshwari during the period of his office in various places. Most of the acquisitive activities of A.O-1 and his wife A-2 fall between 01.04.2011 and 31.03.2017 and hence it was chosen as tentative check period and during that period the AO-1 and his family members were found in possession of assets as detailed below.

Assets found in the name of A.O -1 Tr. A.Ulaganathan : and his wife A.2 Tmt. Rajeshwari in form of House site and a two wheeler at the beginning of the check period i.e as on 01.04.2011.

Assets found in the name of A.O-1 and his family : members in form of House site and bank balances etc., at the end of the check period i.e. as on 31.03.2017.

Rs.86,66,698/-

Income of A.O1 and his family members from known : sources in the form of monthly salary, housing loan, Maturity amount of Recurring Deposit, LIC and Bank Interest during the check period from 01.04.2011 to 31.03.2017

Rs. 71,31,188/-

Expenditure incurred by A.O-1 and his family members : during the check period from 01.04.2011 to 31.03.2017.

Rs. 27,00, 587/-

Value of the assets acquired by A.O-1 and his family : members during the check period from 01.04.2011 to 31.03.2017

Rs.83,84,835/-

Likely savings of A.O-1 and his family members during :

Rs.44,30,601/-

Disproportionate Assets acquired by A.O-1 and his : family members during the check period from 01.04.2011 to 31.03.2017

Rs.39,54,234/-

The available information makes out a prima facie case that A.O-1 Tr.A.Ulaganathan and his wife A-2 Tmt. Rajeshwari were in possession of pecuniary resources and properties to the tune of Rs.39,54,234/- (Percentage of net disproportionate assets – 55.44%) during the check period 01.04.2011 to 31.03.2017, which is disproportionate to their known source of income. There by , A.O-1 had committed the offence of Criminal Misconduct by amassing wealth during the period of his office and A-2 Tmt. Rajeshwari had abetted him to commit the said offence by acquiring the assets through the resources of A.O-1.

Therefore today on 17.09.2021 at 10.30 hrs I registered a case in Tiruvannamalai V&AC Cr. No.06/2021 against A.O-1 Tr.A.Ulaganathan for commission of offence u/s 13(2) r/w 13 (1)(e) of the Prevention of Corruption Act 1988 and A-2 Tmt. Rajeshwari for commission of offence u/s 12 r/w 13(2) r/w 13 (1)(e) of the PC Act 1988

The original First Information Report is submitted to the Hon'ble Chief Judicial Magistrate Cum Special Judge, Tiruvannamalai and a copy of the First Information Report is sent to the Superintendent of Police, Vigilance and Anti-Corruption, Western Range, Chennai-16 for issuing order u/s 17 of the Prevention of Corruption Act 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers book in relation to the accounts of A.O-1 Tr. A. Ulaganathan and A-2 Tmt. Rajeshwari.
