**CONTINUATION OF FIRST INFORMATION REPORT IN
COIMBATORE V & AC CR.NO. 7/2021/AC/CB, Dated.17.02.2021.**

It is submitted that, an enquiry was conducted against Dr.G.James Pitchai, formerly Vice Chancellor of Bharathiar University, Coimbatore (Now retired). The enquiry revealed the following informations :

1) The accused Dr.G.James Pitchai was entered into the Government service on 09.12.1978 as Assistant Professor in the department of Agricultural at Tamil Nadu Agricultural University, Coimbatore. Then he was elevated as Associate Professor on 14.01.1988 and working in the Tamil Nadu Agricultural University till 26.07.1998. He was elevated as Professor on 27.07.1998. During his period of Professor, he was appointed as Dean on 22.11.2009 and working in Tamil Nadu Agricultural University (TNAU), Coimbatore till 06.02.2012. He was also appointed as the Vice Chancellor of Bharathiar University, Coimbatore on 21.09.2012 during his tenure as Professor and working till 20.09.2015.

2) The accused Dr.G.James Pitchai born on 16.09.1954. He studied his B.Sc (Agri) degree at TNAU, Coimbatore from 1972 to 1976 and studied his M.Sc (Agri) degree at TNAU, Coimbatore from 1976 to 1978.

3) He married Dr.Mala Fenn in the year 1984. Dr.Mala Fenn completed her MBBS degree in the year 1984 and completed her MD degree(DGO) in the year 1992. In the year 1997, she took over Fenn Hospital, which was run by his father.

4) The accused Dr.James Pitchai has a daughter by name Dr.Divya James Fenn and she is a Gynecologist. She studied her MBBS degree from May 2006 to March 2012 at Chettinad Hospital and Research Institute, Kelampakkam, Chennai and studied her MS degree from May 2012 to March 2015 at Sri Balaji Medical College, Chennai. She got married with Dr.Girinath in the month of June 2015. Both Girinath and Divya James Fenn are working in Fenn Hospital, Madurai.

5) The accused son Dr.Divaker James Fenn is a Ortho surgeon and he is working in Fenn Hospital as Orthopedics. He studied his MBBS degree at Chettinad Hospital and research institute, Kelampakkam, Chennai from March 2008 to May 2014. and studied his MS degree at the same institute from March 2015 and May 2018. He got married with Chandel Vincent on 30.01.2020.

6) Since, the accused Dr.G.James Pitchai was working as Vice Chancellor from 21.09.2012 to 20.09.2015, the said period is taken as check period for calculating disproportionate assets acquired by him. During this period, the accused was a public servant u/s 2(c) of Prevention of Corruption Act 1988.

7) The enquiry revealed that, during the period between 21.09.2012 TO 20.09.2015, The accused Dr.G.James Pitchai and his wife Dr.Mala Fenn, his daughter Dr.Divya James Fenn and his son Dr.Divaker James Fenn has acquired land and building properties in and around Madurai, Kodaikkanal and Chennai which are disproportionate to his known sources of income.

8) The accused Dr.G.James Pitchai having assets for the value of Rs. **3,21,59,271.80/-** as on 21.09.2012 i.e., at the beginning of the check period (Statement-I). The accused acquired assets in the name of himself and his family members for the value of Rs. **8,75,07,066.85/-** as on 20.09.2015 i.e., at the end of the check period (Statement –II).

9) During the check period between 21.09.2012 to 20.09.2015, the accused Dr.G.James Pitchai and his family members earned income of Rs.**4,57,19,135.68/-** from his salary and other lawful sources (Statement-III). The accused Dr.G.James Pitchai and his family members incurred expenses during the check period was Rs.**5,20,73,947.00/-** (Statement-IV).

10) Hence, the asset acquired by the accused Dr.G.James Pitchai in his name and in his family members during the check period was **Rs. 5,53,47,795.05/-** i.e. (Rs. **8,75,07,066.85/** – Rs. **3,21,59,271.80/**) (Statement–V)

11) Likely savings of the accused Dr.G.James Pitchai and his family members during the check period was Rs.**(-)63,54,811.32** i.e. Rs. **4,57,19,135.68/** – Rs. **5,20,73,947.00/-**. (Statement-VI).

12) Hence, during the check period between 21.09.2012 and 20.09.2015, the accused acquired disproportionate assets in the name of himself and his family members was Rs. **6,17,02,606.37/-** (Statement V – Statement VI)

13) The above information discloses commission of cognizable offences of criminal misconduct committed by public servant punishable u/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988.

14) Hence, the accused Dr.G.James Pitchai being a public servant, while working as Vice Chancellor, Bharathiar University, Coimbatore from 21.09.2012 to 20.09.2015, committed the offences punishable under section 13(2) r/w 13(1) (e) of the Prevention of Corruption Act, 1988.

15) There are prima facie material available for taking investigation against accused Dr.G.James Pitchai for the commission of offences punishable u/s 13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988. Hence, Today 17.02.2021 at 11.30 hrs, I am registering a case in Coimbatore V & AC crime No.7/2021/AC/CB, u/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 against Dr.G.James Pitchai for the aforesaid offences for the purpose to investigation.

16) The original FIR is submitted to the Special Judge, Special court for trial of cases under the Prevention of Corruption Act, Coimbatore and a copy of it is being sent to the Superintendent of Police, Western Range, Vigilance and Anti-Corruption, Chennai for issuing authorization u/s 17 & 18 of the Prevention of Corruption Act, 1988 to take up investigation in this case.
