The A-1 Tr.M. Baskaran, S/o. Moni is working as Block Development Officer, Padappai, Chennai. formerly he worked as Development Officer (Village Panchayat), St. Thomas Mount Block, Sitlapakkam, Kanchipuram District is a Public Servant u/s, 2 (c) Prevention of Corruption (Amendment) Act 2018. He was joined as Typist, Rural Development, Kancheepuram Collectorate the 17.05.1996. He was promoted to rank of Block Development Officer in the year March 2018 at Block Development Office. Kuntathoor. Then he was transferred in the year 13.09.2019 at St. Thomas Mount Panchayat Union Office. Sitlapakkam. During the Check Period from 01.09.2014 and 07.11.2019 the AO held the post of Block Development Officer (Village St. Thomas Panchayat), Mount Block. Sitlapakkam, Kanchipuram District. The A-2 Tmt.B.Sangeetha is the wife of Tr.M.Baskaran (A-1). She is a house wife and doesn't have any independent source of income.

A-1 Tr. M. Baskaran accumulated maximum assets during the period from 01.09.2014 to 07.11.2019. Hence, the Check period is fixed from 01.09.2014 to 07.11.2019 for calculating Disproportionate Assets acquired by him.

During the check period from 01.09.2014 to 07.11.2019 the A-1 acquired assets / pecuniary resources in his name and in the name of his wife A-2 Tmt. B. Sangeetha who had insufficient means to purchase the properties found in her name.

Assets and pecuniary resources held by the A-1 Tr. M. Baskaran and his wife A-2 Tmt. B. Sangeetha at the beginning of the check period as on 01.09.2014 was Rs.1,12,240/-.

Assets and pecuniary resources held by the A-1 Tr. M. Baskaran in his name and in the name of his wife A-2 Tmt. B. Sangeetha at the end of check period as on 07.11.2019 was Rs.59,14,484/-.

Income earned by the A-1 Tr. M. Baskaran during the check period between 01.09.2014 and 07.11.2019 was Rs.46,28,009/-.

Expenditure incurred by the A-1 Tr. M. Baskaran and his wife A-2 Tmt.B.Sangeetha during the check period between 01.09.2014 and 07.11.2019 was Rs. 35,57,212/-.

Assets acquired by the A-1 Tr. M. Baskaran and his wife A-2 Tmt.B.Sangeetha during the check period between 01.09.2014 and 07.11.2019 was Rs. 58,02,244/-.

Likely Savings was Rs. 10,70,797/-.

Disproportionate assets acquired by AOs during the check period was Rs. 47,31,447/- which was calculated to be 102% over his income.

A-2 being wife of A-1 abetted A-1 and persuaded in commission of offence of criminal misconduct by lending her name to acquire properties by A-1 which are disproportionate to his known sources of income.

The above information discloses commission of cognizable offences of criminal misconduct committed by Public Servant. Thus there are prima facie materials available for taking investigation against A-1 for the commission of offences punishable U/s. 13(2) r/w 13 (1) (b) of Prevention of Corruption (amendment) Act 2018. And against A-2 for offences punishable U/s. 12 r/w 13 (1) (b) of Prevention of Corruption (amendment) Act 2018.

Hence, I am registering a case in DVAC, Headquarters Crime No. 07/2021 u/s 13(2) r/w 13 (1) (b) of Prevention of Corruption (amendment) Act 2018 against A-1 Tr. M. Baskaran and 12 r/w 13 (1) (b) of Prevention of Corruption (amendment) Act 2018 against A-2 Tmt.B.Sangeetha for the aforesaid offences.

The original F.I.R. is submitted to the Hon'ble Special Judge for the cases under Prevention of Corruption Act, Chennai and a copy of it is being sent to the Superintendent of Police, Special Investigation Cell, Vigilance and Anti-Corruption, Chennai.
