(C.Jayasree), Inspector Police, Vigilance and Anti-Corruption, Thoothukudi Detachment while was on duty on 01.11.2021, I received a confidential official memorandum of Director of Vigilance and Anti-Corruption, Chennai instructing register a case on the outcome of a Vigilance Report. register the following against (1.)case Block Tr.A.Muruganantham, Development Officer, Formerly Puthukottai Union. Panchayat (2.)Tmt.M.Selvanayagi, Panchayat Secretary, Ayyanadaipu Panchayat Panchayat Formerly Puthukottai Thoothukudi V&AC Union. as Cr.No.07/2021 u/s 120-B, 409, 420, IPC and 13(2) r/w 13(1)(c) and 13(1)(d) of Prevention of Corruption Act. 1988 on 01,11,2021 at 17,00 hrs The details are as under:

Based upon the Vigilance report the following information was gathered.

A-1 Tr.A.Muruganantham was working as Block Development Officer, Block Panchayat, Puthukottai, Thoothukudi District from 20.08.2014 to 27.01.2016 and A-2 Tmt.M.Selvanayagi was working as Panchayat Secretary, Ayyanadaipu Panchayat, Thoothukudi District from 01.12.2011 to 2020. As such the above 2 accused are Public Servants within the ambit and purview of Sec. 2 (c) of Prevention of Corruption Act, 1988 undoubtedly.

- 3. The A-1 Tr.A.Muruganantham was Block Development Officer, Block Panchayat, Puthukottai, Thoothukudi District from 20.08.2014 to 27.01.2016. During his tenure as Block Development Officer, Puthukottai, A-1 Tr.A.Muruganantham entered into criminal conspiracy with A-2 Tmt.M.Selvanayagi, Panchayat Secretary of Ayyanadaipu Village Panchayat and issued work order in the name of Tr.Mariappan, the father of A-2 Tmt.M.Selvanayagi under Chief Ministers' Solar Powered Green House Scheme during 2015-16 even though both A1 and A2 were aware that Tr.Mariappan was in-eligible to get scheme house as per the eligibility criteria prescribed by the Scheme.
- 4. In continuation of the criminal conspiracy, both A-1 and A-2 by misusing their official capacity had cheated the Government by constructing the scheme house at the place in the name of A-2 Tmt.Selvanayagi situated at Ayyanadaipu Village Survey No.165/1.
- 5. On 03.06.2011, The Government launched a "Solar Powered Green House Scheme" for benefit of poor in Rural areas to construct house of 300 Sq.ft. for Rs.1.80 lakh as per G.O(Ms) No.46 Rural Development and Panchayat Raj (SGS1) Department dt.17.08.2011, and subsequently as per G.O (Ms) No.98 Rural Development and Panchayat Raj (SGS1) Department dated 31.07.2013 and G.O (Ms) No.74 Rural Development and Panchayat Raj (SGS1) Department dated 26.06.2014 Government enhanced unit cost from

Rs.1,80,000/-to Rs.2,10,000/- and ad laid eligibility conditions for selection of beneficiary.

- 6. The G.O (Ms) No.46 dt. 17.08.2011, G.O (Ms) No.98 dt. 31.07.2013, G.O (Ms) No.74 dt. 25.06.2014 laid responsibility on the part of the Block Development Officer (BP) that he should issue the work order to the beneficiary after confirming the eligibility of beneficiaries. A-1 Tr.A.Muruganantham, Block Development Officer (BP) was responsible to confirm the eligibility of beneficiaries and to issue work order. A-1 Tr.A.Muruganantham gave work order No. 4/5353/2015 dated 10.04.2015 to one Tr.Mariappan, who is the father of A-2 Tmt.M.Selvanayagi, to construct scheme house under "Chief Minister's Solar Powered Green House Scheme 2015-16" even though the beneficiary Tr.Mariappan had Pucca concrete house in his wife's name Tmt.Thangam.
- 6. Tr. Mariappan after receipt of work order constructed Scheme House at Plot No.10, Punitha Nagar, Ayyanadaipu Village Panchayat which is in the name of his daughter A-2 Tmt.M.Selvanayagi and got the house assessed as No.3/2-37 in the name of Tmt.M.Selvanayagi, wherein A-2 Door Tmt.M.Selvanayagi is residing. Thus A-2 Tmt.M.Selvanayagi, Village Panchayat Secretary who was in-eligible to get any Scheme House entered into criminal conspiracy with A-1 Tr.Murugariantham and availed wrongful gain by getting work order from A-1 in the name of her father Tr. Mariappan who was also in-eligible to get scheme house and thereby obtained pecuniary advantage A-1 Tr.Muruganantham and of Rs.2.10.000/and thereby Tmt.M.Selvanayagi had committed the offences of criminal breach of trust, cheating, criminal misappropriation punishable under the Indian Penal Code and criminal misconduct by public servant punishable u/s 13(2) r/w 13(1)(c) & (d) of the Prevention of Corruption Act. 1988.

Thus the above said acts of the accused would disclose the prima facie offences u/s 120-B, 409, 420, IPC and 13(2) r/w 13(1)(c) and 13(1)(d) of Prevention of Corruption Act, 1988.

Previous approval as per section 17A of the Prevention of Corruption Act-1988 as amended in 2018 was also obtained for both accused from the authority competent as G.O. (3D) No.09 Rural Development and Panchayat Raj (E2) Department dated 19.03.2021.

I am therefore registering the case in Thoothukudi Vigilance and Anti Corruption Cr.No.07/2021 u/s 120-B, 409, 420, IPC and 13(2) r/w 13(1)(c) and 13(1)(d) of Prevention of Corruption Act, 1988 on 01.11.2021 at 17.00 hrs against the accused (1)Tr.A.Muruganantham, Block Development Officer, Formerly Puthukottai Panchayat Union, (2.)Tmt.M.Selvanayagi, Panchayat Secretary, Ayyanadaipu Panchayat Formerly Puthukottai Panchayat Union Thoothukudi District.

The original F.I.R is submitted to the Hon'ble court of the Chief Judicial Magistrate cum Special Judge, Thoothukudi and as per instructions; I am sending a copy of FIR to Tr.G.Hector Dharmaraj, Deputy Supdt. of Police, Vigilance and Anti-Corruption, Thoothukudi for taking up investigation and copies of the FIR are sent to officers concerned.
