Attender of A-1, (Private individual) Credible source information was received against the marginally noted A-1 to A-5 with regard to allegation of conspiracy, demand and acceptance of undue advantage, abetting the offence of bribery, etc.

The information disclosed the following:

The A-1 is now working as Joint Chief Engineer (Highways), O/o the Chief Engineer, Planning, Designs and Investigations, Guindy, Chennai. Previously she worked as Superintending Engineer, Hindu Religious and Charitable Endowments. Chennai from 04.01.2017 to 25.06.2019. She is Public Servant as per the provisions of the Prevention of Corruption Act. Her reputation is ascertained to be not good. The A-2 Mr.N.Dhakshinamoorthy, A-3 Mr.S.Gnanasekaran are said to be relatives. A-4 Ms.Vidya Lakshmi is daughter of A-1. A-2 to A-5 are private individuals.

2) One Mr.Aman Goyal is C.E.O of M/s.Radianz Pvt.Ltd., having office at G/37, Sector-5, Bawanalndl. Area, Delhi – 110039. The Company has been in the business of rendering Electrical, Telecom and Civil Contract services including installation of LED lightings.

3) During April 2019, A-2 Mr.Dhakshinamoorthy, native of Salem District, now settled in Mumbai and his relative A-3 Tr.S.Gnanasekaran approached Mr.Aman Goyal in Delhi and told him that they were the right persons with necessary background knowledge as well as having regular contacts with higher officials in various departments under Government of Tamil Nadu and they would help him to get contracts for installation of LED lightings across the State and National Highways in the State of Tamil Nadu. Further, they had gone through the company's profile and works rendered in the last few years and told the company that they were satisfied with its performance and told it was eligible for proposed multi-crore project in Tamil Nadu.

4) In this regard, A-2 and A-3 brought Mr.Aman Goyal to Chennai on 27.04.2019 and introduced to A-1 Mrs.T.Karthikeyani, who at that time was working as Superintending Engineer in Hindu Religious and Charitable Endowments Department, Chennai, at her residence in House No. 6, Baywatch Cross, 1, Pandiyan Nagar, Near Vettuvankeni Olive Beach, Chennai.

5) In the said meeting which happened on 27.04.2019, the A-1 Mrs.T.Karthikeyani told Mr.Aman Goyal that she was the deciding authority in respect of awarding the multi-crore Government contracts particularly lighting works to be carried out in famous temples under HR&CE department and that the contract would be awarded to whomsoever she says. She further demanded a sum of Rs.1,30,00,000/- (Rupees One Crore thirty lakhs) immediately to her for securing the contract. When Mr.Aman Goyal, requested for some time with an intention to know the veracity and genuineness of her assertions, she further warned that the moment he walks out of the door without securing this contract by paying the amount so demanded, the contract would be given to another person who is next in line and waiting to yield to her demands.

6) Having left with no choice and lured to secure the contract in this highly competitive field, he made arrangements for a sum of Rs.1,00,00,000/- (Rupees One Crore) in cash to be brought immediately to her residence next day (28.04.2019) where the meeting took place and handed over to her in a red colour bag. However, while handing over the money, he had video recorded the receipt of the cash by

Mrs.Karthikeyani and her daughter A-4 Ms.Vidya Lakshmi, who counted the sum of Rs.1,00,00,000/- (Rupees One Crore) and placed it in the presence of A-2 and A-3.

7) Subsequently also the A-1 made demand of Rs.30 lakh additionally, for which, in June 2019, Mr.Aman Goyal gave Rs.30,00,000/- (Rupees Thirty Lakhs) to A-1 through 3 cheques i.e. two cheques in the name of her daughter Ms.Vidya Lakhsmi and another cheque in the name of her attender A-5 Mr.Kesavan, as believed to be her agent, in the following manner:-

- (1) YES bank Current Cheque Nos. 237078, dated 10.06.2019 for Rs.26,00,000/- in the name of Miss. Vidya Lakshmi.
- (2) YES bank Current Cheque Nos. 237079, dated 10.06.2019 for Rs.2,00,000/- in the name of Miss. Vidya Lakshmi.
- YES bank Current Cheque Nos. 237080, dated 10.07.2019 for Rs.2,00,000/- in the name of Mr. S.Kesavan.
 The amounts were withdrawn by A-1 and her associates.

8) Subsequently, there was no response from A-1 and her associates, hence Mr.Aman Goyal came to Chennai and met A-1 at a restaurant at Residency Towers Hotel, Chennai, wherein she further demanded amount of Rs.3 crore stating that the amount received by her earlier was shared among officials and she promised to secure the lighting contract worth Rs.400 crore and told not to worry about the money which was paid to her earlier.

9) Further Mr.Aman Goyal, undertook efforts to locate and approach her and her accomplice to get an update since it was almost a year since the receipt of the sum, only to understood later that there was no such contract published by the HR&CE department. Subsequently A-1 was shifted to Highways department as Joint Chief Engineer.

10) A-1 Mrs.Karthikeyani, being a public servant, conspired with other accused, abused her official position, in connivance with A-2 to A-5, indulged in corrupt practices demanded and accepted undue advantage of Rs.1,30,00,000/- (Rupees One Crore Thirty Lakhs) from Mr.Aman Goyal as a motive or reward in the pretext of getting contract to his company and also cheated the company.

11) The Competent Authority accorded previous approval as per the provisions of the Prevention of Corruption (Amendment) Act, 2018 to take up investigation. After getting permission from the higher officers, this case in DVAC Headquarters Cr.No.08/2021, u/ss 120B IPC and 7, 7A, 12 of the Prevention of Corruption (Amendment) Act, 2018 is registered against A-1 to A-5 this day 16.02.2021 at 16.30 hrs and taken up for investigation.
