Inspector of Police N&AC, Timelveli. Collection of sources reveals that Tr.S.lyyanar hails from a middle class family. He is native of Uthumalai Village, Tenkasi District. Tmt.Valarmathi is a wife of Tr.S.lyyanar.

It is gathered that Tr.lyyanar intentionally enriches himself illicitly in his name and in the name of his wife Tmt.Valarmathi during the period of his office in various places. Most of the acquisitive activities of accused and his wife falls between 01.01.2015 to 31.12.2020 and hence it was chosen as tentative check period. During that period the accused and his wife Tmt.Valarmathi were found in possession of assets as detailed below.

The available information makes out a prima facie case against A.O Tr.S.lyyanar that he is in possession of pecuniary resources and properties to the tune of Rs.41,43,268/- during the check period, which is disproportionate to his known sources of income. Thereby, A.O Tr.S.lyyanar had committed the offence of Criminal Misconduct by intentionally enriching himself illicitly during the check period of his office had abetted him to commit the said offence by acquiring the assets through the resources of A.O Tr.S.lyyanar.

Therefore, today 07.09.2021 at 13.00 hrs, I registered a case in Tirunelveli V&AC., Cr. No.09/2021 against A.O Tr.S.lyyanar for commission of offence u/s 13(2) r/w 13(1) (e) of Prevention of Corruption Act, 1988 and u/s 13(2) r/w 13(1) (b) of PC Act 1988 (as amended in) Act 16 of 2018.

The original F.I.R is submitted to the Hon'ble court of the Special Judge, Special Court for Trial of cases under PC Act, Tirunelveli and a copy of the FIR is sent to the Superintendent of Police, Vigilance and Anti-Corruption, Southern Range issuing order u/s 17 of the Prevention of Corruption Act 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of A.O Tr.S.lyyanar.
