

ACCUSSED:

Tr. K.Sampathkumar (52/2021) formerly Executive Officer, Pannapakkam Town Panchayat Ranipet District, Now Executive Officer, Sankarapuram Town Panchayat Kallakuruchi District.

It is gathered that during the period between 12.07.2018 and 18.12.2019, the accused noted in the margin working as Executive Officer, in Panapakkam Town Panchayat, is a public servant as defined u/s 2 (c) (i) of the Prevention of Corruption Act 1988 as amended by the Prevention

of Corruption (Amendment) Act 2018, During the period of commission of offence, the accused is the executive authority of Panapakkam Town Panchayat. He is assisted by Head Clerk, Junior Assistant, Bill Collector, Typist for the maintenance of records, collection of taxes, maintenance of assets and ensuring the publicity and propaganda and in implementation of Government programmes. The Town Panchayat is responsible in delivery of the following civic services; Providing basic amenities like roads, street lights, water supply, public health and drainage, Granting building licences, Levying of taxes like property tax, vacant land tax, professional tax, water tax, Issue of birth and death certificates, Issue of dangerous and offensive trade licences and Implementation of State/ Central schemes with respect to Panapakkam Town Panchayat.

2. The accused officer Tr. G.Sampathkumar, formerly Executive Officer, Panapakkam Town Panchayat, Ranipet District during the period between 12.07.2018 and 18.12.2019 had misappropriated the government funds to the tune of Rs.7,20,534/-which was allotted towards the development work of the Town Panchayat without following the tender rules. Further, the accused had given contract to selected persons

and obtained three quotations and without purchasing the items by generating forged bills and nexus with private individuals, withdrawn the government fund.

- 3. Further, the accused Tr. G.Sampathkumar, Executive Officer of Panapakkam Town Panchayat, without purchase of incurring expenditure towards dust bin, electrical items, cleaning and sanitation materials, Xerox and binding of booklet, name board and other maintenance submitted false/fake bills and claimed the town panchayat amount to the tune of Rs.5,94,105/-, vide Voucher Nos.685/2018-19, Dt:10.10.2018, 804/2018-19, Dt:19.11.2018, 814/2018-19, Dt:20.11.2018, 832/2018-19, Dt:03.12.2018, 833/2018-19, Dt:03.12.2018, 885/2018-19, Dt:14.12.2018, 874/2018-19 Dt:10.12.2018, 919/2018-19, Dt:31.12.2018, 925/2018-19, Dt:02.01.2019, 954/2018-19, Dt:04.01.2019, 956/2018-19, Dt:04.01.2019, 1004/2018-19, Dt:24.01.2019, 1018/2018-19, Dt:28.01.2019 1040/2018-19. Dt:05.02.2019, 1050/2018-19, Dt:05.02.2019, 1051/2018-19, Dt:05.02.2019, 1060/2018-19, Dt:07.02.2019, 1084/2018-19 Dt:11.02.2019, 1111/2018-19 Dt:15.02.2019, 1186/2018-19, Dt.15.03.2019, 1236/2018-19, Dt:22.03.2019, 1251/2018-19. Dt.26.03.2019. 1266/2018-19. Dt:28.03.2019. 1269/2018-19. Dt:28.03.2019, 1212/2018-19, Dt:20.03.2019, 1249/2018-19, Dt:26.03.2019, as if the items were purchased, and claimed the same from town panchayat fund and misappropriated the fund.
- 4. Further, the accused Tr. G.Sampathkumar, Executive Officer, formerly Panapakkam Town Panchayat, during the period between July 2018 and December 2019 transferred the fund from one account to another account vide voucher No.487/2018-19 Dt:03.09.2018, 788/2018-19 Dt:14.11.2018, 789/2018-19 Dt:14.11.2018 from General Fund to 14th Finance Account and vide voucher No.887/2018-19, Dt:20.12.2018 and 1157 from State Finance Commission Devolution Fund to General fund, to the tune of Rs.39,78,187/-, without the approval/permission of the higher official. The accused, without any specific reasons transferred the fund and claimed the same by submitting fake and false bills, vouchers.

- 5. Further, during the period between 2018 and 2019 the accused officer misappropriated the fund to the tune of Rs.36,410/- by generating false voucher Nos.BPV 404/2018-19, BPV 780/2018-19, BPV 1010/2018-19, BPV 1184/2018-19 and sanctioned, based on the letter given by the pump operator of Panapakkam Town Panchayat, without mentioning the place of repairs and estimate.
- 6. The accused without following the tender procedure claimed, purchased uniform to the staff of town panchayat and sanctioned excess uniform stitching charges vide voucher No.1023/2018-19 Dt:01.02.2019 to the tune of Rs.37,087/- and voucher No. 1024/2018-19 Dt:04.02.2019, to the tune of Rs.17,075/-.
- 7. The accused Tr. G.Sampathkumar, Executive Officer of Panapakkam Town Panchayat, during the period between 04.01.2019 and 05.02.2019 without following tender procedure purchased the rain coat cover to the Dengue staff sanctioned Rs.37,760/- to Sivani Enterprises, Chengalpattu by preparing fake quotation bills and misappropriated the same as if purchased, vide Voucher No. 957/2018-19, Dt:04.01.2019, 962/2018-19, Dt:09.01.2019, 1026/2018-19, Dt:04.02.2019 and 1044/2018-19, Dt:05.02.2019.
- 8. Further, the accused misappropriated the Town Panchayat fund by generating false bills vide Voucher No.1058 Dt:07.02.2019, No.1200 Dt:19.03.2019, No.1211 Dt:20.03.2019 and withdrawn the amount to the tune of Rs.9,500/-, Rs.33,306 and Rs.9,453/- respectively, as if the amount were spent for the purchase of mask & hand gloves to the Health Workers, Stitching charges etc.,
- 9. The accused Tr. K.Sampathkumar, Executive Officer, formerly Town Panchayat, Panapakkam now Sankarapuram Town Panchayat, Kallakuruchi District, in the above said transaction during the year 2018 and 2019, in the name of suppliers those who were actually not running the said shop and quoting higher price as against the actual market price and extending their empty bills, fake bills without actually

purchasing materials, forged the official records as if the items were purchased and misappropriated the Panapakkam Town Panchayat fund to the tune of Rs.7,20,534/- and caused loss to the Government exchequer.

10. Prior approval was obtained for registering regular case from the competent authority concerned. Today 23/07/2021 at 15.00 hrs, I registered a case in Vellore V&AC Cr.No.10/2021 against accused Tr. K.Sampathkumar, Executive Officer, formerly Panapakkam Town Panchayat, Vellore District now Ranipet District for the commission of offence u/s. 409, 467 r/w 477-A, 468 r/w 477-A, 471 r/w 477-A IPC and 13 (2) r/w 13 (1) (b) of the Prevention of Corruption (Amendment) Act 2018.

The original FIR, is submitted to the Hon'ble Court of Chief Judicial Magistrate/Special Judge, Vellore, Vellore District and a copies are sent to the officer concerned.
