A-1 Tr.R.S.Rajan, Formerly District Registrar, (Now not allowed to retire), Chengalpattu Kanchipuram, Plot No.897, Door No.9, 10th Street, H-Block, Anna Nagar Chennai-40.

A-2 Tmt.Komathi, W/o.R.S.Rajan, Plot No.897, Door No.9, 10th Street, H-Block, Anna Nagar Chennai-40. The A-1 Tr.R.S.Rajan, S/o. Tr.K.Ramakrishnan formerly District Registrar, Chengalpattu, Kanchipuram District, (Now not allowed to retire) is a Public Servant u/s. 2 (c) of Prevention of Corruption Act, 1988. He was recruited as Grade II Sub-Registrar, by TNPSC Group-II Examinations in 1995. He was elevated to rank of District Registrar (Admin) on 06.10.2010 and was posted at the O/o. Sub-Registrar, Chengalpattu, Kanchipuram district. During the Check Period from 01.01.2006 to 31.12.2012 A-1 held the post of District Registrar, Registration Department.

The A-2 Tmt.Komathi, is the wife of Tr.R.S.Rajan (A-1) who is having a construction business and does not have sufficient resources to buy properties as found in her name.

A-1 Tr.R.S.Rajan accumulated maximum assets during the period from 01.01.2006 to 31.12.2012. Hence, the Check period is fixed from 01.01.2006 to 31.12.2012 for calculating Disproportionate Assets acquired by him.



During the check period from 01.01.2006 to 31.12.2012 A-1 acquired assets/pecuniary resources in his name and in the name of his wife A-2 Tmt.Komathi name Tmt. Komathi who had insufficient means to purchase the properties found in her name.

Assets and pecuniary resources held by the A-1 Tr.R.S. Rajan and his wife A-2 Tmt.Komathi at the beginning of the check period as on 01.01.2006 was Rs. 8, 89,908.00/-.

Assets and pecuniary resources held by the A-1 Tr.R.S.Rajan in his name and in the name of his wife A-2 Tmt.Komathi at the end of check period as on 31-12-2012 was Rs. 5,82,81,517.00/-

Income earned by the A-1 Tr.R.S.Rajan and in the name of his wife A-2 Tmt.Komathi during the check period between 01-01-2006 and 31-12-2012 was Rs. 3,14,75,720.00/-

Expenditure incurred by the A-1 Tr.R.S.Rajan and his wife A-2 Tmt.Komathi during the check period between 01-01-2006 and 31-12-2012 was Rs.60,96,584.00/-.

Assets acquired by the A-1 Tr.R.S.Rajan and his wife A-2 Tmt.Komathi during the check period was Rs. 5,73,91,609.00/-

Likely Savings was Rs. 2,53,79,136.00/-

Disproportionate assets acquired by AOs during the check period was Rs. 3,20,12,473/- which was calculated to be 101.70% over his income.

The above information discloses commission of cognizable offences of criminal misconduct committed by Public Servant u/s.13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988.

A-1 being public servant, by holding the post of the District Registrar, in the Registration Department, of Kanchipuram District, during the check period is reasonably suspected to have committed the offences punishable under section 13 (2) r/w 13(1) (e) of Prevention of Corruption Act, 1988.

A-2 being wife of A-1 abetted A-1 and persuaded in commission of offence of criminal misconduct by lending her name to acquire properties by A-1 which are disproportionate to his known sources of income.

Thus there are prima facie materials available for taking investigation against A-1 for the commission of offences punishable u/s. 13(2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988 and A-2 for offences punishable u/s. 13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988 r/w 109 I.P.C.

Hence, I am registering a case, today 03.08.2021 in V&AC, Headquarters Crime No.14/2021 u/s.13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988 against A-1 Tr.R.S.Rajan and u/s. 13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988 r/w 109 I.P.C. against A-2 Tmt.Komathi for the aforesaid offences.

The original F.I.R. is submitted to the Hon'ble Court of the Special Judge for Cases Under Prevention of Corruption Act, 1988, Chennai and a copy of it is being sent to the Superintendent of Police, Special Investigation Cell, Vigilance and Anti-Corruption, Chennai.
