Proprietor of Hotel GVC Veettu Sappaadu, Shri Narayani Bhavan & Adhi Narayana Bhavan. 	Municipality, Vellore District. 2. She is a public servant as defined u/s 2 (c) of the Prevention of Corruption Act 1988 and Tr. P.Saravanan, is a private individual.

3. The Accused Officer Tmt. J.Samundeeswari was born on 07.01.1979. She is working as Sanitary Supervisor in Gudiyatham Municipality since 03.01.2014.

4. Extraction of work from 200 sanitary workers engaged on a contractual basis and garbage collection process are being supervised by two sanitary supervisors namely (1) Tmt. J.Samundeeswari and (2) Tmt.Ramani and they have to maintain the muster roll for the outsourced sanitary workers and supervise their work.

5. Tr. P.Saravanan, S/o Patchiyappan has been running three hotels in Gudiyatham for the last two years in the name and style of 1) GVC Veettu Sappaadu at No.75, Arjuna Mudhali Street, Gudiyatham, 2) Shri Narayani Bhavan at No.4,5,6,7, Arjuna Mudhali Street, Gudiyatham and 3) Adhi Narayana Bhavan, No.104/2B2, R.S. Road, Opposite to SBI Bank & Veterinary Hospital, Gudiyatham.

6. Tmt.J.Samundeeswari, Sanitary Supervisor in Gudiyatham Municipality is having jurisdiction over the above three hotels. She had a cordial liaison with Tr. P.Saravanan. She regularly collects the garbage and the waste generated in the above three hotels at doorstep by engaging sanitary workers. For which, she used to collect from Tr. P.Saravanan a sum of Rs.1500/- per month for Adhi Narayana Bhavan and Rs.4500/- for the remaining two hotels GVC Veettu Sappaadu and Sri Narayani Bhavan as undue advantages. Apart from this, she used to collect Rs.3000/- per month as routine mamool from Tr.P.Saravanan. Altogether, she had been collecting a total sum of Rs.9000/- per month, as undue advantages from October 2020 to March 2021. for 6 months, to cause performance of public duties. On some occasions, Tmt. J.Samundeeswari, used to raise her demand of undue advantages from Tr. P.Saravanan (9361839001 and 9845212211) over the mobile phone that was pedantically recorded by Tr. P.Saravanan. Further,

7. Tr. P.Saravanan having outraged over the legal action of officials of Gudiyatham Municipality, circulated the audio file recorded by him on social media. Hearing of those conversations reveals that Tmt. J.Samundeeswari, had obtained undue advantages regularly. In one instance, on the demand of A-1 Tmt. J.Samundeeswari, A-2 Tr. P.Saravanan, delivered the demanded bribe amount through mobile payment from his mobile number 9845212211 linked with his City Union Bank account number 247001001081398 to A-1's account linked with mobile number 8682899273 on 20th March 2021.

8. The available information makes out a prima facie case against Tmt. J.Samundeeswari, Sanitary Supervisor, that she had been in the habit of collecting undue advantage from the general public and other commercial establishments to perform her official duty. The information available on hand clearly makes out a cognizable offence against Tmt. J.Samundeeswari, Sanitary Supervisor, u/s 7(a) & 13(2) of the Prevention of Corruption Act.1988 as amended in 2018.

9. The available information makes out a prima facie case against Tr. P.Saravanan that on some occasions when Tmt. J.Samundeeswari used to raise her demand of undue advantages from Tr. P.Saravanan over the mobile phone it was

pedantically recorded by Tr. P.Saravanan and it is gathered that, during the 2nd wave of Covid-19 Pandemic, on 14.05.2021, the management of the hotel 'GVC Veettu Sappaadu' being a commercial establishment violated the Standard Operating Procedure which is to be mandatorily followed during the pandemic. Hence, the Gudiyatham Municipality authorities, booked the said hotel under Tamil Nadu Public Health Act 1939 and collected compounding fees of Rs.5,000/- vide cash receipt for compounding fee in S.No. VEL/2020/47158 dated 14.04.2021. While collecting the compounding fee, Tr. P.Saravanan, being the proprietor of GVC Veettu Sappaadu had an altercation with the Municipality officials and deterred them from discharging their duty. In this connection Tmt. J.Samundeeswari, Sanitary Supervisor of Gudiyatham Municipality lodged a report in Gudiyatham Town Police Station. Based on the report, a case in Gudiyatham Town P.S. Crime No.203/2021, was registered against Tr. P.Saravanan on 18.05.2021. Tr. P.Saravanan, having outraged over the legal action of officials of Gudiyatham Municipality, belatedly after the expiry of 7 days of the statutory period provided under the act and circulated the audio file recorded by him on social media, further, to give unofficial additional extra care in the collection of garbage from his hotels i.e., inside the hotel, in and around the hotel, he offered bribe to Tmt. J.Samundeeswari.

10. Concurrence from Vigilance Commission is obtained for registration of a regular case. Therefore today on 11.12.2021 at 16.45 hrs, I registered a case in Vellore Vigilance and Anti-Corruption Cr.No:22/2021 against the Accused-1 Tmt. J.Samundeeswari, u/s 7 (a) & 13 (2) of the Prevention of Corruption Act.1988 as amended in 2018 and against the accused Tr. P.Saravanan u/s 8 of the Prevention of Corruption Act 1988 as amended in 2018.

11. The original First Information Report is submitted to the Hon'ble Special Judge/Chief Judicial Magistrate, Vellore and copy of the First Information Report is sent to the officers concerned.
