The accused-1 Tmt.V.Prema is presently serving as Executive Officer, Town Panchayat, Walajabad, Kanchipuram District. During the period between 03.03.2019 and 17.07.2020, the Accused-1 served as the Executive Officer in Thirumazhisai Town Panchayat, Thiruvallur District and as such she is a Public Servant as per Section 2 (c) of the Prevention of Corruption Act, 1988.

The accused - 2 namely M/s. Chennai Residential Developers Private Ltd., are real estate promoters who form layouts and carry on their business in and around Chennai, Kanchipuram and Thiruvallur Districts. It is a Commercial Organization as per section 9 (3) (a) of the Prevention of Corruption Act, 1988.

The accused-3 namely Thiru. Dega Srinivasalu Reddy, S/o. Ramgopal Reddy, is the Authorized Signatory and the person associated with the commercial organization namely A-2, who performs services for and on behalf of the said commercial organization as per section 9 (3) (c) of the Prevention of Corruption Act, 1988.

during the period between 03.03.2019 and 17.07.2020, M/s. Chennai Residential Developers Private Ltd., (A-2) had developed layout at Sembarambakkam Village which was earlier known as Neduncherry Village Survey Numbers 66/1B part, 2A part, 2B part & 3, 67/1 part, 2 part & 3 part and 68/8, 9A part, 9B part & 10 part to an extent of 9.5 acres (36,781 Sq.mts.) and also in Pirayampathu and Neduncherry Villages in Survey Numbers 64/2A2, 2B2, 2C, 3B & 6, 65/5B part, 66/1B part and 83/1B, to an extent of 13.98 acres (56,417 Sq.mts.) as Phase-I & Phase-II respectively. Accused-2, the said Commercial organization applied to CMDA to get layout approval for the above projects and the same was forwarded for clearance to Thirumazhisai Town Panchayat. Tmt.Prema (A-1), who was the then Executive Officer of the said Town Panchayat should have satisfied herself that the condition prescribed in the government orders concerned and the existing Rules and Regulations for giving clearance to the layouts developed by the promoters, were followed and the development of the layouts were in accordance with the government orders, Rules and Regulations. A-2 and A-3 should have executed the following works namely (1) Road Formation, (2) Drainage Specialities with Treatment Plant for Sewerage Planning, (3) Water Supply, (4) Street Lights, (5) Storm/Rain Water Harvesting System, (6) Park Developments, (7) Water tank, (8) Earth Filling, (9) Solid Waste Management System, (10) Scrutiny Fees and (11) Place for installation of T.N.E.B Transformer.

That Tmt.Prema (A-1), knowing fully well that A-2 and A-3 have not executed the above said works in the layouts, failed to obtain estimates from the concerned departments to collect the prescribed fee and development charges for the completion of the said works and further, Tmt.Prema (A-1) in her capacity as the Executive Officer of Thirumazhisai Town Panchayat had hastily obtained Gift Deeds in Document No. 4795/2019 dated: 31.12.2019 and Document No. 1174/2019 dated: 26.03.2019 respectively for Phase-I and Phase-II at Poonnamallee Sub-Registry from A-2 and A-3, who have not carried out and fulfilled the norms provided under the Rules and Regulations and had issued clearance certificates to facilitate A-2 and A-3 to get approval from

CMDA. Thus she had performed her public duty improperly and dishonestly in anticipation or in consequence of accepting an undue advantage from A-2 and A-3 by not collecting the prescribed fee and development charges from them, which resulted in wrongful loss to the government to the extent of Rs.2,78,12,423/- for both the phases and resulting in consequential benefit and wrongful gain to A-2 and A-3. A-1 had also ignored the fact that A-2 and A-3 have not followed the Rules laid down **CMDA** Master Plan-II by abetting each other for their personal wrongful gains.

Hence, the acts of A-1, A-2 and A-3 mentioned above clearly constitute cognizable offences warranting investigation by registration of a Criminal case. Therefore, a case in Kanchipuram V&AC Cr.No.2/AC/2022/KM, U/s. 7 (c) and 12 of the Prevention of Corruption Act, 1988 as amended by Amendment Act, 2018 is registered, which is within my competency to investigate after obtaining prior approval U/s. 17 (A) of the Prevention of Corruption (Amendment) Act, 2018 and taken up for investigation. Based on the findings of the Vigilance Report, A Regular Case is ordered vide DVAC Memorandum VR.NO.2163/2021/TP/KM, Dated: 07.03.2022, by obtaining prior permission from the Commissioner for Town Panchayats, M.R.C.Nagar, Chennai-28 vide C.No.6034/2021/2011, dated: 23.06.2021 to register a FIR against the Accused-1 Tmt.V.Prema, Executive Officer, formerly Thirumazhisai Town Panchayat, Thiruvallur District. Hence, I registered a case in Kanchipuram V&AC, Cr.No.2/AC/2022/KM u/s. 7 (c) & 12 of The Prevention of Corruption Act-1988, as amended by amendment Act, 2018 against the Accused-1 Tmt.V.Prema, Executive Officer and 2 others on 17.03.2022 at about 16.30 hrs and took up for action.
