Now Headmistress Government Higher Secondary School, Kovur, Sriperumbudur Educational District. A Preliminary Enquiry was conducted against Accused officer Tmt. V.Veeralakshmi to probe into allegations of misappropriation of Government fund Rs.1,66,000/- entrusted to her while she was working as Headmistress, Government Higher Secondary School, Anakaputhur, St.Thomas Mount Education Dt, Kanchipuram District during 09.08.2016 to 20.08.2019. The result of the enquiry reveals the following credible information.

Tmt. V.Veeralakshmi, is currently working as Headmistress, Government Higher Sec School, Kovur, Sriperumbudur Educational Dt, Kanchipuram district. She is a public servant as defined under Section 2(c) of Prevention of Corruption Act, 1988.

- 2) The Department of School Education vide G.O(Ms).No.255, dated: 05.12.2017 had announced establishment of "Competitive Exam Coaching Centers" in 412 Government / Aided schools in the State under "THODUVAANAM" Scheme to help students prepare for NEET Exam & others.
- 3) To effect the above G.O, the Director of School Education through proceedings vide Rc.No.33986/K/E3/2017 Dated 17.01.2018 directed Chief Educational Officers in the districts to accord financial sanction of Rs.58,800/- towards payment of faculty remuneration and Rs.1,66,000/- towards purchase of equipment (LCD Projector, Wall-mounted smart Board, Computer, etc) for each coaching center.

- 4) Accordingly, Chief Educational Officer, Kanchipuram District drawn proceedings vide Na.Ka.No.6521/A3/2017, dated 07.03.2018 and also issued Cheque No. 258895 for Rs.2,24,800/- (Rs.58,800 + Rs.1,66,000) to Headmistress, Anakaputhur, GHS School towards faculty remuneration & purchase of said equipment. The above cheque was credited into Headmaster's Indian Bank account on 15.03.2018.
- 5) The above amount Rs. 1,66,000/- meant for purchase of equipments was withdrawn as cash by accused officer Head mistress Tmt. V.Veeralakshmi, on 26.03.2018 through a self-drawn Cheque No.392445 and with dishonest intentions, swindled that money for her own use instead of purchasing the equipment.

In order to account for the money, she had created incorrect invoice bill dated 24.3.2018 on the letter-pad of firm M/s. ANS Equipments, as if, she had actually purchased the equipment by payment and then she submitted utilization certificate along above incorrect invoice bill to Chief Educational Officer, Kanchipuram, falsely stating that she has installed the equipment (wall-mount smart board, LCD Projector, Computer) worth Rs.1,66,000 to create virtual classroom for NEET coaching.

6) Further, the school's 'stock register' entries reveal that, the already existing, one virtual classroom in the school was created with similar equipment only during the year 2016 and the same is being currently utilized for NEET coaching. The 'Stock Register', entries for year 2018, doesn't reflect purchase of any equipment for creation of virtual classroom.

- 7) Hence, the accused officer Tmt. V. Veeralakshmi, while working as Headmistress, Government Higher Secondary School, Anakaputhur, St. Thomas Mount ED, Kanchipuram district between March 2018 & November 2018, with malafide intentions to gain pecuniary advantage, created incorrect purchase invoice bills, cheated the government by furnishing the same to CEO office, as if the equipments were purchased and installed, thereby she had dishonestly misappropriated the amount of Rs. 1,66,000/- for her own use which was entrusted to her causing revenue loss to government Exchequer. Thus, the act of Accused officer disclose prima facie evidence for the commission of cognizable offences u/s. 167, 409, 420 IPC and 13(2) r/w 13(1)(c) of PC Act 1988 and 13(2) r/w 13(1)(a) of PC (Amendment) Act 2018.
- 8) The aforesaid facts and circumstances reveal prima facie offences which I am empowered to investigate. The competent authority accorded previous approval in Na.Ka.No.17466/W1/E3/2020 dated 30.04.2021 of Directorate of School Education as per the provisions of the Prevention of Corruption (Amendment) Act, 2018 to take up investigation in this matter.

Therefore, after observing necessary formalities this day on 04.03.2022 at 1200 hrs, I'm registering a case in DVAC Headquarters Crime No 02/2022 u/s 167, 409, 420 IPC and 13(2) r/w 13(1)(c) of Prevention of Corruption Act 1988 and 13(2) r/w 13(1)(a) of Prevention of Corruption (Amendment) Act 2018, against Accused Officer Tmt.V.Veeralakshmi, Formerly Headmistress, GHSS, Anakpudur.

The original F.I.R. is submitted before the Court of Hon'ble Chief Judicial Magistrate/Special Judge, Chengalpet and copies are sent to the concern officers.
