Based on the Vigilance report submitted by an officer of the Directorate of V & AC, on the allegation that the Accused Officer-1 Selvi. A. N. Lavanya, District Backward Classes, Most Backward Classes and Minorities Welfare officer, Tiruvannamalai District, Accused Officer -2 Tr. Maheshwaran, Assistant Accounts Officer, DBCW Office, TVM District, Accused Officer -3 Tr.Dharmalingam, Tutor Cum Warden, Govt.College (MBC) Boys Hostel, Cheyyar, Accused Officer -4 Tr.Balaji, Hostel Warden, Govt. Students Hostel (BC), Tiruvannamalai, TVM Dist and Accused Officer -5 Tmt.K.Mangala Merry, Hostel Matron, Govt. Arts College Girls Hostel (BC), Cheyyar, Tiruvannamalai District misappropriated the Government fund by preparing false vouchers in the month of February 2019 and July 2019.

Tamil Nadu Government has formed 973 number of Backward Classes, Most Backward Classes and Minorities students Hostels throughout the State for the socio-economic empowerment and uplift the students from Backward classes, Most Backward classes. Various Government orders and detailed guidelines were issued in the Departmental Manual (updated on 23.12.2005) for the better management of these hostels and these must be scrupulously followed by the Hostel Wardens/ Welfare Officer DBCMWOs to safeguard the interest of the students. Feeding and dietary requirements of the students assumes foremost importance among other welfare measures provided to the students.

With regard to purchase of articles, in the departments manual, the under mentioned guidelines were issued:-

For the Purchase of the dietary articles of Rice, as per rule 56:

(i) Super fine rice required for the hostels should tie purchased through TNCSC on credit basis. The DBCMWOs shall furnish hostel wise monthly indent for rice requirement to the DSO for onward transmission to the Regional Manager, TNCSC, in the districts. After supply of rice and on receipt of bills from the TNCSC the bill should be settled to the TNCSC within 15 days from the date of receipt of bills.

For the purchase of Provisions, as per rule 57:-

Dietary articles other than rice, which are also sold by the T.N.C.S.C should be purchased only from the units of T.N.C.S.C or from the nearby co-op societies. If there are more than one co-op society provisions may be purchased from the co-op society which sells at lesser price without compromising on the quality.

For the purchase of Vegetables, Mutton / Chicken Egg etc., as per rule 58:-

"Items which are not generally sold by the co-op societies such as vegetables, Coconut, Mutton / Chicken, egg, lemon, Milk, Firewood etc., if not available in co-op, societies have to be purchased only through tender system by following Tamil Nadu Tender Transparency in tenders Act 1998 and Rules 2000. To overcome the difficulty and bottlenecks in fixing tender at District level, tender may be adopted at Taluk, Block

levels if required; Tenderer should be insisted upon to supply hygienic and good quality items as per tender specification without difficulty".

As mentioned in the guidelines above, all the food items especially groceries for the upcoming month and it should be calculated well in advance for a month and it should be purchased from the Co-Operative societies. If not they have to purchase only through tender system by following Tamilnadu Tender Transparency in tenders Act 1998 and Rules 2000 and buying of groceries in retails should be scrupulously avoided, at any cost.

Further as per rue 59, the report on finalization of tender should be sent to Directorates brfore 30th June every year.

During the course of enquiry into allegations of misappropriation of funds committed by AO1 to AO5, for a random check, the sanctioned bills of the following Hostels from Feb to July 2019 were perused,

For the sanction of the above bills, the respective hostel wardens/ Matrons enclosed an abstract of expenditure and self made, false documents of computer printed invoices/ Xerox. It was observed that proper bill was submitted only for the purchase of gas cylinder.

In the above said instant cases, the following irregularities / malpractices were unearthed in gross violation of the guidelines:-

1) The accused AO3 to AO5, hostel wardens/Matrons simply used computer print outs / Xerox of invoice model and prepared Invoice cum Receipts by filling up the details of groceries and price, and include the fictitious name of grocery shop and also

signed in the name of fictitious person as if groceries were supplied by them with intention to believe that the document was made by real person and sent the same to the DBCMWO's for sanction of fund.

- 2) The accused AO1 and AO2, knowingly that, AO3 to AO5 placed invoice cum receipt by violating the guidelines said above, clearly all the bills dishonestly with the collusion of accused AO3 to AO5.
- 3) AO3 to AO5 purchased commonly available groceries from private shops instead of Co-operative Societies which are easily available in all Co-operative societies by violating the guideline. Example: Jaggery and Red Chilli.
- 4). Further AO3 to AO5 made incorrect records of attendance Register by marking as if all students were present irrespective of their actual availability in order to hike the claim for funds, for the non present students, in order to misappropriate the amount

The nature of activity creates suspicion that the hostel wardens/matrons have not purchased the above items for quantity claimed in the bills with the listed price. The AO s have indulged in malpractices, created forged/ bogus invoices, submitted them as bonafide documents for sanction of Government funds from the higher authorities with malafide intension to misappropriate Government funds meant for the welfare and upliftment of economically margined students.

Further ,the DCBMWO of Tiruvannamalai District who are vested with the power to sanction the bill claims ,have failed to question and scrutinize the above mentioned irregularities in respect of the procedure for the purchase of groceries, furnishing of bogus bills as original bills etc.. This is a clear indication of conspiracy of DCBMWO with the erring Hostel wardens/matrons .

Considering all the above aspects it is presumed that these are all only fake bills to claim the Government allotted funds, with the intention to wilfully misappropriate and create loss to Government exchequer. The concerned Hostel wardens/Matrons, Assistant Accounts Officer, District Backward Classes Most Backward Classes and Minorities Welfare officers Tiruvannamalai have thereby conspired conjointly and misappropriated Government funds. while enquiring from some Hostel wardens/Matrons about the purchase of grocery items , they were not able to offer satisfactory explanation about the seller, shops etc.. which indicates foul play and malpractices .

On credible information it came to knowledge that the Suspect Officers 1,2,3,4 &5 colluded together for misappropriate Government money, and in consequence of collusion they committed forgery for the purpose of falsification of accounts, made false entries in the stock register, prepared bogus bills and used it as genuine and thereby claiming Rs.1,37,47,215/- (Rupees One Crore Thirty Seven lakhs Forty Seven Thousand Two Hundred and Fifteen only) from the government exchequer of which nearly 50% of the claim is bogus. Prior permission u/s 17 A of the Prevention of Corruption (Amendment) Act 2018 to register a Regular case against AO1 to AO5 was obtained from the competent authority.

The above incident is only a tip of the ice-berg. To unearth the whole incident in respect of Anti Corruption activities and the allegation involves the misappropriation of Government money, I am registering a case in Tiruvannamalai, V&AC, Cr.No. 02/2022 u/s. 120B, 167, 409,420, 467, 468, 471, 477 A IPC and u/s 13 (2) r/w 13 (1) (a) of Prevention of Corruption Act 1988, as amended by PC (Amendment) Act - 2018 against AO-1.Selvi.A.N.Lavanya, District Backward Classes, Most Backward Classes and Minorities Welfare officer, 2.Tr.Maheshwaran, Assistant Accounts Officer, 3.Tr.Dharmalingam, Tutor Cum Warden, Govt. College (MBC) Boys Hostel, Cheyyar, 4.Tr.Balaii. Hostel Warden, Govt. Students Hostel(BC). Tiruvannamalai. 5.Tmt.K.Mangala Merry, Hostel Matron, Govt. Arts College Girls Hostel (BC), Cheyvar, when serving in District Backward Classes, Most Backward Classes and Minorities Welfare Department, Tiruvannamalai on 09.02.2022 at 16.00 hrs.

The original was submitted to the Hon'ble court of special Judge cum Chief Judicial Magistrate, Tiruvannamalai and other copies were sent to the officers concerned.
