Noothencheri, Madampakkam, Chennai-126. A credible source information was received against the marginally noted accused and the information is as follows.

A.O Tr.S.Rajeswara Sethupathy full time was appointed as temporary Clerk at Vengaivasal, Panchayat Office, Madhurapakkam, Jalladiyan Pettai, Kancheepuram in 1988. Then in 1991, he was promoted as permanent Panchayat Secretary in the same place. Further, he was transferred to Chitlapakkam, Panchavat Office and he was working as Panchayat Secretary at the same office till August 2020. Now he is working as Panchayat Secretary at Panchayat Union Office, Melnagar, West Aarani, Thiruvannamalai District.

A.O Tr.S.Rajeswara Sethupathy is a Public Servant as defined u/s 2 (c) of the Prevention of Corruption Act, 1988 during the period of commission of offence.

The A.O Tr.S.Rajeswara Sethupathy is native of Madampakkam, Kancheepuram District, born in a below poverty line family. His father Tr.Shanmugam was an astrologer and mother Tmt.P.Gowri was a homemaker and he has 2 brothers, who do not have permanent employment.

In the year 2004, A.O married Tmt.R.Anandhi, D/o Pandurangan and they have no children. Tmt.R.Anandhi was a home maker and she didn't have any independent source of income. After demise of Tr.Pandurangan, his wife Tmt.P.Gowri lived with her daughter Tmt.R.Anandhi. Tmt.R.Anandhi expired on 07.07.2021. Except the A.O Tr.S.Rajeswara Sethupathy none of his family members have any other sources of income.

It is gathered that A.O Tr.S.Rajeswara Sethupathy intentionally enriches himself illicitly in his name and in the name of his deceased wife Tmt.R.Anandhi during the period of his office at Chitlapakkam Panchayat, Kancheepuram District only. Most of the acquisitive activities of accused fall between 01.01.2016 and 31.12.2019 and hence it was chosen as tentative check period. During that period the accused was found in possession of assets as detailed below.

The available information makes out a prima facie case against A.O Tr.S.Rajeswara Sethupathy that he is in possession of pecuniary resources and properties to the tune of Rs.23,86,686/- during the check period, which is disproportionate to his known sources of income. Thereby, A.O Tr.S.Rajeswara Sethupathy had committed the offence of Criminal Misconduct by intentionally enriching himself illicitly during the check period of his office.

This said information was forwarded appropriate authority and obtained their concurrence for taking up a Regular Case. Therefore, today 05.04.2022 at 13.30 hrs., I registered a case in DVAC, Headquarters Crime No.03/2022 against A.O Tr.S.Rajeswara Sethupathy for the commission of offence u/s 13(2) r/w 13(1)(b) of Prevention of Corruption(Amendment) Act 2018.

The original F.I.R. is submitted to the Hon'ble Chief Judicial Magistrate, cases under PC Act, Chengalpet and a copy is sent to the Superintendent of Police, Special Investigation Cell, Vigilance and Anti-Corruption, Chennai -16.
