As per the DVAC memo vide PE 2021/MISC/KM, dated:07.07.2022 Ι a Regular Case against the ter inally noted accused Tr.S.Devendran as Preliminary Enquiry A was vs. ucted against the accused officer Devendran as per the direction of the High Court of Madras in ble .P.No.18879/2021, dated 20.10.2021 based on the DVAC memo order in PE 2021/MISC/KM, dated.27.11.2021, with rd to the allegation of demand and ptance of Rs.7,00,000/- from one ruldoss by abusing his position as a c Servant, for arranging to get a rnment job in Animal Husbandry artment for Tmt.Sudhalakshmi, the wife r.Aruldoss during the month of January ) and cheated Tr.Aruldoss without ring any Government Job to his wife Sudhalakhsmi.

The accused Tr.S.Devendran was appointed on temporarily basis in the office of the then Minister for Housing and Urban Development with effect from 12.06.2016 and he was working as Office Assistant (Outsider) in the State Minister Office from 12.06.2016 to 07.05.2021 and during that period initially he was working at the office of the then Minister for Housing and Urban Development and subsequently he was working at the office of then Minister for Animal Husbandry Department, Government of Tamilnadu and he is a public servant as per the definition of 2 (c) (i) and (viii) of Prevention of Corruption Act 1988 (as amended in 2018).

The defacto complainant Tr.Aruldoss, S/o.Elumalai, Marakanam Road, Tindivanam Taluk, Villupuram District, was temporarily worked as Electrician at Secretariat, Chennai on contract basis during the period 2019-20 and at that time, the defacto complainant

Tr.Aruldoss had occasion to meet the accused and they became friends. The accused came to know that the wife of Tr.Aruldoss was a need of job. The accused officer Tr.Devendran informed to the defacto complainant Tr.Aruldoss that the Animal Husbandry Department has to call for notification for the post of Office Assistant and Live Stock Inspector (Gr-II) during the month of December 2019 and he would make arrangements to get job for his wife and instructed to apply for the above said two posts. As instructed by the accused officer, Tmt.Sudhalakshmi who was completed M.Com, B.Ed applied for the post of Office Assistant and Live Stock Inspector (Gr-II) on 06.12.2019 in Animal Husbandry Department.

Subsequently on 21.01.2020 when the defacto complainant Tr.Aruldoss approached the accused officer Tr.Devendran at Ponneri Bus Stand, Thiruvallur District with regard to the job for his wife, he demanded Rs.3,00,000/- for himself as undue advantage as a motive by using his personal influence in the minister's office to get the job and as instructed by the accused on 22.01.2020 at about 15.00 hrs at Ponneri Bus stand when Tr.Aruldoss met the accused, the accused demanded and accepted Rs.3,00,000/- as undue advantage from Tr.Aruldoss in the presence of friends of Tr.Aruldoss to arrange for job of Office Assistant in Animal Husbandry Department for Tmt.Sudhalakshmi. Further, at that time, the accused officer informed to the defacto complainant Tr.Aruldoss if he would pay additional amount of Rs.4,00,000/-, he would make arrangements for the job of Live Stock Inspector (Gr-II) and within a week, he would get an appointment order for the post of Live Stock Inspector (Gr-II) in Animal Husbandry Department.

Subsequently, on 23.01.2020 at about 17.30 hrs when the defacto complainant Tr.Aruldoss met the accused at Ponneri Bus Stand, Thiruvallur District, he demanded and accepted Rs.4,00,000/- from the defacto complainant Tr.Aruldoss in the presence of one Tr.Arivazhagan, friend of Tr.Aruldoss and accused undertook to get the appointment within three days, otherwise, he would return the amount of Rs.7,00,000/-. But the accused failed to get job for Tmt.Sudhalakshmi as per his undertaking.

The defacto complainant gave a petition before the Superintendent of Police, Thiruvallur for the illegal activities of the accused and subsequently, a case was registered in Thiruvallur DCB Cr.No.21/2021 U/s. 406, 420 IPC on 14.07.2021 against the accused Tr.Devendran and while the accused approached the Hon'ble High Court of Madras, a

direction was given to make enquiry into the above said matter by the V&AC department and a Preliminary Enquiry was conducted and the above said facts were found during that enquiry.

It is gathered that the accused officer Tr.Devendran while working temporarily as Office Assistant (Outsider) at the O/o the Animal Husbandry, Government of Tamilnadu by abusing his official position as Public Servant demanded and accepted Rs.3,00.000/- on 22.01.2020 and Rs.4,00,000/- on 23.01.2020 at Ponneri Bus Stand, Thiruvallur District from the defacto complainant Tr.E.Aruldoss in order to influence the unknown public servant to get the Govt. job in Animal Husbandry Department for the wife of Tr.Aruldoss and he obtained pecuniary advantage of Rs.7,00,000/- by abusing his official position as Public Servant and cheated the defacto complainant and hence there is prima facie materials available to suspect for the commission of cognizable offences warranting the registration of a regular Case against the accused Tr.S.Devendran, S/o.Subramaniya Reddiar, formerly Office Assistant (Outsider), O/o. the Minister for Housing and Urban Development, Govt. of Tamilnadu, Subsequently worked at the O/o. the Minister for Animal Husbandry Dept., Govt.

After completion of enquiry, the competent authority of the accused officer was requested to issue necessary permission u/s 17(a) of (Prevention of Corruption Act 2018), for which the State Government replied that prior permission to register a regular case against Tr.Devendran does not arise and seems not to be necessary in this case. The DVAC, Chennai also directed to register FIR in this case as per the Memorandum No.PE114/2021/MISC/KM, dated: 07.07.2022.

The registration of FIR is necessary to investigate and to unearth further facts and hence, I am registering a case in Kanchipuram V&AC Cr.No.4/2022/AC/KM u/s.420 IPC and 7 (A) of Prevention of Corruption Act 1988 (as amendment Act 2018) on 25.07.2022 at 16.00 hrs against the Accused Tr.S.Devendran, S/o Subramaniya Reddiar, formerly Office Assistant (Outsider)O/o. the Minister for Housing and Urban Development, Subsequently worked at O/o. the Minister for Animal Husbandry Dept., Govt. of Tamilnadu for the purpose of conducting investigation.

The original FIR is submitted to the Special Judge, Thiruvallur and copies were sent to the officers concerned.
