Tmt.V.Dhanalakshmi, W/o.A-1 Thiru S.Velusamy, Door No.3A, Thiruvalluvar Street, Chitlapakkam Main Road, Chitlapakkam, Chennai-600 064.

There was a Vigilance information that the marginally noted A-1 Thiru S. Velusamy while working Panchayat Secretary. Nanmangalam Panchayat during the period from 31.07.2020 01.01.2015 to accumulated and possessed assets and pecuniary resources in his name and in the name of his family members which are disproportionate to his known sources of income during the period between 01.04.2015 and 07.11.2019

- 2) This information was verified through a Preliminary Enquiry.

  Based on the outcome of the Preliminary Enquiry, the

  Directorate has permitted to register FIR and taken up investigation. The

  outcome of the Preliminary Enquiry discloses the following:-
- Thirumangalam Taluk, Madurai District. He has been residing at Door No.4, Thiruwalluvar Street, Chitlapakkam Main Road, Chitlapakkam, Chennai with his wife A-2 Tmt.V.Dhanalakshmi and the couple is blessed with a son Pugalendhi.

- Panchayat Secretary, Nanmangalam Panchayat, now Panchayat Secretary, Thandarampet Union, Thiruvannamalai District is a Public Servant as defined by the Prevention of Corruption Act. The Accused-1 Thiru S.Velusamy, while holding office as public servant during his tenure as Panchayat Secretary, Nanmangalam Panchayat from 01.01.2015 to 31.07.2020 has acquired and was in possession of movable and immovable assets in his name and in the name of his wife A-2 Tmt.V.Dhanalakshmi, which are disproportionate to his known sources of income
- 5) The Accused A-2 Tmt.V.Dhanalakshmi is a working as Assistant Manager (Sales) in M/s.TAG Corporation, Manufacturing of hardware fittings for Towers, Chrompet, Chennai and A-2 abetted A-1 for acquiring movable and immovable properties.
- 2015 and 2019, the check period for assessing the disproportionate assets is taken from 01.04.2015 and 07.11.2019. The Value of the assets found in his name, and his wife A-2 Tmt.V.Dhanalakshmi's name as on 01.01.2015 have been shown in Statement-I. The Value of the assets found in possession of the Accused-1 Thiru S.Velusamy in his name and in the name of his wife A-2 Tmt.V.Dhanalakshmi at the end of check period as on 07.11.2019 have been shown in Statement-II. The income derived by the Accused-1 Thiru S.Velusamy, his wife A-2 Tmt.V.Dhanalakshmi through known sources of

income during the check period have been shown in Statement-III and the expenditure incurred by the A-1 Thiru S.Velusamy and his wife A-2 Tmt.V.Dhanalakshmi during the check period have been shown in Statement-IV are described hereunder.

From the above statements, during the check period between 01.04.2015 and 07.11.2019 the value of assets acquired by the Accused-1 Thiru S.Velusamy and his wife Accused-2 Tmt.V.Dhanalakshmi have been calculated in Statement-V. The likely savings of the Accused-1 Thiru S.Velusamy and his

wife A-2 Tmt.V.Dhanalakshmi have been shown in Statement-VI and the quantum of disproportionate assets acquired by the Accused-1 in his name and in the name of his wife A-2 Tmt.V.Dhanalakshmi has been shown in Statement-VII as detailed below:-

Statement-V (St.II – St.I)	Value of assets acquired by A-1 Thiru S.Velusamy in his name and in the name of his wife A-2 Tmt.V.Dhanalakshmi during the check period between 01.04.2015 and 07.11.2019	49,17,879.00
Statement-VI (St.III – St.IV)	Likely savings of the Accused-1 Thiru S.Velusamy in his name and in the name of his wife A-2 Tmt.V.Dhanalakshmi during the check period between 01.04.2015 and 07.11.2019	23,22,868.00
Statement-VII (St.V – St.VI)	The quantum of assets disproportionately acquired by the Accused-1 Thiru S.Velusamy in his name and in the name of his wife A-2 Tmt.V.Dhanalakshmi during the check period between 01.04.2015 and 07.11.2019	25,95,011.00

As per the above statements, the Accused-1 Thiru S.Velusamy had the likely savings about Rs.23,22,868/- during the check period i.e. between 01.04.2015 and 07.11.2019 and hence the pecuniary resources and properties acquired by him and in the name of his wife A-2 Tmt.V.Dhanalakshmi should not have exceeded Rs.23,22,868/- during the check period. But he has acquired assets worth Rs.25,95,011/- in excess out of his total income, which is disproportionate to the known sources of income.

7) The discussion made above reveal that the Accused-1 incurred excess expenditure over his known sources of income. The value of properties and pecuniary resources acquired by the Accused-1 Thiru S.Velusamy in his name and in the name of his wife Tmt.V.Dhanalakshmi is

arrived at Rs.25,95,011/- and the percentage of disproportionate assets is calculated as 74.42 %.

Period between 01.04.2015 and 07.11.2019, the Accused 1 Thiru S. Velusarry was found in possession of pecuniary resources which constituted the offences of Criminal Misconduct punishable U/s 13 (2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988 for the period between 01.04.2015 and 25.07.2018 and U/s 13(2) r/w 13(1)(b) of the Prevention of Corruption Act, 1988 as amended in 2018 for the period from 26.07.2018 and 07.11.2019.

A-2 Tmt.V.Dhanalakshmi abetted A-1 Thiru S.Velusarry which constituted the offences punishable U/s 109 IPC r/w 13 (2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988 for the period between 01.04.2015 and 25.07.2018 and U/s 12 r/w 13(2) r/w 13(1)(b) of the Prevention of Corruption Act, 1988 for the period between 01.04.2015 and 25.07.2018 and U/s 12 r/w 13(2) r/w 13(1)(b) of the Prevention of Corruption Act, 1988 as amended in 2018 for the period between 26.07.2018 and 07.11.2019.

Hence, this day 18.04.2022 at 16.30 hrs, I am registering a case in V&AC, Headquarters Crime No.04/2022/AC/HQ U/s 13 (2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988 for the period between 01.04.2015 and 25.07.2018 and U/s 13(2) r/w 13(1)(b) of the Prevention of Corruption Act, 1988 as amended in 2018 for the period from 26.07.2018 and 07.11.2019 against the Accused-1 Thiru S.Velusamy and U/s 109 IPC r/w 13 (2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988 for the period between 01.04.2015 and 25.07.2018 and U/s 12 r/w 13(2) r/w 13(1)(b) of the

Prevention of Corruption Act, 1988 as amended in 2018 for the period between 26.07.2018 and 07.11.2019 against A-2 Tmt.V.Dhanalakshmi

Judicial Magistrate and Special Judge, Chengalpet for Cases under Prevention of Corruption Act and a copy of FIR is being sent to the Superintendent of Police, Special Investigation Cell, Vigilance and Anti-Corruption, Chennai for issuing authorization U/s 17 of the Prevention of Corruption Act, 1988 to investigate the case and Authorisation U/s 18 of the Prevention of Corruption Act, 1988 to inspect Banker's Book relating to the accounts of the Accused and taken up investigation in this case.
