functions of Zonal Deputy Block Development Officer is that he should make spot inspection of various scheme works and to ensure proper site related identification and also verification of the genuineness in the selection of beneficiaries under, Green House etc., A.O.2 Tr.P.Marimuthu served as Overseer (Supervisor), in the Manamadurai Panchayat Union, Sivagangai District during the occurrence period and responsible for the supervision of work of his subordinates. A.O.3 Tr.M.Kannadasan served as Panchayat Secretary, Mangulam Panchayat within the limits of Manamadurai Panchayat Union. One Tr.N.Padmanaban then Block Development Officer, Manamadurai Panchayat Union, Sivagangai District being the executive authority sanctioned the amount of Rs.1,70,000/- by issuing order PMAY-G No.TN 1181765, dated 02.08.2018 to one Ayyamperumal, Mangulam Panchayat included is the Manamadurai Panchayat Union to construct a house under the scheme of Pradhan Mantri Awaas Yojana Gramin (PMAY-G) for the year 2017 to 2018.

The list of beneficiaries under the scheme was prepared by the committee consisting members Zonal Deputy B.D.O (A.O.1), Panchayat Union Overseer (Supervisor) (A.O.2) and Panchayat Secretary (A.O.3). On 25.08.2018 the Union Overseer (Supervisor) (A.O.2) Marimuthu inspected the proposed site and reported that the construction work was already completed at the foundation level. On 13.08.2018 Rs.26,029/-, 03.09.2018 Rs.26,715/-, 04.12.2018 Rs.26,681/- and 18 Days Daily Wages (MGNEGS) amount Rs.4,032/- totally Rs.83,457/- were credited to the said Ayyamperumal S/o Periasamy Bank Account. However the actual beneficiary is one Ayyamperumal S/o Ponnazhagu. Tr.N.Padmanabhan, Block Development Officer, Manamadurai Panchayat Union, Sivagangai District identified the same and insisted said Ayyamperumal S/o Periasamy to re-pay the amount of Rs.83,457/- to Government Account. Hence Ayyamperumal S/o Periasamy repaid the amount on 03.04.2019 to the Manamadurai Bharatha State Bank, SIPCOT in Government Bank Account Number-37128134551. The accused officers A.O.1 to A.O.3 has knowingly committed the offence, with intend to secure pecuniary

advantage, uploaded some false registration and there by misused the government to the tune of Rs.83,457/-.

The accused officers 1 to 3 allotted a house as per work ID No.TN1129995 to P.Rajendran, S/o Pitchai, Mangulam Panchayat under the PMAY-G Scheme for the year 2017-2018 and payment has been made to the said beneficiary P.Rajendran for Rs.1,20,000/- by disbursing 4 installments for the alleged house. But no construction was actually made by the beneficiary Rajendran in Mangulam Panchayat and thereby the accused officers A.O.1 to A.O.3 with in consequence of obtaining pecuniary advantage, framed incorrect document and there by caused loss to the government to the tune of Rs. Rs.1,20,000/-.

The accused officers 1 to 3 allotted a house as per work ID No.TN2050142 to Tmt.Nagavalli, W/o Raja, Mangulam Panchayat in the Manamadurai Panchayat Union under the PMAY-G Scheme for the year 2017-2018 and payment had been made to the said beneficiary Tmt.Nagavalli for Rs.1,20,000/- by disbursing the amount to 4 installments for the alleged house situated in the Mangulam Panchayat. But in-reality no construction was carried out by the beneficiary Tmt.Nagavalli and thereby the accused officers A.O.1 to A.O.3 abused their official position and obtained pecuniary advantage for the said beneficiary causing loss to the government to the tune of Rs. Rs.1,20,000/- by framing incorrect documents.

The Pradhan Mantri Awaas Yojana Gramin (PMAY-G) was launched in 2016. It is a rural housing scheme aimed at providing housing for all by the year 2022. Each house under this scheme is equipped with basic amenities and PMAY-G is a Social Welfare Scheme designed to consequently uplift the living standards of poor people. PMAY-G provides financial assistance for improving housing infrastructure in rural areas. The eligibility for PMAY-G is based on the states of the house hold under the social criteria of Socio-Economic Factors (SECC) the government has set some guidelines for implementation of the scheme (PMAY-G) effectively.

The committee consisting members Zonal Deputy B.D.O (A.O.1), Panchayat Union Overseer (Supervisor) (A.O.2), Panchayat Secretary (A.O.3) and being the member of the selection committee and as a Panchayat Secretary (A.O.3) played an important role colluded with each other abused their official position and obtained undue advantage for others by knowingly disbursing financial assistance to the beneficiaries, who did not construct the houses, which is against the guidelines laid down by the government for the implementation of PMAY-G Scheme for the year 2017-2018 and in order to facilitate said crime framed incorrect documents which are offences falling u/s 167 IPC and Section 7(c) of the Prevention of Corruption (Amendment) Act, 2018.

As per the Prevention of Corruption (Amendment) Act, 2018 u/s 17 (A) prior permission was accorded by the District Collector, Sivagangai for registering a regular case against A.O.1 to A.O.3.

Since, the above said act of A.O.1 to A.O.3 disclosed the commission of above said offence and I register a case in Sivagangai Detachment, V&AC Crime No.05/2022 against A.O.1 to A.O.3 (Singed. Tr.M.Kumaravel, Inspector of Police, Vigilance and Anti-Corruption, Sivagangai District). The F.I.R. along with the sheet attached is submitted to the court of Chief Judicial Magistrate / Special Judge, Sivagangai. The copies of F.I.R. are sent to the higher officers concerned.
