On a Vigilance Report submitted by an officer of DVAC, following information was gathered:-Accused No.1 Tr.Sridhar, formerly was working as Manager, (Marketing Service). and Coimbatore Housing Unit, Tatabad, Tamil Nadu Housing Board Coimbatore from December 2014 to July 2018. Now working Manager, (Marketing as Service) at Viluppuram Housing Unit, TNHB Viluppuram District. public servant as He is a defined under section 2(c) of Prevention of Corruption Act, 1988.

Accused No.2 Tmt.R.Banumathi, W/o Ramamoorthy Mookambigai Nagar, 5 th street, Karumarampalayam, Mannarai, Tiruppur District and Accused No.3 Tr.A.Khadar Basha, S/o Abdul Nabi 29 A, Vedachalam Mudaliyar street, Arakonam, Vellore District are private individuals.

One Tmt.P.Uma Maheswari W/o. Tr.Palanisamy, D.No.7/169/547 Main road, Pudu Kuyyanur, Sathyamangalam, Bannari, Erode was allotted a plot No. MIG 975 Measuring 1972 square feet at Mudalipalayam, Tiruppur District on 23.05.2005 by Tamil Nadu Housing Board, Tatabad, Coimbatore. The allottee Tmt.P.Uma Maheswari paid Rs.30,675/- as initial payment remitted the monthly installment of Rs.1,201/- and settled the entire amount of Rs.1,46,578/- along with interest. After paying entire amount, she had applied for Sale Deed for the said plot during the year 2018. At that time, the officials of TNHB, CBE instructed her to obtain the Encumbrance Certificate for her allotted plot No.MIG 975 from the Sub Registrar Office, Thottipalayam, Tiruppur District for the preparation of sale deed. Accordingly the allotte obtained an Encumbrance Certificate for her allotted plot and it was found that a sale deed was registered in favour of A2 Tmt. R. Banumathy. When enquired about this it was reliably learnt that A-1 Tr.Sridhar, Manager, Marketing and Service, Coimbatore Housing Unit, Tatabad, Coimbatore had fabricated documents and fraudulently issued the sale deed of the plot No. 975 in favour of A-2 Tmt. Banumathi, W/o Ramamoorthy, Moogambigai Nagar, 5 th street extension, Karumarampalayam,

Mannarai Tiruppur District on 16.07.2018 for obtaining pecuniary gain by abusing his official position and cheated the original allottee Tmt. P. Uma Maheswari.

A-2 Tmt. Banumathi having known the facts has colluded with A1 fraudulently registered the said document by illegal means and undue influence on 07.11.2018 in document No. 4470/2018 at Sub Registrar office, Thottipalayam, Tiruppur District and cheated the original allottee Tmt. Uma Maheswari. Thereby A2 Tmt. R. Banumathi obtained unlawful gain and caused a wrong full loss to the original allottee Tmt. Uma Maheswari.

Thereafter A2 Tmt. Banumathi within a week fraudulently registered the property ie. plot No.975, in a hasty manner to Tr.Khadar Basha S/o Abdul Nabi D. No. 29, A Vedachalam Mudaliar street, Arakonam, Vellore District on 15.11.2018 in document No. 4582/2018 at SRO Thottipalayam, Tiruppur District.

The fraudulent transfer was made by A2 Banumathi in connivance with A3 Tr. Khadar Basha with malafide intention to cheat the original allottee Tmt. Uma Maheswari.

There by A1 Tr. Sridhar, Manager, Marketing and Service, TNHB, Coimbatore, A2 Tmt.Banumathi and A3 Tr.Khadar basha forged the documents in order to cheat the original allottee Tmt. Uma Maheswari and used the same as genuine and caused wrongful loss to Tmt. Uma Maheswari. Similarly A 1 being the Public Servant abused his official position and forged the documents and fraudulently executed a sale deed in favour of

co-accused A2. In turn A2 had fraudulently transferred the property in the name of A3 Tr. Khadar Basha and caused a wrongful loss to the original allottee Tmt. Uma Maheswari.

Hence the above acts constitute the offences against accused No. 1 punishable u/s 468, 471,420 IPC and 13 (2) r/w 13 (1) (d) of Prevention of Corruption Act 1988 and A2 Tmt. Banumathi, private individual and A3 khadar Basha, Private individual for an offence 109 r/w 13(2) and 13(1)(d) of PC Act 1988 and 468, 471 and 420 IPC.

Based on the above reliable information, I M. Vijayalakshmi, Inspector of Police, Vigilance and Anticorruption, Coimbatore registered a case on 22.03.2022 at about 13.45 hrs in Coimbatore V&AC Cr. No.06/2022/AC/CB u/s 468, 471,420 IPC and 13 (2) r/w 13 (1) (d) of Prevention of Corruption Act 1988 against A1 and and u/s 109 r/w 13 (2) and 13 (1) (d) of PC 1988 and 468, 471 and 420 IPC against A2 and A3. The original FIR is submitted to the Hon'ble Spl.Judge, Special Court for cases under the prevention of corruption Act, Coimbatore and copies are submitted to the officers concerned.
