Hon'ble sir, Received the information on pertaining to the registration of FIR as per the instruction in Memorandum in VR No.16191/2020/TP/TN, dated 30.05.2022 of the Director, Vigilance and Anti-Corruption, Chennai, I register a case in Theni V&AC, Cr.No.06/2022, u/s 409, 465, 467, 468, 471, 477A r/w 109 of IPC and 7 and 12 of the Prevention of Corruption Act 1988, As amended by the PC (Amendment) Act, 2018 on 10.06.2022. Prior approval as per the provision of 17A of PC Act, 1988, As amended by the PC (Amendment) Act, 2018 has been obtained from the Additional Chief Secretary to Government, Municipal Administration and Water Resources Management, Secretariat, Chennai for registering a regular case against the Accused Officers Tmt.N.Vijayalakshmi formerly Assistant Director of Town Panchayat/ Special Officer for the Selection Grade Town Panchayats in Theni District and 10 others. A-12 and A-13 are contractors/ private individuals. I submit the above said case as under.

During the year 2019-2020, the above mentioned AO-1 to AO-11 had procured, roughly 1300 numbers of 36 watts LED Bulbs at the rate of Rs.9,987/- from one J.R.Electicals, K.Puthupatti, Theni District. But the market price of these LED Bulbs are ascertained ranging from Rs.1,200/- to a maximum of Rs.2,500/- per Bulb. That means, roughly an amount of Rs.7,487/- per LED Bulb was swindled by the AO-1 to AO-11. It is also reliably learnt that Transparency of Tender Act procedures were not followed in the purchase of these LED Bulbs and all the Tender Schedules were obtained from the same person in different names. The total value of 1300 LED Bulbs which were purchased during the year 2019 amounts to Rs.1,29,83,100/- and thus roughly an amount of Rs.97,33,000/- was the undue advantage obtained by AO-1 to AO-11 with the help of A-12 and A-13 who are contractors/ private individuals.

Hence AO-1 to AO-11, A-12 and A-13 criminally conspired together, and they in order to getting undue advantage, intentionally, dishonestly and fraudulently prepared

forged bills, forged quotations and documents in the capacity of Public Servants with intentional aid of private individuals i.e A-12 and A-13 and used as genuine one. As such, they caused wrongful loss to Government money to the tune of Rs.97,33,000/- in the pretext of purchase of LED Bulbs for the use of the respective Town Panchayats during the financial year 2019-2020 without following the STANDARD SCHEDULE OF RATES 2019-2020 given by the Public Works Department, Government of Tamil Nadu.

Hence, the above said AO-1 to AO-11 and the accused 12 and 13 (contractors/ private individuals) have committed offences punishable of U/S 409, 465, 467, 468, 471, 477A of IPC r/w 109 IPC and 7 and 12 of PC Ac. 1988, As amended by the PC (Amendment) Act, 2018. And also, as per Memorandum in VR No.16 91/2020/TP/TN, dated 23.11.2020 of the Director of Vigilance and Anti-Corruption, Chennai, prior approval has been granted by the Additional Chief Secretary to Government, Municipal Administration and Water Resources Management, Secretariat, Chennai in Letter (2D) No.G1, dated 06.11.2020 under the provisions of 17A(1)(b) of PC Act, 1988 [As amended by the PC (Amendment) Act, 2018].

Hence I am registering a case in Crime No.06/2022 in Vigilance and Anti-Corruption, Theni Detachment against Tmt.N.Vijayalakshmi formerly Assistant Director of Town Panchayat/ Special Officer for the Selection Grade Town Parchayats in Theni District and 12 others, u/s 409, 465, 467, 468, 471, 477 A r/w 109 of IPC and 7 and 12 of the Prevention of Corruption Act 1988, As amended by the PC (Amendment) Act, 2018. The original FIR has been sent to the Chief Judicial Magistrate/ Special Court for trial of cases under Prevention of Corruption Act and the copy of the FIR has been forwarded to the superior officers for further action.
