ATTACHMENT TO COLUMN No.12 OF FIRST INFORMATION REPORT IN VIGILANCE AND ANTI-CORRUPTION, SALEM DETACHMENT CRIME No.9/AC/2022.

The information was gathered during the collection of information against the accused noted in the margin. A-1 Tr.V.Karthikeyan, Executive Officer, Ayothiyapattinam Selection Grade Town Panchayat, Salem District was working from 1.7.2019 to 1.7.2021 during the period of commission of offence. Prior to that he worked at P.Mettupalayam, Elampillai, Salem District as Executive Officer.

A-1 is a public servant as defined u/s 2(c) of the Prevention of Corruption Act 1988 during the period of commission of offence. A-2 Tmt.K.Sharmila is a private person and wife of A-1.

Collection of sources reveals that he hails from a Middle class family. He is native of Aavani Perur Melmugam Village, Edapaady, Salem District. His wife A-2 Tmt. K. Sharmila is a housewife and non - earning member of the family. One of their daughters, Selvi. Priyadharsini is studying MBBS in Sri Devi medical college, a private college at Tumkur, Karnataka.

It is gathered that, he intentionally enriches himself illicitly in his name and in the name of his wife A-2 during the period of his office in various places. Most of the acquisitive activities of Accused falls between 1.1.2015 and 31.12.2019 and hence it was chosen as tentative check period and during that period the A1 & A2 was found in possession of assets as detailed below.

Assets found in the name of A-1 Tr.V.Karthikeyan and A-2 Tmt.K.Sharmila in form of house sites, agricultural lands, bank balances and other assets in edapaady, Salem District at the commencement of the check period i.e as on 1.1.2015.	37,17,637

The available information makes out a prima facie case against A-1 Tr.V.Karthikeyan and his wife A-2 Tmt.K.Sharmila, that they were in possession of pecuniary resources and properties to the tune of Rs.46,81,481 during the check period, which is disproportionate to their known sources of income. The Percentage of disproportionate assets to his known sources of income is 137%. Thereby, A1 had committed the offence of Criminal Misconduct by intentionally enriching himself illicitly during the period of his office and A2 intentionally abetted A1 to commit the said offence by acquiring the assets through the resources of the Accused.

Therefore, today 26.5.2022 at 11.00hrs, I registered a case in Salem V&AC., Cr.No.9/AC/2022 against A-1 Tr.V.Karthikeyan for commission of the offence u/s 13(2) r/w 13(1) (e) of Prevention of Corruption Act 1988 for the period 1.1.2015 to 25.07.2018 and u/s 13(1)(2) r/w 13(1)(b) of Prevention of Corruption Act 1988 as amended in 2018 for the period from 26.07.2018 to 31.12.2019 and A-2 Tmt.K.Sharmila u/s 13(2) r/w 13 (1)(e) of Prevention of Corruption Act 1988 and u/s 109 IPC for the period from 1.1.2015 to 25.07.2018 and u/s 13(2) r/w 13(1)(b) and 12 of Prevention of Corruption Act 1988 as amended in 2018.

The original F.I.R is submitted to the Hon'ble court of the Special Judge for trial of cases under Prevention of Corruption Act Court, Salem District and a copy of the FIR is sent to the Superintendent of Police, Vigilance and Anti-Corruption, Western Range issuing order u/s 17 of the Prevention of Corruption Act 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of A-1 Tr.V.Karthikeyan.
