The Marginally noted accused No.1 Tr.Saravanan, who served as Sub Registrar Grade I, No.2 Joint Sub Registrar office, Karaikudi from 01.08.2019 to 21.12.2021, is presently working as Sub Registrar, Kalayarkovil Sub Registry, Sivagangai District on Deputation from 03.08.2022.

The Marginally noted accused No.2 Tr.P.Karthick Kumar, who served as Assistant, No.2 Joint Sub Registrar office, Karaikudi from May 2018 to November 2021, is presently working as Assistant in the office of Sub Registrar, Devakottai on Deputation from 19.11.2021.

The Marginally noted accused No.3 Smt.V.Seetha, who residing at Door No.10, Muthupattinam 2nd Street, is working as Typist under Document Writer viz., Murugappan and having the office near to the No.2 Joint Sub Registrar office, Karaikudi.

The Marginally noted accused 1 and 2 are Public Servants as defined U/s 2(c) of Prevention of Corruption Act, 1988 and discharged public duty u/s 2(b) of Prevention of Corruption Act, 1988 and Accused No.3 is a Private Individual.

On credible information received and on the factual amount of events as collected through sources which revealed the fact that Tr.V.Somasundaram residing at No.20 D Monte Street, E Block, Flat No.3. Santhome, Chennai had approached No.2 Joint Sub Registrar Office, Karaikudi on 21.09.2020 for the purpose of *applying* certified copy of documents pertaining to the ancestral properties situated at Kalani Vasal Village, Karaikudi in order to file Special Leave Petition before the Honourable Supreme Court and he has been instructed by Tr.P.Karthick Kumar, Assistant to contact Smt.Seetha, (3rd accused herein) for applying certified copies of document through online mode.

Information revealed that when Tr.V.Somasundaram contacted Smt.Seetha (A-3) on 21.09.2020, Smt.Seetha (A-3) had instructed to pay Rs.7,500/- for getting certified copy of documents [Rs.7,000/- through online for 14 documents and Rs.500/- for one document through offline mode] and also demanded to give Rs.1400/- that to be paid as bribe to the A-1 Tr.Saravanan, Sub-Registrar & A-2 Tr.Karthick Kumar, Assistant. It is also learnt that Smt.Seetha had also mentioned said details in the self-written paper and Tr.V.Somasundaram had paid Rs.7,500/- to the account No.949023780 in Indian Bank, Karaikudi Branch, IFSC-IDIBOOK017 on 21.09.2020 of Smt.Seetha (A-3) as instructed by her.

It is also learnt that on 22.09.2020 Smt.Seetha had returned the amount of Rs.2,000/- to Tr.V.Somasundaram since out of the 14 documents, 4 documents could not be obtained through online mode. Smt.Seetha had also instructed him to contact A-2 Karthick Kumar, Assistant along with self-written paper and to pay undue advantage amount of Rs.100/- per document to both A-1 and A-2 as bribe.

It is learnt that in accordance with instruction given by Smt.Seetha (A-3), Tr.V.Somasundaram had approached Tr.Karthick Kumar (A-2) on 22.09.2020 at No.2 Joint Sub Registrar Office, Karaikudi and shown the paper written by Smt.Seetha (A-3) that Karthick Kumar (A-2) in order to discharge his

official duty had further demanded an undue advantage of Rs.100/- per document for himself and also for Tr. Saravanan (A-1), Sub Registrar in order to issue certified copies of documents.

A-1 and A-2 both also being public servants while discharging their public duty with dishonest intention had attempted to obtain an undue advantage by corrupt and illegal means for the performance of official duty in improper and illegal manner in connivance with the A-3 and thereby committed an cognizable offence u/s 7(a) and 12 of Prevention of Corruption Act 1988 as amended by the Prevention of Corruption (Amendment) Act, 2018.

Since A-1 and A-2 are public servants, prior approval u/s 17 (A) (1) of Prevention of Corruption (Amendment) Act, 2018 to register a regular case was obtained from the competent authority i.e, from the Inspector General of Registration, Chennai vide Proceeding in No. 11340/V3/2021, dated 17.03.2022. There are, thus prima-facie materials available on record for taking up investigation against A1 to A3 for the offence u/s 7(a) and 12 of Prevention of Corruption Act 1988 as amended by the Prevention of Corruption (Amendment) Act, 2018.

Therefore I am registering the case in Sivagangai V&AC., Crime No.9/2022 u/s 7(a) and 12 of Prevention of Corruption Act 1988 as amended by the PC (Amendment) Act, 2018 on 21.10.2022 at 16.45 hrs.

The original FIR is submitted to the Hon'ble Special Judge, Special Court for Trial of Cases under Prevention of Corruption Act, Sivagangai and copies of FIR were sent to the Officer's concerned.
