Inspector of Police, VFAC, Tiruvannamalai The following information was gathered during the Detailed Enquiry conducted against the AO-1 Tr.N.Azagarasu and his wife A-2 Tmt.S.Rani.

The AO-1 was working as Deputy Transport Commissioner at Trichy. Prior to that, he worked as Regional Transport Officer, Tiruvannamalai during the period from 22.06.2009 to 22.09.2011 and worked as RTO, Nagercoil during the period from 01.04.2012 to 18.07.2012 and worked as RTO, Tindivanam, Villupuram District during the period from 20.07.2012 to 23.10.2014 and again worked as RTO, Tiruvannamalai during the period from 23.10.2014 to 08.01.2018 during the period of the commission of offence.

AO-1 is a public servant as defined u/s 2(c) of the Prevention of Corruption Act 1988 during the period of commission of offence. A-2 Tmt.S.Rani is the wife of AO-1 and she is a housewife.

The detailed enquiry reveals that AO-1 Tr.N.Azhagarasu hails from a middle class family. He is a native of Hasthampatti in Salem District. A2 is a house wife, AO-1 and A2 are blessed with two daughters and one son and they all are Doctors with MBBS degree while their elder daughter has completed her Master's Degree in Medicine.

It is gathered that AO-1 Tr.N.Azhagarasu amassed wealth in his name and in the name of his wife Tmt.S.Rani during the period of his office in various places. Most of the acquisitive activities of AO-1 and his wife A-2 fall between 01.04.2010 and 31.03.2016 and hence tentative check period was fixed accordingly and during that period the AO-1 and his family members were found in possession of assets as detailed below.

Assets found in the name of AO-1 Tr.N.Azhagarasu and his wife A2 Tmt.S.Rani in form of house sites, agriculture land, motor car and bank deposits etc., at the beginning of the check period i.e., as on 01.04.2010

Rs. 94,80,496/-

Assets found in the name of AO-1 and his family members in form of house sites, agriculture land, house buildings, motor car and fixed deposit in banks etc., at the end of the check period i.e as on 31.03.2016

Rs.4,61,51,739/-

Income of AO-1 and his family members from known : sources in the form of Monthly Salary, Maturity of LIC policies, house rents, bank FD interest and compensation received from NHAI, Salem during the check Period from 01.04.2010 to 31.03.2016.

Rs.2,07,40,630,/-

Expenditure Incurred by AO-1 and his family members : during the check period from 01.04.2010 to 31.03.2016

Rs. 43,33,200 /-

Value of the assets acquired by AO-1 and his family : members during the check period from 01.04.2010 to 31.03.2016.

Rs.3,66,71,243/-

Likely savings of AO-1 and his family members during the :

Rs.1,64,07,430/-

check period from 01.04.2010 to 31.03.2016.

Disproportionate Assets acquired by AO-1 and his family : members during the check period from 01.04.2010 to 31.03.2016

Rs.2,02,63,813/-

The available information makes out a prima facie case that AO-1 Tr.N.Azhagarasu has accumulated assets in the name of his wife A-2 Tmt.S.Rani and both were in possession of pecuniary resources and properties to the tune of Rs.2,02,63,813/- (Percentage of net disproportionate assets - 97.70%) during the check period from 01.04.2010 to 31.03.2016, which is disproportionate to their known sources of income. Thereby AO-1 had committed the offence of Criminal Misconduct by amassing wealth during the period of his office and A-2 Tmt.S.Rani had abetted him to commit the said offence by acquiring the assets through the resources of AO-1.

Therefore today on 10.10.2022 at 1700 hrs I registered a case in Tiruvannamalai V&AC Cr.No. 11/2022 against AO-1 Tr.N.Azhagarasu for the commission of offence u/s 13(2) r/w 13(1) (e) of the Prevention of Corruption Act 1988 and A-2 Tmt.S.Rani for the commission of offence u/s Section 109 IPC and 13(2) r/w 13(1) (e) of the Prevention of Corruption Act 1988.

The original First Information Report is submitted to the Hon'ble Special Judge cum Chief Judicial Magistrate, Tiruvannamalai and a copy of the First Information Report is sent to the Superintendent of Police, Vigilance and Anti Corruption, North Range, Chennai – 16 for passing order U/s 17 of the Prevention of Corruption Act 1988 to investigate the case and authorization u/s 18 of the PC Act 1988 to inspect bankers book in relation to the accounts of A.O-1 Tr.N.Azhagarasu and A-2 Tmt.S.Rani.
