V&AC, Cr.No.2/AC/2023/CC-V continuation Based on the Petition received from Tr.V.Anbalagan, No.13/9, Malliyam Narasimman Nagar, Poonamallee, dated 27.03.2017, DVAC Memo No. PE 47/2018/LB/CSU-I Chennai-56. Dt: 05.03.2018 was ordered for a Preliminary Enquiry which revealed the following facts. The AO-1 Tr.Sivakumar, Commissioner, Pallavaram Municipality and AO-2 Tr.Karuppaiah Raja, Municipal Engineer, Pallavaram Municipality are public servants under the purview of Sec 2 (c) of the Prevention of Corruption Act 1988 and AO-3 to AO-5 are private individuals. It is ascertained through the entries found in the Local Fund Audit report that tender was awarded to M/s Deepthi Enterprises for cleaning 184 toilets in 11 schools coming under the control of Pallavaram Municipality. But it was on record that out of 184 toilets, 47 toilets were only used by the staffs and teachers of 11 schools who were engaged in examination paper valuation work during vocational holidays in the year 2015. AO-1 Tr.Sivakumar in connivance with M/s Deepthi Enterprises created records as if 184 toilets were cleaned by M/s Deepthi Enterprises. Based on the incorrect records, AO-1 paid full amount Rs.8,55,000/- to M/s Deepthi Enterprises. But, he was supposed to pay only a sum of Rs.1,70,000/- to M/s Deepthi Enterprises for cleaning of 47 toilets that were used during the vocational holidays in the year 2015. Whereas, he paid additional sum of Rs.6,85,000/- to M/s Deepthi Enterprises and thereby S.O-1 Tr.Sivakumar caused financial loss to Pallavapuram Municipality to the tune of Rs.6,85,000/- and committed grave criminal misconduct. Further, it was alleged that A O-1 Tr. Sivakumar, during the year 2016 allotted toilet cleaning work for 11 schools Pallavaram Municipality at a cost of Rs.9.75 lakhs for 30 days to M/s Deepthi Larby Enterprises. By violating the TN Tender in Transparency Act, A.O-1 extended that work for 1 year and paid a sum of Rs 1,10,40,000/- for the above said work to M/s Deepthi Enterprises. For the above said amount, A.O-1 had not obtained previous administrative sanction from the Commissioner for Municipal Administration, Chennai. Further, A.O-2 Tr. Karuppaiah Raja had not obtained technical sanction from the Chief Engineer, Municipal Administration, Chennai and both the accused

officers violated the Government direction and had done financial favour to a private company, namely Deepthi Enterprises. If they had followed the directions of the Government in allotting the above work which was estimated for a huge amount and floated tenders, large companies would have participated and the cost of the work would have been reduced and fund of Pallavaram Municipality would have been saved. The above said allegations were noted in the Audit Report of Local Fund Audit for the year 2016-17 and 2017-18 of Pallavapuram Municipality. By ignoring the Government directions the Accused Officers had done financial favours to the private firms namely M/s Deepthi Enterprises. There are prima facie material Tr.Sivakumar, formerly Municipal evidences available to show that A.O-1 Commissioner and A.O-2 Tr.Karupaiah Raja, formerly Municipal Engineer, M/s Deepthi Enterprises collected Pallavapuram Municipality along with Rs.17,98,200/- (approximately) on the strength of the forged bills for the maintenance of toilet and shared the said amount between them and thereby obtained wrongful gain by causing wrongful loss to the Exchequer. Further, it is alleged that during the year 2015-16, A.O-1Tr. Sivakumar while working as Municipal Commissioner, Pallavaram Municipality without following the tender rules awarded tender to M/s Reylon Facility Services Private Limited to engage Domestic Breeding Checkers for one year for an estimate of Rs. 1,14,48,000/-. The Domestic Breeding Checkers were engaged to control proliferation of mosquitoes during the period of rainy seasons. There is incriminating material evidence to show that in mosquito control activities, tender had been awarded to M/s Reylon Facility Services Private Limited for more than one year and undue favour had been done to M/s Reylon Facility Services Private Limited. Further, it is alleged that there was malpractice in purchase of medicine used to cure Elephantiasis. During the period November 2016, the officials of Pallavaram Municipality made entries in the registers of Pallavaram Municipality as if 300 liters of Fenthion medicines for Elephantiasis were purchased from Pyrethrum India Private Limited, Rajabather Street, T.Nagar, Chennai-17. The Pyrethrum India Private Limited claimed

Rs.4,92,487/- for supplying Fenthion medicine. There were no entries found in the stock register of Pallavaram Municipality during the year 2016 for the above said purchase. Further, there were no entries made in the distribution register of Pallavaram Municipality to show that the Fenthion medicine said to be purchased for control of Elephantiasis was distributed to the public in proper manner. Thus, A.O-1 Tr.Sivakumar paid a sum of Rs.4,92,487/- towards the purchase of Fenthion medicine and caused financial gain to Pyrethrum India Private Limited and caused financial loss to the Pallavapuram Municipality to a tune of Rs.4,92,487/- There are sufficient Prima facie materials available to register a regular case against A.O-1 Tr.Sivakumar and A.O-2 Tr.Karuppaiah Raja u/s 120 B, 406, 409 IPC and Section 13(2) r/w 13(1) (c) (d) of the Prevention of Corruption Act, 1988, and Government have accorded prior permission as per Sec 17 A of Prevention of Corruption Act, 2018 vide Lr. No.(d) No. 4841 dated 21.12.2021. Hence, today 13.03.2023 at 17.00 hrs, I am registering a case in V&AC Cr. No.2/AC/2023/CC-V, u/s 120 B, 406, 409 IPC and Section 13 (2) r/w 13 (1) (c) and 13 (1) (d) of the Prevention of Corruption Act, 1988 against A.O-1 Tr.Sivakumar, formerly Commissioner, Pallavaram Municipal Corporation now Commissioner, Erode City Municipal Corporation, Erode A.O-2 Tr.Karupaiah Raja, formerly Municipal Engineer, Pallavaram Municipal Corporation now Regional Executive Engineer, Chengalpet A.O-3, M/s Deepthi Enterprises No. 22/140 Basin Road, Tiruvottiyur, Chennai-19, A.O-4 M/s Reylon Facility Services Pvt Ltd, 1st Floor, No.2/20, 2nd Cross Street, Indira Nagar, Adyar, Chennai-20 and A.O-5 Pyrethrum (India) Pvt Ltd. 11/64 Rajabather Street, T.Nagar, Chennai-17 for the offences committed by them. The original FIR along with original complaint of Tr.V.Anbalagam, Malliyam Narasimman Nagar, Poonamallee, Chennai-56 are submitted to the Hon'ble Chief Judicial Magistrate cum Special Judge, Chengalpet and copy of the FIR is forwarded to officers concerned
