

I, G.Hector Dharma Raj, Deputy Superintendent of Police, Vigilance and Anti-Kanyakumari Detachment Corruption, Nagercoil, when I was in the office of the Vigilance and Anti-corruption, Kanyakumari Detachment @ Nagercoil while on duty on 28.03.2023 at about 10.00 hrs. I received and perused the Memorandum of DVAC, Chennai in DE 75/2017/TNCSC/KK along with the copy of the prior approval u/s 17(A)(1) Prevention of Corruption Act 1988 as amended by Act 16 of 2018 with the letter No. 541/1686/22 issued by the Regional Manager, TNCSC, Kanyakumari District against the Accused No. 1 mentioned in the accused column for the above mentioned officers and registered a case in Kanyakumari Detachment at Nagercoil Cr. No. 2/2023 u/s 13(2) r/w 13(1)(c) of Prevention of Corruption Act 1988 and 167, 409, 465, 467, 468, 471 IPC. The factual matrix of the case disclosed through the above mentioned confidential communication is unfolded under:

The accused No.1 Tr.R. Ravi worked as a Junior Quality Inspector in Tamilnadu Civil Supplies Corporation Ltd. Godown at Konam II, Nagercoil, Kanniyakumari District from 17.08.2016 to 20.09.2016 and again from 05.01.2017 to 20.02.2018.

The accused No.2 Tr.A.Sathishkumar worked as a Junior Assistant, in Tamilnadu Civil Supplies Corporation Ltd. Godown at Konam II, Nagercoil, Kanyakumari District from 27.07.2016 to 04.07.2017.

The accused No.3 Tr.P. Pugazhenthi worked as a Junior Quality Inspector in Tamilnadu Civil Supplies Corporation Ltd. Godown, Konam II, Nagercoil, Kanyakumari District from 22.02.2016 to 19.02.2017.

The accused No.4 Tr.Selvaraj worked as a Junior Assistant in Tamilnadu Civil Supplies Corporation Ltd. Godown at Konam II, Nagercoil, Kanyakumari District from 17.12.2015 to 30.06.2021.

'The accused No.5 Tr.Easwarakumar worked as a Bill Clerk in Tamilnadu Civil Supplies Corporation Ltd. Godown at Konam II, Nagercoil, Kanyakumari District from 28.04.2014 to 04.07.2017.

Hence, they are coming under the purview of public servants within the ambit of Section 2(c) of Prevention of Corruption Act 1988.

"Amma Cement Scheme" on September 2014 for the benefit of the people of Tamil Nadu due to the increase in the rate of key construction component and modalities. In continuation of the said scheme, the guidelines of the scheme was ordered in G.O. (MS) No.188 Industry (MID-2) Department dated 11.12.2014. The object of the scheme is to benefit the lower and middle class people in the construction of residential building for their dwellings. Hence, the Tamil Nadu government has procured 2 lakh Metric Tonnes of cement per month at the rate of Rs.185/- from various cement manufacturers and sold them to all urban and rural local bodies at the rate of Rs.190/- per bag in order to mitigate the hardship faced in the house construction of lower and middle class people.

Under the scheme 50 bags of Amma cements was distributed per 100 sq.ft. for construction, 250 bags of Amma cements was distributed per 500 sq.ft. for construction, 500 bags of Amma cements was distributed per 500 to 1000 sq.ft. for construction, 750 bags of Amma cements was distributed per

1000 to 1500 sq.ft. For repairs and renovation the beneficiaries are eligible to get 10 to 100 bags cement.

The crux of the Detailed Enquiry against the above said accused revealed that during their tenure in their respective posts in Tamil Nadu Civil Supplies Corporation Ltd., Konam II Godown, they have created forged and falsified invoice cum delivery order as if cement bags under Amma Cement Supply Scheme were supplied to the beneficiaries at Rs.190/- per cement bag, whereas actually the number of cement bags noted in the forged and falsified invoice cum delivery order were sold to outsiders.

Tr. Pugazhenthi, Junior Quality Inspector, Konam II The Accused TNCSC Godown had forged the signature of Tr.Kutthalam in the invoices i) Invoice 40 dt.Nil, ii) Invoice No.48 dt.19.09.2016 and iii) Invoice No.28 dt.30.11.2016, without the signature of Tmt.Maheshwari in invoice No 55 dt 22.09.2016, forged the signatures of Tr.R.Vijayan in the invoices i) Invoice No. 10 dt 10.09.2016, ii) Invoice No.22 dt 30.11.16 iii) Invoice 34 dt 02.02.2017 and without signature of Tr. Vijayan in the invoices i) Invoice 26 dt 19.09.2016, forged the signatures of Tmt. Thangalekshmi in i) Invoice No.27 dt 30.11.2016, forged the signatures of Tr.Gnanamuthu in Invoice No.29 dt. 30.11.16 and without the signature of Tr.Gnanamuthu in the invoice, i) Invoice No.28 dt 31.08.2016 and ii) Invoice No.49 dt 19.09.2016, forged the signatures of Tr.Antony Micheal in the Invoice No.32 dt 10.09.2016 and without the signature in the invoice No.57 dt 22.09.16 and forged the signatures of Tr.S. Vaigunda Sivarajan in the invoice No.25 dt 30.11.16 sold 750 bags of Cement under the Amma cement scheme to some other persons rather than the actual beneficiary for enhanced rate more than the actual rate of Rs.190/per bag and cheated the actual beneficiaries and Government and attained wrongful gain Rs.1,66,875/- and defeated the basic concept of the Amma Cement Scheme.

The Accused Tr. R.Ravi, Junior Quality Inspector. Konam II TNCSC Godown had forged the signature of Tmt.Thangalekshmi in the invoices i) Invoice 66 dt 19.04.2017, forged the signature of Tr.Ayyasamy in the i) Invoice

No.67 dt 19.04.17 and forged the signatures of Tr.S.Vaigundasivarajan in the invoices i) Invoice No.20 dt 24.11.16 (When he was working in Direct Purchase Centre, Nagercoil) and ii) Invoice No.69 dt 22.04.17 and iii) Invoice No.79 dt 24.04.17 and sold 250 bags of Cement under the Amma Cement Scheme to some other persons rather than the actual beneficiaries for enhanced rate more than the actual rate of Rs.190/- per bag and cheated the above actual beneficiaries and Govt and attained wrongful gain Rs.55,625/- and defeated the basic concept of the Amma Cement Scheme.

The Accused Tr.Selvaraj, Junior Assistant, Konam II TNCSC Godown had forged the signature of Tr.Vijayan in the invoices i) Invoice No.4 dt 24.06.2016 and forged the signature of Tmt.Thangalekshmi in the i) invoice No.279 dt 11.06.16 and sold the 100 bags of Cement under the Amma cement scheme to some other persons rather than the actual beneficiaries for enhanced rate more than the actual rate of Rs.190/- per bag cheated the above actual beneficiaries and Govt and attained wrongful gain of Rs.22,250/- and defeated the basic concept of the Amma cement scheme.

The Accused Tr.Sathishkumar, Junior Assistant. Konam II TNCSC Godown had forged the signature of Tmt.Maheshwari in the invoices i) Invoice No.48 dt 09.02.2017 and forged the signature of Tmt.Thangalekshmi in the i) invoice 68 dt 22.04.2017, forged the signature of Tr.Antony Micheal in the i) invoice 41 dt 09.02.2017 and forged the signature of Tr.S.Vaikunda sivarajan in the invoices i) Invoice No.59 dt 13.04.17 ii) Invoice No.42 dt 09.02.17 and sold 250 bags of Cement under the Amma cement scheme to some other persons rather than the actual beneficiaries for enhanced rate more than the actual rate of Rs.190/- per bag and cheated the above actual beneficiaries and Govt and attained wrongful gain of Rs.55,625/- and defeated the basic concept of the Amma Cement Scheme.

The Accused Tr.Eswarakumar, Bill Clerk, Konam II TNCSC Godown had forged the signature of Tr.Vijayan in invoice No.44 dt 19.09.16 and without

the signature of Tmt. Thangalekshmi in invoice No. 24 dt 31.08.16 and sold 100 bags of Cement under the Amma cement scheme to some other persons rather than the actual beneficiaries Tmt. Thangalekshmi and Tr.R. Vijayan for enhanced rate more than the actual rate of Rs. 190/- per bag and cheated them and the Government and attained wrongful gain of Rs. 22,250/- and defeated the basic concept of the Amma cement scheme.

Therefore all the accused having the capacity of public servant prepared the above said invoices known that it to be incorrect and intended to injure the actual beneficiaries. The accused committed criminal breach of trust and forged the signature of the actual beneficiaries and cheat the Government. They fraudulently used the invoices and other documents as genuine and misappropriated the Government funds. They committed criminal misconduct and fraudulently misappropriate the property entrusted to him. Hence the above said acts constituted the offence u/s 13(2) r/w 13(1)(c) of Prevention of Corruption Act 1988 and Section 167, 409,465,467,468 and 471 IPC.

Therefore today 28.03.2023 at 10.30 hrs, I registered a case in Kanyakumari V&AC Cr. No. 2/2023 against the above said accused 1 to 5 for the commission of offence u/s 13(2)r/w 13(1)(c) of Prevention of Corruption Act 1988 and Section 167, 409,465,467,468 and 471 IPC.

The original FIR is submitted to the Honourable Court of the Chief Judicial Magistrate cum Special Judge, Kanyakumari District at Nagercoil and a copies of the FIR are sent to the officers concerned.
