l, T.T.Rema, Inspector of Police, Vigilance & Anti-Corruption, Kanyakumari Detachment while on duty today (13.07.2023) at 07.00 hrs received confidential instruction in memorandum No. PE.89/2019/MISC/KK of the Director, DVAC, Chennai and registered a case in Kanyakumari Vigilance & Anti-Corruption Cr.No.4/2023 u/s 13(2) r/w

13(1)(e) of the Prevention of Corruption Act, 1988 against the marginally noted accused Tmt.Roselin Premalatha @ Latha Chandran. The Hon'ble Madurai Bench of Madras High Court W.P No.17588/2019 dated 16.10.2019 had passed orders in petition filed by one Tr.E.Sukumaran, S/o. Ravi Vellar, Kullalar Theru, Chunkankadai Post, Kanyakumari District to take necessary action in the manner known to law. In pursuance of the above said order, the Director, Directorate of Vigilance and Anti-corruption, Chennai instructed to conduct a Preliminary Enquiry in to the assets amassed disproportionately to the known sources of income against the accused. Tmt.Roselin Premalatha @ Latha Chandran W/o. Chandran was serving as President of Aloor Town Panchayat, Kanyakumari District from 21.10.2011 to 30.10.2016. Thus she was a public servant within the definition of section 2 (c) of the Prevention of Corruption Act 1988.

The petition discloses that Tmt. Roselin Premalatha @ Latha Chandran is a resident of Kullatar Theru, Chunkankadai Post, Kanyakumari District. She married Tr. Chandran and she is a housewife. The accused is having two male children namely Shajumon and Vijumon who are Engineering graduates. Shajumon had married one Kowsalya and they are having one child. Shajumon is further studying B.L Legal course and also acting in film Industry. Vijumon is working in Fair price shop.

The above said accused and her family members are not having any other income from any other legal sources. The check period in this case had been fixed from 21.10.2011 to 30.10.2016. Considering the tenure of the accused Tmt. Roselin Premalatha @ Latha Chandran, as President of Aloor Town Panchayat and the acquisition of activities and wealth amassed in her name other than the known sources of income.

The accused Tmt. Roselin Premalatha @ Latha Chandran constructed a house in Kanyakumari District, Kalkulam Taluk, Villukuri villge, Kulalar street bearing D.No. 16-61 B and 16-61 C situated in Aloor Town Panchayat during the year 2013-2014 as per building plan approval File No. 14/2013-2014 for an amount of Rs. 32,63,121/-.

The assets of the accused during the check period are calculated as mentioned below in Statement I to VII.

Assets found in the name of AO and others in the beginning of check period on 21.10.2011 Rs. 1,49,454/- (Statement - I)

Assets found in the name of AO and others at the end of check period on 30.10.2016 is Rs. 34,47,381/- (Statement - II)

Income of AO and others from known sources of income during the check period between 21.10.11 to 30.10.2016 is Rs. 19,27,900/- (Statement-III)

Expenditure incurred by AO and others during the check period between 21.10.11 to 30.10.2016 is Rs. 19,97,295/- (Statement-IV)

Value of assets acquired by AO in her name and other names during the check period between 21.10.2011 to 30.10.2016 is Rs. 32,97,927/- (Statement-V)

Likely savings of AO and others during the check period between 21.10.11 to 30.10.2016 is (minus) Rs. 69,395/- (Statement-VI) (Here AO had more expenditure beyond his income during the check period. Hence she had no savings during the check period. The amount of expenses over his income Rs. 69,395/- is deemed to be an asset.)

Disproportionate assets acquired by the AO and others during the check period between 21.10.2011 to 30.10.2016 can be calculated by subtracting the likely savings of the accused officer from the assets acquired by the accused officer during the check period

Disproportionate assets = Assets acquired during the check period minus likely savings during the check period Rs. 32,97,927/- (- Rs.69,395/-) = Rs. 33,67,322/- (Statement-VII)

On calculation of the assets acquired by the accused and others during the check person between 21.10.2011 to 30.10.2016 in percentage is

Thus the collection of materials discloses that the accused, Tmt. Roselin Premalatha @ Latha Chandran had amassed wealth of Rs. 33,67,322/- against her known sources of income during her tenure as Aloor Town Panchayat President between 21.10.2011 to 30.10.2016.

The available information makes out a prima facie case against the accused for the offence of criminal misconduct as she had intentionally enriched herself and in possession of assets disproportionate to her known sources of income during the check period by abusing her official position as public servant as stated above.

Therefore today 13.07.2023 at 07.00 hrs I registered a case in Kanyakumari Detachment Vigilance and Anti-Corruption Cr. No.4/2023 against the accused Tmt.Roselin Premalatha @ Latha Chandran for the commission of offences u/s 13(2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988.

The original FIR is submitted to the Hon'ble Chief Judicial Magistrate cum Special Judge court, Nagercoil on 13.07.2023 and a copy of FIR is sent to the Superintendent of Police, Southern Range, Vigilance and Anti-Corruption for issuing order u/s 17 of the Prevention of Corruption Act, 1988 to investigate the case and authorisation u/s 18 of the said Act to inspect Bankers books in relation to the accounts of the accused and others in the course of investigation.
