

Based on the petitions sent by the petitioner Tr.S.Ravi, S/o. R.Sadhasivam, 2-91-B, Nadupatti, Alavaipatty Post, Rasipuram Taluk, Namakkal District, the Directorate of Vigilance and Anti-Corruption, Chennai had ordered a Preliminary Enquiry.

A1 Tr.M.Jothiswaran, is serving President, Nadupatty Village Panchavat. Vennandur Block Namakkal District from 02.01.2020 A2 Tmt A Tamilselvi is working as Panchayat Secratary. Nadupatty Village Panchayat, Venandur block, Namakkal district from 07.06.2016 to till date. A3 Tmt.P.Sathiya is working as Worksite Supervisor MGNREGS from the year 2015-16.

A4 Tr.K.Mani is a contractor in Nadupatty Village Panchayat, Vennandur block, Namakkal District and he is father of A1. One Chellammal is the mother of A1 and wife of A4, who was Panchayat President, Nadupatty Village Panchayat from the year 2011 to 2016. Now, she is no more. She expired on 24.06.2021.

The accused A1 and A2 are public servants and hence previous approvals have been granted to investigate by registering a Regular case against them.

The accused A3 and A4 are Private individuals.

The petitioner Tr.Ravi in his petitions levelled so many allegations about the misappropriation of funds sanctioned for works at Nadupatty Village Panchayat by the Panchayat President and other officials viz., 1) Construction of houses under Pradhan Mantri Awaas Yojana-Gramin, 2) Construction of houses under Chief Minister's Solar Powered Green House Scheme (CMSPGHS), 3) Job Cards created by the accused under MGNREGS for the Non-residents of the village and the amount were credited to the said non-employees, 4) Construction of Farm Ponds under MGNREGS, 5) Construction of Individual House hold Latrines under MGNREGS, 6) Fixing Electric Motor and Laying pipe lines with Panchayat Fund, 7) Construction of Check Dam at Eri Odai under MGNREGS and Stone bunding activity under MGNREGS. In order to find-out whether any prima facie case is made out against the accused, in random few of the allegations were taken up for the Enquiry and the enquiry disclosed the following information:-

President of Nadupatti Village Panchayat and A-3 Tmt.Sathiya, Worksite Supervisor of MGNREGS, Nadupatti Village Panchayat colluded with the officials of Vennandur Panchayat Union, forged the records as if a house was constructed to Ganapathy S/o.Sengodan, Nadupatti Village Panchayat under Indira Awas Yojana Scheme and misappropriated a sum of Rs.1,20,000/-(Rupees one lakh twenty thousand only). Further, they forged the records as if latrine was constructed in the newly constructed house of Ganapathy and misappropriated a sum of Rs.12,000/- (Rupees Twelve Thousand only). The accused also forged the records as if one Senthil Kumar, who is resident of Chennai, Kanagaraj and others had worked in the construction in the said house

and misappropriated a sum of Rs.16,470/- (Rupees Sixteen thousand four hundred and seventy only) from MGNREGS fund.

- 2) During the year 2015-2016, the deceased Tmt.Chellammal, who was President of Nadupatti Village Panchayat and A-3 Tmt.Sathiya, Worksite Supervisor of MGNREGS, Nadupatti Village Panchayat colluded with the officials of Vennandur Panhayat Union, forged the records as if solar powered green house was constructed in the name of Ramasamy S/o.Palanigoundar under Chief Minister's Solar Powered Green House Scheme and misappropriated a sum of Rs.1,80,000/- (Rupees one Lakh Eighty thousand only). Further, they forged the records as if latrine was constructed in the solar green house and misappropriated a sum of Rs.12,000/- (Rupees Twelve thousand only). The accused also forged the records as if Tr.Ramasamy, Tr.Saravanan, and Tr.Palaniappan had worked in the construction of above said house and misappropriated Rs.16,470/- (Rupees Sixteen Thousand four hundred and seventy only) from MGNREGS fund and the accused also misappropriated Rs.30,000/- (Rupees Thirty thousand only) which was allotted to fix the Solar Power system for the said house.
- 3) During the year 2015-2016, the deceased Tmt.Chellammal, who was Panchayat President of Nadupatti Village Panchayat, A3 Tmt.Sathiya and A4 Tr.K.Mani connived with the Officials of Vennandur Panchayat Union and constructed one latrine to Tmt.Gunasundari, W/o.Palaniappan of Nadupatty village, but created records as if two more latrines were constructed to Tmt.Gunasundari and misappropriated two latrine amount of Rs.24,000/-(Rupees Twenty four thousand only).
- 4) During the year 2020-2021, A1 Tr.M.Jothiswaran, Panchayat President, Nadupatti Village Panchayat with the active connivance of A2 Tmt.Tamilselvi, Panchayat Secretary, Nadupatti Village Panchayat, A3 Tmt.Sathiya, Worksite Supervisor of MGNREGS, Nadupatti Village Panchayat and Officials of

Vennandur Union created records as if a stone bunding work was carried out in the field of one Dhanam W/o.Ramasamy, Nadupatty village under MGNREGS Scheme and misappropriated the sum of Rs.18,176/- (Rupees Eighteen thousand one hundred and seventy six only).

Likewise, the accused colluded with other officials misappropriated so many amounts in various works carried out in Nadupatty Village Panchayat, Vennandur Panchayat Union during the years 2011 to 2020.

The above information clearly makes out a prima facie case against the above marginally noted accused u/s. 120-B, 468, 471 IPC and 13(2) r/w 13(1)(c) of the Prevention of Corruption Act, 1988 and 13(2) r/w. 13 (1) (a) of the Prevention of Corruption Act, 1988 as amended in 2018. The Government accorded permission to register a regular case against the Public Servants u/s. 17-A of the Prevention of Corruption Act, 1988 as amended in 2018.

Therefore, today on 04.05.2023 at 16.00 hrs, I had registered a case in Namakkal Vigilance and Anti-Corruption Crime No.4/AC/2023, u/s.120-B, 468, 471 IPC and 13(2) r/w 13(1)(c) of the Prevention of Corruption Act, 1988 and 13(2) r/w. 13(1) (a) of the Prevention of Corruption Act, 1988 as amended in 2018 against the accused noted in the margin as per the orders of the Director of Vigilance and Anti-Corruption, Chennai. The original F.I.R. along with attested copy of consolidated petition of Tr.S.Ravi, dated 18.05.2020, six original petitions of Tr.S.Ravi dated 18.05.2020 and a original petition dated 15.10.2020 sent by Tr.Ravi were submitted to the Hon'ble Court of the Special Judge / Chief Judicial Magistrate, Namakkal and other copies are sent to the officers concerned.
