Submitted:

Based on the collection of information and the parallel investigation conducted on the irregularities committed by the noted accused, marginally Tr.C.Subramaniyam S/o Chellan, formerly Assistant Director, i/c Deputy Director, Town and Country Planning, Vellore, Vellore District, it is ascertained that during the period from 01.04.2016 to 10.09.2018, Tr.C.Subramaniyam incurred excess expenditure over his known sources of income.

During the period between 01.04.2016 and 10.09.2018 Tr.C.Subramaniyam has served as Supervisor/Draughtsman Gr-II at Mamallapuram Local Planning Authority, Chengalpet, Assistant Director, i/c Deputy Director, Town and Country Planning, Vellore, Vellore District and as such, he was a public servant as defined u/s 2(c) of the Prevention of Corruption Act, 1988.

The accused, Tr.C. Subramaniyam S/o Chellan, hails from a middle-class family. He is a native of Singaperumal Koil, Chengelpet Taluk, Chengelpet District. He married one Tmt.Chitra, who is house-wife. They have only son, namely, Selvan C.S.Dravid, who studied Under Graduation in Psychology and Finance (4-year course) at Leysin American School, Western University, Switzerland from 2016 to 2018. The accused, Tr.C.Subramaniyam has incurred a huge expenditure for the education of his son Selvan C.S.Dravid from 2016 to 2018. The AO had opened a separate bank account in his name vide Account No.913010052855694 at Axis Bank, Vellore Branch on 28.11.2013 to infuse the ill-gotten amounts.

12.02.2019. the accused 13.04.2016 to from period During the Tr.C.Subramaniyam has made huge cash deposits to the tune of Rs.1,17,70,700/- in the above said bank account, beside other modes of transfer like, Immediate Payment Service (IMPS), National Electronic Funds Transfer (NEFT), Real Time Gross Settlement (RTGS) and Mobile Banking (MOB) directly by himself and also through his staff and private individuals. The scrutiny of the bank Account No.913010052855694 shows that during the period from 2016 to 2018, a total of Rs.1,85,74,505/- was deposited in this account and the same amount had been expended by his son at abroad. As most of the expenses were made between 2016 and 2018, a tentative check period is fixed as between 01.04.2016 and 10.09.2018 to ascertain the excess expenditure incurred by the AO over the income.

A Basic Statement was prepared based on the Income, expenditure and the assets in possession of the accused Tr.Subramaniyam, as under

From the above statements, during the check period between 01.04.2016 and 10.09.2018, the value of assets acquired by Tr.C.Subramaniyam has been calculated and given in Statement-V and his likely savings has been shown in Statement-VI. The quantum of expenditure incurred by AO to his known sources of income which is disproportionate shown in Statement-VII as detailed below.

The available information makes out a prima facie case against the accused Tr.C.Subramaniyam, formerly Assistant Director, i/c Deputy Director, Town and Country Planning, Vellore, Vellore District, had committed the offence of criminal misconduct by incurring excess expenditure to the tune of Rs.1,64,54,957/-, which is 1120% more than his known source of income, during the period of his office from 01.04.2016 to 10.09.2018, for which he could not satisfactorily account for.

Therefore, today 24.07.2023 at 13.00 hrs, I registered a case in Vellore V&AC Cr.No.04/2023 against the accused Tr.C.Subramaniyam S/o Chellan, formerly Assistant Director, i/c Deputy Director, Town and Country Planning, Vellore, Vellore District under section 13(2) r/w 13 (1) (e) of the Prevention of Corruption Act 1988 for the period between 01.04.2016 and 25.07.2018 and 13(2) r/w 13(1)(b) of the Prevention of Corruption Act, 1988 as amended in 2018 for the period between 26.07.2018 and 10.09.2018.

The original F.I.R. is submitted to the Hon'ble Court of Chief Judicial Magistrate / Special Judge, Vellore, Vellore District and a copy of FIR is sent to the Superintendent of Police, Northern Range, Vigilance and Anti-Corruption, Chennai for issuing order u/s 17 of the Prevention of Corruption Act 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of the accused Tr.C.Subramaniyam S/o Chellan, formerly Assistant Director, i/c Deputy Director, Town and Country Planning, Vellore, Vellore District.
