one Tr.T.Arunainadhan, S/o.Tr.N.Thangaraj, Door.No.7/56(1) Varukathattu, Kalpadi, Kanyakumari District the Preliminary Enquiry was conducted. The Preliminary Enquiry unfolded the following facts The accused Tr.T.Sadhasiyam worked as a Village Administrative Officer, Vellimalai village, Kalkulam Taluk, Kanyakumari District from 07.03.2019 to 08.07.2020. Now he is working as a Village Administrative Officer, Puthalam, Kanyakumari District is a public servant within the definition u/s 2(c) of the Prevention of Corruption Act 1988 as amended in Act 16/2018. The defacto complainant Tr.T.Arunainathan residing at Door.No.7/56(1) Varukathattu, Kalpadi, Kanyakumari District. He owned 3 acres of agricultural land in Vellimalai village. He intented to Primary. obtain the loan for agriculture purpose in Manavilai Agricultural Co-operative Bank. The small marginal farmers certificate is a vital document for obtaining Govt. subsidy. For applying small marginal farmers certificate and to obtain loan the Adangal is the important document that acts as proof of land ownership. On AM. the about 10.45 defacto complainant 03 07.2020 at Tr.T.Arunainathan went to the Vellimalai Village Administrative office and met the accused Tr.T.Sadhasivam to levy the arthread to his above mentioned six patta numbers 12649, 9683, 12619, 12652, 12267, 12650 and his brother Tr.T.Arunagiri Raj land comprising patta No. He gave Rs. 6/- + Rs. 1/- the Govt. fee for to the 12695. accused and obtained the receipt No 0970451 and 0970452 for the fasali year 1430. Afterwards the defacto complainant gave the above said six patta copies to the accused and orally requested to issue the Adangal. The accused Tr.T.Sadhasivam demanded an undue advantage

of Rs.1000/- for issuing Adangal for six survey numbers related to the above said pattas. The defacto complainant expressed his inability to pay Rs. 1000/-and he added that there is no fee imposed for obtaining Adangol. The occused reduced Rs.200/- and stated that all survey numbers had 20, 30 cents land so you have to pay the above said demanded amount. The defacto complainant paid Rs.200/- at the moment for gaining faith to the accused and video graphed the entire event to his mobile phone and converted into the CD (compact Disc). The accused accepted the undue advantage of Rs.200/- to perform his official duty improperly by himself and issued the Adangal to the above said six survey numbers. The above said act of the accused Tr.T.Sadhasivam in demand and acceptance of undue advantage with the intention to perform public duty dishonestly and acquired the said Rs.200/- with an illegal motive by abusing his official position as a public servant constituted offence u/s 7 (a) of Prevention of Corruption Act 1988 as amended in Act 16/2018. Therefore, today 25.08.2023 at 13.00 hrs I registered a case in Kanyakumari Detachment, Vigilance and Anti-Corruption, Nagercoil Crime No.5/2023, against Tr.T.Sadhasivam, VAO, Vellimalai Village, Kalkulam Taluk, Kanyakumari District for the commission of offence u/s 7 (a) of Prevention of Corruption Act 1988 as amended in Act 16/2018.
