The following information was gathered during collection of information against the accused noted in the margin.

A-1 Tr.L.Elangovan was working as Block Development Officer (V.P), Uthangarai Block, between 12.06.2013 Krishnagiri District to 20.11.2014 and 20.05.2015 to 15.06.2015. A-2 Tr. G.Ponnurangam was elected and served as President of Kathavani Village Panchayat, Krishnagiri District during the period 2006 to 2016. A-3 Tr.V.Sarathy was working as Secretary Kathavani Village Panchayat, Krishnagiri District between 05.06.1998 to 30.09.2008 and 11.02.2009

to 28.05.2020. A-1 to A-3 are public servants as defined u/s 2 (c) of the Prevention of Corruption Act 1988.

The Government of India have introduced a scheme Nirmal Bharath Abiyan (NBA) in july 2012 which aims to accelerate sanitation coverage in rural areas to achieve the vision of Nirmal Bharath by 2022with all Gram Panchayats in the country attaining Nirmal status. In order to improve the sanitation facilities in rural areas of Tamil Nadu, State Government had decided to construct Individual House Hold Latrines (IHHL) to the eligible inhabitants of villages with the financial assistance of the Central Government. They are being constructed under the scheme Nirmal Bharath Abiyan (NBA) Convergence with Mahatma Gandhi National Rural Employment Guarantee Scheme. Beneficiaries have to construct IHHL on their own accord as per the type design circulated by the Government and they should be monitored by the officials concerned. After completion of the work, funds being released to the beneficiaries by the village panchayats concerned. The fund release pattern under this scheme during the year from 2013-2015 is given here under.

A combined list of all the eligible desirous beneficiaries from village panchayat for constructing Individual Household Latrines (IHHL) shall be prepared. The District Collector will issue the administrative sanction order under Mahatma Gandhi National Rural Employment Guarantee Scheme for all the IHHLs which are approved by Grama Sabha for the year, clearly indicating the labour portion under Mahatma Gandhi National Rural Employment Guarantee Scheme and the material portion of converge under Nirmal Bharat Abhiyan. Based on the Administrative Sanction, the Block Development Officer (Village Panchayat) will issue work order to the beneficiaries individually and copy will be marked to the President of Village Panchayats concerned.

The Village Panchayat will be the implementing Agency. Only Job Card holders under MGNREGS will be employed for the unskilled labour work. For IHHL, it is necessary that the beneficiary also work on his/her IHHL. Contractor is not allowed and machine shall not be deployed for construction of toilet unit. The measurement of the work will be made on completion of individual household toilet unit. Upon completion of assigned IHHL to him/her, the designated worker will attest the NMR for attendance, certify the completion of work done and hand it over to the Overseer for further processing. Then, the Overseer hand over the NMR to the Block Development Officer (VP) and he shall issue fund release order in duplicate to the Village Panchayat. The BDO should conduct field inspection in 50% of the total IHHL construction before releasing the funds. The fund release order should clearly indicate how much amount should be given to the beneficiary from Nirmal Bharat Abhiyan funds and how much amount should be released from Mahatma Gandhi National rural Employment Guarantee Scheme fund. In respect of subsidy amount under Nirmal Bharat Abhiyan scheme, the Village Panchayat President should make payment through cheque from Village Panchayat Scheme fund Account No.3.

The District collector Krishnagiri District issued administrative sanction to Kathavani Village Panchayat in Uthangarai Block for constructing 529 Individual Household Latrines (IHHL) under the scheme Nirmal Bharat Abhiyan(NBA) during the year 2012-2013 through his proceeding Na.Ka.No.314/2013/R6, Dated:12.02.2013. Based on this order the Block Development Officer (V.P) Uthangarai Block was accorded sanction to the President Kathavani Village Panchayat to issue work order to the beneficiaries for the construction of Individual Household Latrines (IHHL) under the scheme Nirmal Bharat Abhiyan(NBA). As per the above mentioned order, after completion of IHHL construction work the subsidy amount should be paid to the beneficiaries concerned through cheque from Village panchayat Scheme Fund Account No.3. The lobour cost should be paid based on the muster roll of MGNREGS through cheque from Village Panchayat Presidents concerned.

According to the G.O.Ms.No.146 Rural Development and Panchayat Raj (C4) Department dated:17.08.2007 Village panchayat Scheme Fund Account shall be operated by the President and Vice President of the Village Panchayats concerned. However, Collectors should instruct the concerned bank branches in writing to make suitable ledger / computer entries to honour the cheques signed by the President and Vice-President only if they are accompanied by the released orders in the form of proceedings of the B.D.O. (Village Panchayats) for the payment of works from the Village Panchayat Scheme Funds concerned. The cheque leaves should also be stamped with "To be paid only if accompanied by proceedings of the B.D.O. (Village Panchayats)" and no self-cheques or drawls based upon withdrawal forms are to be permitted for this account.

It is gathered that during the period 2013-14 & 2014-15 in the construction of Individual Household Latrines (IHHL) under the scheme NBA in Kathavani Village Panchayat, Uthangarai Block, Krishnagiri District a total sum of Rs.29,75,400/- was misappropriated. The above said amount was released at 14 instances from BDO(V.P) Uthangarai to Kathavani Village Panchayat Scheme fund Account No.3. According to the entries made in Kathavani Village Panchayat cash book the above said amount was released from Kathavani Village Panchayat Scheme fund Account No.3 to 522 beneficiaries by cheque, as it was received and disbursed by the secretary of Kathavani Village Panchayat to the beneficiaries concerned. But no acknowledgement of the beneficiaries are available for the disbursement of the above cheques and hence, it appears to be misappropriated by the officials without disbursed. It is further gathered that there were 529 beneficiaries identified for the IHHL in NBA scheme in the year 2012-2013 in which 7 beneficiaries was not desired to construct IHHL.

Therefore, it is revealed that the maximum number of beneficiaries noted in the beneficiaries list had not benefited under the scheme. It is gathered that out of 522 maximum numbers of Individual House Hold Latrines were not constructed in the Kathavani Village Panchayat. The individual subsidy amount Rs.5,700/- was not remitted to any single beneficiary through cheque. They have falsely created 389 Muster Rolls in which beneficiary details of Kathavani Village Panchayt was not found and the remaining 133 Muster Rolls are found missing in Kathavani Village Panchayat office (total beneficiaries 389+133 = 522). The total amount allotted for the 522 beneficiaries Rs.29,75,400/- (Rs.5,700 x 522 = 29,75,400/-) was sent by the State Government to the Panchayat Scheme fund Account No-3. Subsequently, the same amount had been disbursed through cheques in the name of Tr.Ponnurangam, President Kathavani Village Panchayat and three contractors(Private Persons).

The above information makes out a prima facie case against the accused in which, A-1 Tr.L.Elangovan,A-2 Tr.G.Ponnurangam,A-3 Tr.V.Sarathy being the public servants, by entering in to a criminal conspiracy with each other with dishonest intention to defraud the government fund and in pursuance of the conspiracy, they derived

pecuniary advantages by corrupt or illegal means by abusing their official capacity in course of discharging their duties. And they willfully misappropriate the government funds by creating false documents and hence they committed the offences u/s 120(B), 167, 409, 466, 468, 471, 477-A IPC and 13(2) r/w 13(1)(c) & (d) of the Prevention of Corruption Act 1988.

Prior approval u/s 17(A) of the Prevention of Corruption Act, 1988 as amended in 2018 was obtained from the competent authorities for A-1,A-2 and A-3. Therefore, today 09.08.2023 at 10.00 hrs, I registered a case in Krishnagiri V&AC Cr.No.05/AC/2023 u/s 120(B), 167, 409, 466, 468, 471, 477-A IPC and 13(2) r/w 13(1)(c) & (d) of the Prevention of Corruption Act 1988. The original FIR was sent to the Hon'ble Court of Special Judge and Chief Judicial Magistrate, Krishnagiri and a copy of the F.I.R is sent to the officer concerned.
