The credible information was gathered on the petition received from Tr. S. Selvaraj, S/o Savarimuthu, residing at No. 3/27, Main Road, V. Kalathur, Veppanthattai. Perambalur District and after obtaining prior approval, a Preliminary Enquiry was conducted which revealed the following information.

A-1 Tr.K.Prabhu took charge as the President of V.Kalathur Panchayat on 06.01.2020 and is holding the office till date. A-2 Tr. T.Manivannan was working as Overseer in Veppanthattai Union from 07.06.2019 to 31.08.2020 and A-3 Tr N Chandrasekaran, was working as Junior Engineer in Veppanthattai Union from 12.02.2020 to 11.05.2022 Hence, A-1 to A-3 are public servants as per section 2(c) of the Prevention of Corruption Act, 1988 as amended by the Prevention of Corruption Act, 2018.

A-1 Tr.K.Prabhu is the Competent Authority responsible for the Administrative functions of installation, maintenance, repair street lamps, drains, wells construction of roads and A-2 Tr. T. Manivannan is the Competent Authority to make measurements and A-3 Tr. N. Chandrasekaran. Junior Engineer, Veppanthattai Union is the Competent Authority to make check measurements with regard to the execution of the works in the Veppanthattai Panchayat union.

A-4 Tr. Deva, S/o Manivel. Veppanthattai Taluk is the contractor, Private Individual who executed the Public works taken up for investigation.

The Preliminary Enquiry was conducted into the allegations against A-1 to A-4 and it reveals the following.

<u>Creation of forged Bills and Subverting the Procedure of Quotation collection</u> causing Pecuniary Loss to the Government.

The A-1 Ti Prabul the President of V Kalathur Panchayat has created false vouchers for the below mentioned Public Works in the name of Traders like Shanmugha Electricals Popular Electricals Royal Corporation and other traders and has subverted the procedure of quotation collection and unduly favoured Kutti Amman Agency Perambalur Sri Venkateswara Traders Valikandapuram and Jasim Electrical V Kalathur with the intent to dishonestly use the public money and thereby committing Criminal Breach of Trust and caused pecuniary loss to the Government to the tune of Rs 6.51.188/- (approximately)

Misappropriation of Public Funds:

During the course of Enquiry, it is found that there were vouchers claiming the purchase of Chemical items like Bleaching Powder and Phenyl from the Electrical Shops and Hardware Shops like Kutti Amman Agency, Sri Venkateswara Traders and Jasim Electricals, which is not legally and logically possible as the chemicals were not usually permitted to be sold in the electrical and hardware shops unless they have been specifically permitted to do so. Further, on discrete enquiry with the State Tax Officer, Perambalur, it is found that the said Kutti Amman Agency. Perambalur, Sri Venkateswara Traders, Valikandapuram and Jasim Electricals, V.Kalathur have not received licence to sell chemical items like bleaching powder and phenyl etc. Thus, it is found that the President of V.Kalathur Panchayat, has created false vouchers as if sanitary items like bleaching powder and phenyl were purchased from the said traders viz. Kutti Amman Agency, Perambalur, Sri Venkateswara Traders, Valikandapuram and Jasim Electricals, V.Kalathur without actually purchasing the same thereby dishonestly misappropriating the Government Funds as tabulated below.

The public fund utilized for the listed under public works has been done without proper way of call for tender, proper monitoring of works at site and failure in recording the actual measurement in the M. Book. The M. Books, Vouchers and Utilization Certificate seems that the entries made in the M. Book such as measurement of works and check measurement were done mechanically which appears to be table works. On enquiry, it is found that the specification for the said work has not been done as mentioned in the M. Book and proper procedure has not been adopted in the execution of the said works. It clearly shows, that the accused Tr. Prabu, the President, in collusion with one Deva, S/o Manivel, Contractor. 2/105. Theru. Thondapadi, Veppanthattai Taluk have misappropriated the Government funds. Further, it is ascertained that second hand electrical motors were erected for the water supply scheme and prepared vouchers as if new motors were purchased and erected in vouchers No.69, 113 and 114 for the year 2020-2021. The tabulation of the public works wherein the Government funds are dishonestly misappropriated as tabulated below.

Thus, the A-1 Tr.Prabu, the Panchayat President, in collusion with the Contractor A-4 Tr.Deva, S/o Manivel has created false records with the intent to commit forgery and has dishonestly misappropriated the Government fund and thereby committing Criminal Breach of Trust. Further, it is ascertained that the execution of the pipe line works and the erection of electric motors were not properly measured and check measured in the M. Book by the A-2 Tr.T.Manivannan, the then Union

Overseer and the A-3 Tr N Chandrasekharan, the then Junior Engineer of Veppanthattai Union respectively

Further, it is ascertained that the Government fund utilized in the form of purchase of Electrical, Plumping and Sanitary materials from Kutti Amman Agency, Perambalur, Sri Venkateswara Traders, Valikandapuram and Jasim Electricals, Vikalathur and also the execution of the Water supply works through the contractor one Tr Deva, Sio Manivel were paid to the respective persons bank account number through PEMS

The A-1 Tr Prabu, the Panchayat President of V Kalathur Village A-2 Tr T Manivannan the then Union Overseer and the A-3 Tr N Chandrasekharan, the then Junior Engineer of Veppanthattai Union who all are public servants and A-4 Private Individual contractor one Tr.Deva, S/o Manivel have misappropriated the Government fund to the tune of Rs. 14,24,408/- by committing the offences of criminal conspiracy, framing of incorrect records, creating forged documents and falsification of accounts, Criminal Misconduct and have done their public duties dishonestly

The accused 1 to 3 performed dishonestly a public duty in consequence of accepting an undue advantage by abusing their position as public servants and by corrupt and illegal means. A4 has abetted A1 to A3 public servants in the offence of criminal misconduct.

Hence. A-1 to A-3 have committed offences punishable u/s 13(2) r/w 13(1)(a) and 7(c) of the Prevention of Corruption Act 1988 (as amended in 2018) and u/s 120-B. 167. 409. 468. 471 and 477 A IPC.

Further, A-4 Private Individual contractor one Tr.Deva, S/o Manivel have committed offences punishable u/s 12 r/w 13 (2) r/w 13 (1)(a) and 7(c) of the Prevention of Corruption Act 1988 (as amended in 2018) and u/s 120-B. 468 and 471 IPC.
