Continuation of Tenkasi Vigilance and Anti-Corruption Crime No.06/2023:-

Cr.No.06/2023 against A-1 Tmt.A.Ananthy for the commission of offence u/s 13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988 for the period between 01.04.2014 and 25.07.2018 and 13(2) r/w 13(1) (b) of the Prevention of Corruption Act, 1988 as amended in Act 16 of 2018 for the period between 26.07.2018 to 31.03.2022 and A-2 Tr.Arinarayanan for commission of the offence u/s 13(2) r/w 13 (1) (e) of P.C Act, 1988 r/w 109 IPC for the period between 01.04.2014 and 25.07.2018 and 12 of P.C Act, 1988 as amended in Act 16 of 2018 for the period between 01.04.2014 and 25.07.2018 and 12 of P.C Act, 1988 as amended in Act 16 of 2018 for the period between 01.04.2014 and 25.07.2018 and 12 of P.C Act, 1988 as amended in Act 16 of 2018 for the period between 26.07.2018 and 25.07.2018 and 31.03.2022.

The crux of the allegations pertains to the registration of the first Information report are excerpted here under :-

The following information was gathered during the collection of information against the Accused noted in the margin. A-1 Tmt.A.Ananthy is the i/c Sub Registrar, Tenkasi in the year 2021 and 2022. A-1 Tmt.A.Ananthy initially worked as Junior Assistant for consolidated monthly pay of Rs.4,000/- in Health Department, Sankarankovil from the year 2003. She then worked as Junior Assistant on temporary basis in Revenue Department, Alangulam. She was made permanent and posted in Registration Department as Junior Assistant in the year 2010. She was promoted as Assistant in the year 2014. She was in-charge Sub Registrar, Puliyangudi, in the year 2015-16. She was in-charge Sub Registrar, Alangulam from 2016-17 to 2018. She held charge as in-charge Sub Registrar during the temporary absence (or) leave vacancies of Sub Registrars in the jurisdiction of District Registrar, Tenkasi in the year 2018-19 and 2019-20. She then held charge as in-charge Sub Registrar in Oothumalai in the year 2020.

As such A-1 Tmt.A.Ananthy is a Public Servant as defined u/s 2(c) of the Prevention of Corruption Act, 1988 during the period of commission of offence.

Collection of sources reveals that A-1 Tmt.A.Ananthy hails from a middle class family. Her husband A-2 Tr.Arinarayanan is a B.Com., graduate, who had

worked initially as part time Postal Officer for a monthly consolidated salary of Rs.900/- in the year from 1990 to 1998. He was then dismissed from the Postal Department for misappropriating Government money. He then studied B.L. Presently he was elected as 20th Ward Councillor of Alangulam Panchayat Union. He conducted a Nursery and Primary School in the name and style of "Saruka Nursery School" upto Vth standard from the year 1992. Initially he had run the School in a rented residential building at Maruthamputhoor village and now he is running the Saruka CBSE School in the newly constructed own building with the old permission upto Vth standard in the years from 2017 to 2022 after purchasing 6 acres of land at Pudupatty. A-2 Tr.Arinarayanan is having only a meagre income.

A-1 Tmt.A.Ananthy has one son by name Tr.A.Sagar and one daughter by name Tmt.Saruka. Her son studied BA and MBA in Einstein Arts and Science College, Abishegapatti and her daughter studied B.Sc., B.Ed. in the same college. Her daughter was married in the year 2018 and her son was married in the year 2021. Both A-2 Tr.Arinarayanan and Tr.A.Sagar are looking after the School. Now her daughter Tmt.Saruka and her husband are running a Textile shop in the name and style of "Ananthy Textiles" in a rented building at Tenkasi from their marriage onwards.

The beginning of the check period was fixed as 01.04.2014 keeping in mind the purchase of landed properties for the school. The end of the check period was fixed as 31.03.2022 keeping in mind the additional construction of her house at Maruthamputhoor village, Alangulam Taluk and the construction of school buildings. Thus the check period was conveniently fixed between 01.04.2014 and 31.03.2022 keeping in mind the cash flow, assets and expenditure of the A-1 Tmt.A.Ananthy and her husband A-2 Tr.Arinarayanan.

Information gathered has revealed that A-1 Tmt.A.Ananthy had intentionally enriched herself and in possession of assets in her name and in the name of her husband A-2 Tr.Arinarayanan during the period of her office in various places,

which are disproportionate to her known sources of income. Most of the assets acquisition activities of the A-1 Tmt.A.Ananthy in her name and in the name of her husband A-2 Tr.Arinarayanan fall between 01.04.2014 and 31.03.2022 and hence the check period is tentatively fixed between the above said period. During that period the A-1 Tmt.A.Ananthy and his dependents A-2 Tr.Arinarayanan were found in possession of pecuniary resources/assets as detailed below.

The A-1 Tmt.A.Ananthy is in possession of peçuniary resources and properties (in the form of lands, vehicle, bank balances etc.,) to the tune of Rs.2,43,007/- in her name and in the name of her husband A-2 Tr.Arinarayanan as on 01.04.2014 i.e., at the beginning of the said check period.

The A-1 Tmt.A.Ananthy is in possession of pecuniary resources and properties (in the form of house sites, house buildings, lands, bank balances, school buildings, vehicles etc.,) to the tune of Rs.1,96,80,138/- in her name and in the name of her husband A-2 Tr.Arinarayanan as on 31.03.2022 i.e., at the end of the said check period.

The A-1 Tmt.A.Ananthy and others had received lawful sources of income from pay and other allowances, through hand loans and interest from bank to the tune of Rs.59,47,824/- during the check period.

The A-1 Tmt.A.Ananthy had incurred expenses (in the form of living expenses and others) to the tune of Rs.14,52,094/- during the check period.

Thus the A-1 Tmt.A.Ananthy acquired pecuniary resources and properties to the tune of Rs.1,94,37,132/- (Rs.1,96,80,138 - Rs.2,43,007 = Rs.1,94,37,132/-) during the check period.

Further the A-1 Tmt.A.Ananthy have saved Rs.44,95,730/- (Rs.59,47,824 - Rs.14,52,094 = Rs.44,95,730/-) as excess fund and could have acquired pecuniary resources and properties only to the tune of Rs.44,95,730/- during the said check period by making use of her likely savings.

But A-1 Tmt.A.Ananthy has acquired assets in her name and in the name of her husband A-2 Tr.Arinarayanan to the tune of Rs.1,49,41,402/- (Rs.1,94,37,132 - Rs.44,95,730 = Rs.1,49,41,402/-) in excess of the likely savings, during the check period.

Thus, A-1 Tmt.A.Ananthy during the period of her working as Assistant and In-charge Sub Registrar from 01.04.2014 to 31.03.2022 is in possession of pecuniary resources and properties in her name and in the name of her husband A-2 Tr.Arinarayanan to the tune of Rs.1,49,41,402/- which is disproportionate to the known sources of income. The extent of disproportionate asset is 251% of the total income during the said check period.

The available information makes out a prima facie case against A-1 Tmt.A.Ananthy and A-2 Tr.Arinarayanan that they were in possession of pecuniary resources and properties to the tune of Rs.1,49,41,402/- during the check period between 01.04.2014 and 31.03.2022 which is disproportionate to their known sources of income. Thereby, A-1 Tmt.A.Ananthy had committed the offence of Criminal Misconduct as she intentionally enriched herself and in possession of assets disproportionate to known source of income during the check period by abusing her official position as public servant and A-2 Tr.Arinarayanan had abetted her to commit the said offence by acquiring the assets through the resources of A-1 Tmt.A.Ananthy.

Therefore, today 20.09.2023 at 12.00 hrs, I registered a case in Tenkasi V&AC., Cr.No.06/2023 against A-1 Tmt.A.Ananthy for the commission of offence u/s 13 (2) r/w 13 (1) (e) of Prevention of Corruption Act 1988 for the period between 01.04.2014 and 25.07.2018 and 13(2) r/w 13(1) (b) of the Prevention of Corruption Act, 1988 as amended in Act 16 of 2018 for the period between 26.07.2018 to 31.03.2022 and A-2 Tr.Arinarayanan for commission of the offence u/s 13(2) r/w 13 (1) (e) of P.C Act 1988 r/w 109 IPC for the period between 01.04.2014 and

25.07.2018 and 12 of P.C Act, 1988 as amended in Act 16 of 2018 for the period between 26.07.2018 and 31.03.2022.

The original F.I.R is submitted to the Hon'ble court of the Special Judge, Special Court for Trial of cases under PC Act, Tirunelveli and a copy of the FIR is sent to the Superintendent of Police, Vigilance and Anti-Corruption, Southern Range for issuing order u/s 17 of the Prevention of Corruption Act, 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of A-1 Tmt.A.Ananthy and her husband A-2 Tr.S.Arinarayanan.
