Accused Officer

Tr.V.Govindharaju (Age-55/2023), Assistant Secretary, S.175 Belukurichi Primary Agricultural Cooperative Credit Society, Belukurichi, Senthamangalam Block, Namakkal District. The accused officer Tr.V.Govindharaju has been working as Assistant secretary since 01.06.2019 and now incharge of Secretary, S.175 Belukurichi Primary Agricultural Cooperative Credit society, Belukurichi, Senthamangalam Block, Namakkal District is a public servant as defined u/s 2(c) of the Prevention of Corruption Act, 1988.

The Department of Co-operative, Food and Consumer Protection (CC-1) of Tamil Nadu Government on 01.11.2021, released a Government Order in G.O.(Ms.) No.97 on the waiver of gold loans where gold weighing five sovereigns were mortgaged in cooperative banks. The Government Order stating that the gold loans taken from cooperative banks till March 31, 2021 will be waived off based on certain qualifications to benefit the needy. The Government Order also mentioned a set of guidelines to be followed by the cooperative banks for the waiver process. According to the guidelines, if a ration card holder and the members having one or more gold loans (gross weight up to 40g) in one or more cooperative banks, they will be eligible for the waiver. In case of the eligible borrower had repaid part of the loan already, the balance loan amount including principal and other interests will be taken into account of the waiver. The Government Order also listed the ineligible categories like the loans taken after March 31, 2021 are not eligible for waiver. The gold loan above 40grams of gross weight in one or more cooperative banks will not be eligible for the waiver. The

gold loan within 40grams of gross weight taken on or before the cut-off date of March 31, 2021 will not be entertained for the waiver if the loan had been closed on or before the release of the Government Order.

Following the announcement made by the Government for a waiver for gold loans, obtained pledging up to a gross weight of 40 grams (5 sovereigns) in cooperative sector banks, a total of 48,84,726 gold loan applications were scrutinized and out of this, 13,47,003 loans were waived off, while 35,37,693 applications were ineligible for the waiver due to various reasons.

As far as the Namakkal District is concerned totally 47,618 beneficiaries were finally selected for Gold Ioan waiver scheme. Namakkal District has two cooperative sub-division viz., Namakkal and Tiruchencode sub-divisions. S-175 Belukurichi Primary Agricultural Cooperative Credit Society (PACCS), Belukurichi comes under the Senthamangalam Block of Namakkal sub-division. In the above said society, totally 311 jewel Ioans were eligible under this scheme.

Further, it is revealed on the video circulated in social media, intelligence inputs collected and on the report of Tr.P.Karnan, Deputy Registrar of Cooperative Department that Accused Tr.V.Govindharaju has been working as Assistant Secretary, S-175 Belukurichi Primary Agricultural Cooperative Credit Society, Senthamangalam Block, Namakkal District from 01.06.2019 and presently in-charge as Secretary, demanded an undue advantage of Rs.4,000/from Tmt.V.Yuvarani, W/o. Vishwanathan on 28.03.2022 for processing to waive her gold loan number 2257, dated: 29.01.2021 with loan amount of Rs.89,000/for 30grams of jewels. Likewise, the Accused Tr.V.Govindharaju had demanded undue advantage from Gold Loan borrowers Tmt.Keerathana, Tr.G.Srinivasan, Tmt.M.Chandra, Tr.V.Perumal and Tr.P.Silambarasan for processing to waive their gold loans on the date when they approached him for getting Gold Loan Waiver certificate.

Further, the Accused Tr.V.Govindharaju had demanded and accepted undue advantage of Rs.1,500/- from Tr.C.Kandaswamy, S/o.Chinnasamy, on or after 28.03.2022 for processing to waive his Gold Loan Number 2072, dated: 12.11.2020 with loan amount Rs.50,000/- for 31.500 grams of jewels.

Thus the Accused Tr.V.Govindharaju demanded and accepted undue advantage for the performance of Public duty. The said allegation clearly makes out a prima facie case against the accused Tr.V.Govindharaju u/s. 7(a) of the Prevention of Corruption Act, 1988 as amended in 2018.

The Co-operative Sub-Registrar/Administrator accorded permission to register regular case against the above Government Official u/s. 17-A of the Prevention of Corruption Act, 1988 as amended in 2018.

Therefore, today on 29.08.2023 at 11.00 hours, I had registered a case in Namakkal Vigilance and Anti-Corruption Crime No.7/AC/2023, u/s. 7(a) of the Prevention of Corruption Act, 1988 as amended in 2018 against the accused Tr.V.Govindharaju, Assistant Secretary, S.175 Belukurichi Primary Agricultural Cooperative Credit Society, Belukurichi, Senthamangalam Block, Namakkal District and further investigation of this case is entrusted to Tmt.M.Nallammal, Inspector of Police, Vigilance and Anti-Corruption, Namakkal as per the orders of the Director of Vigilance and Anti-Corruption, Chennai. The original F.I.R. is submitted to the Hon'ble Court of the Special Judge / Chief Judicial Magistrate, Namakkal and other copies are sent to the Officers concerned.
