FIR Continuation in V&AC, Nagercoil- Cr.No.08/2023

Office, Fisheries Department, Nagercoil, Kanyakumari District on deputation duty since 02.08.2013. He is a public servant within the definition of section 2 (c) of the Prevention of Corruption Act, 1988.

Tr.V.Mahesh worked as Assistant in the Fisheries Department on OD basis in the office of the Divisional Engineer, Fisheries Department, Nagercoil, Kanyakumari District. By corrupt or illegal means abusing his official position, he acquired movable and immovable assets and pecuniary resources in his name and in the name of his wife Tmt.Anuratha, the accused intentionally enriched himself illicitly during the period of his office.

Accused married Tmt.G. Anuratha in the year 2003. They have two children namely Selvan M.Sreeman Vishnava Vanash, Age 19 and Selvi Gayathri, Age 17. The family background of SO-1 Tr. Mahesh is very poor. His father was having only one Acre 24 cents of land in his name prior to the entry of the SO in Government service. He is having three younger sisters and they were not earning. After he entered into Government job he accumulated huge wealth which cannot be equated with his legal income by way of salary from Government service.

During the course of investigation, considering the sensitiveness of the post held by the accused and the frequency of funds flow, the check period was fixed between 01.06.2013 to 31.12.2022.

The assets of the accused during the check period are calculated as mentioned below in Statement I to VII.

Assets found in the name of AO and his wife in the beginning of check period on 01.06.2013 is Rs. 4,03,381.80/- (Statement – I)

Assets found in the name of AO and his wife at the end of check period on 31.12.2022 is Rs. 3,05,10,764.92/- (Statement - II)

Income of AO and others from known sources of income during the check period between 01.06.2013 to 31.12.2022 is Rs. 91,25,809.00/- (Statement-III)

Expenditure incurred by AO and others during the check period between 01.06.2013 to 31.12.2022 is Rs. 39,48,505.00/- (Statement-IV)

Value of assets acquired by AO in his name and in the name of his wife during the check period between 01.06.2013 to 31.12.2022 is Rs. 3,01,07,383.12/- (Statement-V)

Statement –II – Statement – I

Rs. 3,05,10,764.92 - Rs. 4,03,381.80 = Rs. 3,01,07,383.12/-

Likely savings of AO and others during the check period between 01.06.2013 to 31.12.2022 is Rs. 51,77,304/- (Statement-VI) Hence he had savings during the check period.

Statement - III - Statement - IV

Rs. 91,25,809.00 - Rs. 39,48,505.00 = Rs. 51,77,304/-

Disproportionate assets acquired by the AO in his name and in the name of his wife Anuratha during the check period between 01.06.2013 to 31.12.2022 can be calculated by subtracting the likely savings of the accused officer from the assets acquired by the accused officer during the check period

Disproportionate assets = Assets acquired during the check period minus likely savings during the check period Rs. 2,49,30,079.12/-

Statement –V – Statement – VI

Rs. 3,01,07,383.12/- (-) Rs. 51,77,304/- = Rs. 2,49,30,079.12/-(Statement-VII)

The assets acquired by the accused and others during the check period between 01.06.2013 to 31.12.2022 in percentage is

Rs. 2,49,30,079.12 =X 100 = 273.18% Rs. 91,25,809

Thus the collection of materials discloses that the accused Tr.V. Mahesh had amassed wealth of Rs. 2,49,30,079.12/- against his known sources of income during her tenure from 01.06.2013 to 31.12.2022.

The available information makes out a prima facie case against the accused for the offence of criminal misconduct as he had intentionally enriched himself and in possession of assets disproportionate to his known sources of income during the check period by abusing his official position as public servant as stated above.

Therefore today 10.00 at hrs I registered a case in Kanyakumari Detachment Vigilance and Anti-corruption Cr. No. 08/2023 against the accused. Tr.V. Mahesh, S/o Tr.Velayuthaperumal, Assistant as has committed the offence u/s 13(2) r/w 13(1)(e) of Prevention of Corruption Act, 1988 for the period of 01.06.2013 to 25.07.2018 and committed the offence u/s 13(2) r/w 13(1)(b) of Prevention of Corruption Act,1988 as amended by Act 16/2018 for the period from 26.07.2018 to 31.12.2022.

The original FIR is submitted to the Hon'ble Court of the Chief Judicial Magistrate cum Special Judge, Nagercoil and a copy of FIR is sent to the Superintendent of Police, Vigilance and Anti-Corruption, Southern Range for issuing order u/s 17 of the Prevention of Corruption Act, 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of the accused and others relevant copies to officer concerned and one copy to Tmt.C.Siva sankari, Inspector of Police, Vigilance and Anti-Corruption, Kanyakumari Detachment @ nagercoil for conducting further investigation.
