## Continuation of FIR for SI.No.12 of Namakkal Vigilance and Anti-Corruption, Crime No.10/AC/2023, Under Section 7(a) of the Prevention of Corruption Act, 1988 as amended in 2018 and Section 420 IPC.

## **Accused Officer**

Tr.G.Sathishkumar (Age-31/2023), S/o.Ganapathi, Formerly Sub-Inspector of Survey, Survey Section, Taluk Office, Kollihills Taluk, Namakkal District. Now Sub-Inspector of Survey, District Adi-Dravidar Welfare Office, District Collectorate, Namakkal.

(Residing at: D.No.1/100 Main Road, Sarkar Valavanthi-Post, Mohanur Taluk, Namakkal District.)

The marginally noted accused officer Tr.G.Sathishkumar, S/o.Ganapathi was working as Sub-Inspector of Survey, Survey Section, Taluk Office, Kollihills Taluk, Namakkal District from 01.06.2019 04.05.2022 and he was holding to additional charge Firka Surveyor. as Valavanthinadu Firka, Namakkal District during the above said period. Now he has been working as Sub-Inspector of Survey. District Adi-Dravidar Welfare Office. District Collectorate. Namakkal since 05.05.2022. He is a public servant within the definition of section 2(c) of the Prevention of Corruption Act, 1988 as amended in 2018.

As stipulated in the (Tamil Nadu) Survey and Boundaries Act. 1923 (Tamil Nadu) Act No. VIII of 1923, the duties and responsibilities of the accused officer Tr.G.Sathiskumer is that to conduct field inspection. survey the land draw the survey map, maintain field measurement book and send tile verifications/ recommendation reports to the Tahsildar, Kollihills Taluk through his higher officials of the Head Draughtsman and Deputy Inspector of Survey Survey Section, Kollihills Taluk, Namakkal District

The petitioner Tr.T.Charles Victor, S/o.T.S.Thangaiya, is residing in Chennai. He has agricultural land of 8 acres at Alathur Nadu Village, Kollihills Joint patta was issued for the said land on Taluk, Namakkal District. 22.06.2020. He applied separate patta to Kollihills Tashildar on 24.08.2020. He also sent copy of petition to Sub-Inspector of Survey, Kollihills Taluk. The Surveyor Tr.G.Sathishkumar contacted the petitioner in cell phone and told that patta would be given after surveying the land and demanded Rs.18,000/-. The Surveyor said Rs.2,000/- is for receipt fee and Rs.2,000/- per acre is for Government survey fee. The Surveyor asked the petitioner to send that amount immediately. The petitioner sent the receipt fee of Rs.2,000/- to Sathishkumar's SBI account No.35605168470 through Google pay on 02.09.2020. Then, surveyor Tr.G.Sathishkumar compelled the petitioner to pay the balance amount immediately through Google pay of his wife's cell phone number. So, the petitioner sent Rs.10,000/- to Tr.G.Sathishkumar's wife Tmt.Balasangeetha's phone number 9940779242 through Google pay on 24.09.2020. The surveyor Tr.G.Sathishkumar, the Village Administrative Officer Tmt.Jayasudha, and the Village Assistant surveyed the land on 25.09.2020. The petitioner's brothers Tr.Anburaj and Tr.Chinnadurai, his relatives were present there. Then, the surveyor Tr.G,Sathishkumar told to send the balance amount in his wife Tmt.Balasangeetha's cell phone number. So, the petitioner sent Rs.5,000/- through Google pay on the day evening. The surveyor Tr.G.Sathishkumar came with his officers on 26.09.2020 and 27.09.2020 and surveyed the land. The petitioner's brothers Tr.T.S.Anburaj and Tr.T.S.Chinnadurai, his relatives were also present there. Since receipt and separate patta were not given for a long time, the petitioner again contacted the surveyor Tr.G.Sathishkumar. The surveyor said lesser amount has been paid towards survey fee and he asked him to send patta application to him and Kollihills Tashildar and sent Rs.20,000/-again. He also asked to send patta processing fee of Rs.500/-. The petitioner sent patta processing fee of Rs.500/- to SBI account number through Google pay on 03.12.2020 Since no action was taken, the petitioner approached Tr.S.Rajkumar,

Tahsildar and told his grievance. Tahsildar said his patta application was not available in office, his (petitioner's) land was not surveyed and there was no such record for it. The petitioner came to know that he was cheated and also surveyor Tr.G.Sathishkumar had cheated many tribal people like him

The surveyor Tr.G.Sathishkumar demanded and accepted totally Rs.17,500/- as undue advantage for himself from the petitioner Tr.T.S.Charles Victor for surveying his land and issuing separate Patta. Also the surveyor Tr.G.Sathishkumar obtained that amount on the promise of issuing separate patta to the petitioner which amount to cheating.

The said allegations clearly makes out a prima facie case against the accused officer Tr.G.Sathishkumar under section 7(a) of the Prevention of Corruption Act, 1998 as amended in 2018 and section 420 IPC. The Assistant Director, District Land Survey Office, Namakkal District accorded permission u/s. 17-A of the Prevention of Corruption Act, 1988 as amended in 2018 to register a regular case against the said officer.

Therefore, today on 02.11.2023 at 16.30 hrs, I registered a case in Namakkal Vigilance and Anti-Corruption Crime No.10/AC/2023, u/s. 7(a) of the Prevention of Corruption Act, 1988 as amended in 2018 and section 420 IPC against the accused officer Tr.G.Sathishkumar noted in the margin. The original F.I.R is submitted to the Hon'ble Court of Special Judge cum Chief Judicial Magistrate, Namakkal and copies are submitted to the officers concerned.
