- 1. Tr. N. Murugesan, S/o Nainamalai, Assistant Revenue Officer, Kondalampatty Ward Office, Salem Corporation, Salem.
- 2) Tmt. K.R. Kavitha, W/o. Murugesan, Door No.98/6, Ponnusamy East Street No. II, Ramanathapuram, Kannankuruchi Main Road, Salem -6.

The following information was gathered through sources against A-1 Tr. N. Murugesan and his wife A-2 Tmt. K.R. Kavitha that A-1 was found in possession of assets in his name and in the name of his wife Tmt. K.R. Kavitha and enriched himself illicitly during the period of his office as an Assistant Revenue Officer which is disproportionate to his known sources of income.

It is gathered that A-1 Tr. N. Murugesan is now working as Assistant Revenue Officer, Kondalampatty Ward Office, Salem Corporation, Salem and he is a Public Servant as defined u/s 2(c) of the Prevention of Corruption Act 1988. A-2 is wife of A-1, she is a private individual. A-1 entered into Government Service as a Junior Assistant, Rasipuram Municipality on 28.01.1994. Then, he was promoted as Assistant Revenue Officer on 11.01.2018. He is going to retire from service on attaining the age of superannuation on 30.06.2029.

It is further gathered that A-1 Tr. N. Murugesan hails from a middle-class family. He is a native of Salem District. His father was a Junior Assistant, Salem Corporation and he had expired during his service. His mother is a house wife. He married A-2 Tmt. K.R. Kavitha, D/o Kandasamy Rajan on 04.12.1997. Now she isworking as a Manager at Hotel Grand Estanica, No.349/3, Bangalore Bye-Pass Road, Narasothipatti, Salem. Previously she was an employee of La Four Seasons and worked as Resort Manager at Living Art Hospitality LLP, No.172/3, LA Rohan Maple, KMS Garden, Alagapuram Pudur, Salem. His son Tr. M. Vignesh is a manager of a software company.

It is gathered that most of the acquisition activities of A-1 and his family members fall between 01.01.2015 and 31.12.2021, hence it was chosen as tentative check period and during that period, he and his wife were found in possession of assets as detailed below:-

The available information makes out a prima facie case against A-1 Tr. N. Murugesan that he was found in possession of pecuniary resources and his wife A-2 Tmt. K.R. Kavitha, was found in possession of a substantial portion of the

assets on his behalf, all to the tune of Rs. 2,32,52,820/- which comes 182% of his total income during the check period, which is disproportionate to their known sources of income. Thereby, A-1 being a public servant had committed the offence of criminal misconduct and A-2 had abetted him to commit the said offence by acquiring the assets from the resources of A-1.

Therefore, today 26.10.2023 at 09.45 hrs, I registered a case in Salem V&AC Cr. No.10/AC/2023 against A-1 Tr. N. Murugesan for the commission of offence u/s 13 (2) r/w 13(1) (e) of the Prevention of Corruption Act, 1988 and 13(2) r/w 13(1) (b) of the PC 1988 as amended in 2018 and his wife Tmt. K.R. Kavitha for the commission of offence of Abetment u/s 13(2) r/w 13(1) (e) of the PC Act, 1988 r/w 109 IPC and 12 r/w 13(2) r/w 13(1) (b) of the PC Act 1988 as amended in 2018.

The original FIR is submitted to the Hon'ble Special Judge, Special Court for Trial of Cases under the Prevention of Corruption Act, Salem and a copy of the FIR is sent to the Superintendent of Police, Vigilance and Anti-Corruption, Western Range for issuing order u/s 17 of the Prevention of Corruption Act, 1988 to the investigating officer and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of A-1 and his family members.
