Accused:

Tr.S.Sridhar, Age 52 S/o.D. Santhanakrishnan Formerly Manager (Marketing & Service), Tamil Nadu Housing Board, Coimbatore Housing Unit, Tatabad, Coimbatore. The Accused Tr.S.Sridhar was serving as Manager (Marketing & Service) in Tamil Nadu Housing Board, Coimbatore from 08.12.2014 to 31.07.2018 (now placed under suspension). He is a public servant within the definition of 2(c) of the Prevention of Corruption Act, 1988.

The Manager (Marketing & Service) of TNHB is in charge of the execution and management of all works entrusted to him. He has to verify the documents namely the Sale Deed Register, Day Book Receipt, Subsidiary Day Book, Receipts Book, FMB Sketch Register, Working Sheet prepared for the allotment of the house plot, Allottee Ledger and Genuineness of the Allottee in person.

The Manager (Marketing & Service) has to sign in the Sale Deed as Vendor only after discussing with his subordinates and verifying the payment of full final cost by the allottee.

The duty of the Superintendent along with other duties is to attest as witness in the witness column (1) of the Sale Deed before registration.

The duty of the Assistant apart from other duties is to attest as witness in the witness column (2) of the Sale Deed before registration.

It is the practice and procedure in TNHB that after paying the entire payment of the sale price to the TNHB, the allottee would approach the Assistant of the concerned section with the required documents. The same would be verified by the section Superintendent and the concerned Assistant. After the satisfaction of the payment of full final cost, a Sale Deed intimation letter would be sent to the allottee.

Later the draft Sale Deed, as per the format prescribed in the TNHB Allotment Manual, would be given to the allottee with the knowledge of the

Manager (Marketing and Service) and a copy of Sale deed will be retained in the Housing Unit file itself. Section Assistant would sign in the place of Assistant as witness after verifying the sale deed.

The Superintendent would re-verify the sale deed and would affix the signature in the column of Superintendent as witness. Then the MMS would take the allottee along with the documents and register for approval and sign in the sale deed as Vendor.

Finally, the sale deed would be handed over to the allottee along with the authorization letter u/s 88(i) of Indian Registration Act to be registered in the concerned SRO office. Accordingly, the allottee can submit before the SRO for registration of the sale deed. During the registration of Sale Deed in the SRO office, the two private individuals should sign in the Sale deed to establish the identification of the allottee.

On 21.06.2001, the Tamil Nadu Housing Board, Coimbatore had allotted a HIG Plot No.H-941 IV of Ganapathy Block 1 – 4 scheme to the allottee Tr.Selvaraj Mahendran under the hire purchase scheme at the tentative rate of Rs.7,07,800/-. The deposit amount for the allotted plot was fixed as Rs.2,83,200/-. Similarly, the installment amount and maintenance amount were fixed as Rs.6,663/- and Rs.180/- respectively for 14 years. After the remittance of the above deposit, installments and maintenance, the allottee Tr.Selvaraj Mahendran had remitted an amount of Rs.4,77,100/- on receiving the intimation from the TNHB, Coimbatore. As such, the allottee Tr.Selvaraj Mahendran has remitted an amount of Rs.11,46,063/- till 20.06.2017. He is yet to pay Rs.1,68,533/- balance amount to Tamil Nadu Housing Board before registration.

While so on 20.06.2017, the Accused Tr.Sridhar being the Manager (Marketing & Service) of TNHB, Coimbatore abused his official position and in order to show the favouritism towards the allottee Tr.Selvaraj Mahendran arbitrarily and capriciously executed a sale deed in a clandestine manner and issued the same to the allottee before the remittance of the balance amount of Rs.1,68,533/- as per the computerized working sheet and in result of which, the Accused caused a wrongful loss to the TNHB. Further, the Accused abused his official position, violated the practice and procedures of TNHB with an oblique motive and tampered the approved draft sale deed, which was approved earlier by the Tamil Nadu Housing Board, by way of

removing the official witnesses column of the sale deed and allowed to sign the allottee Tr.M.Selvaraj Mahendran's wife Tmt.Vallithai and son Tr.Karthick Mahendran as witnesses in the witness column of the sale deed.

The information discloses that the act of the Accused Tr.Sridhar, Manager (Marketing & Service), TNHB, Coimbatore is an offence u/s 167, 409, 465, 471 IPC and u/s 13(2) r/w 13(1)(d) of the Prevention of Corruption Act, 1988.

Therefore, this FIR being registered after obtaining prior permission from the competent authorities u/s 17A (1) of the Prevention of Corruption Act, 1988 as amended by the Prevention of Corruption (Amendment) Act, 2018. I am registering a case in Coimbatore V&AC Cr.No.12/2023/AC/CB against Accused Tr.S.Sridhar, formerly Manager (Marketing & Service), TNHB, Coimbatore on 28.12.2023 at 15.30 hrs for commission of an offence of criminal misconduct punishable u/s. 167, 409, 465, 471 IPC and u/s 13(2) r/w 13(1)(d) of the Prevention of Corruption Act, 1988.

The original FIR is submitted to the Honourable Special Court for trial of cases under the Prevention of Corruption Act, Coimbatore, a copy of the FIR is sent to the Superintendent of Police, Western Range, Vigilance and Anti-Corruption, Chennai and the case was entrusted to Tmt.P.Parimaladevi, Inspector of Police, Vigilance and Anti-Corruption, Coimbatore for further investigation.
