The A-3 Tmt.Shanthi, had issued her Proceedings to the Head Masters/Head Mistress vide Letter No. ந.க எண்.71/ஒபக/க.ப/2019, dated 21.08.2019, in which stated that

The sanctioned amount of Rs.48,00,000/- was credited to the schools concerned through PFMS / ECS.

A-4, A-5, A-6, A-7, A-8 procured the furniture from private firm instead of invoking procurement by way of limited tender. The A-3 and A-2 did not permit A-4 to A-8 to entertain into the procurement transactions in their School level instead by invoking his supervisory powers (misuse) in the capacity as an District Programme Coordinator and also the A-3 and A-2 with dishonest intention to commit fraud on the RMSA scheme funds instructed the A-4 to A-8 as receive the furniture from whom they permitted to supply and issue the cheque in the name of private firm and hand it over to the A-2. In pursuance of the Criminal conspiracy, the A-4 to A-8 also have been given their cooperation as followed by the A-3 & A-2 instruction with ulterior motive of procuring inprivate firm, instead of invoking RMSA Scheme procurement guidelines. To avoid implementation of Limited Tender for procuring furniture to the Schools, the A-3, A-2 with dishonest intention wrongfully guided the Head Masters and colluded with them by procuring through private firm.

The sanctioned amount of Rs.62,23,000/-was credited to the schools concerned through PFMS / ECS.

Preliminary Enquiry reveals that the above said 13 Head Masters had procured the furniture from private firm instead of procuring from TANSI and other Government industries for their Schools in Class Room Wise, so they utilized the RMSA Scheme funds below the limit level of invoking Tender. The A-1 & A-2 did not permit them(Head Masters/Head Mistress) to entertain into the procurement transactions in their School level instead by invoking their supervisory powers in the capacity as an District Programme Coordinator by invoking RMSA Scheme procurement guidelines and also misguided the Head Masters as receive the furniture from whom they permitted to supply and issue the cheque in the name of private firm and handed it over to the A-2. Even though the said 13 Head Masters were utilized the RMSA Scheme funds below the limit level of invoking Tender, the A-1 & A-2 did not permit them with dishonest intention to entertain in to the procurement transactions in their School level. Despite the released of RMSA funds, the A-1 and A-2 together used their powers to procure the furniture through the ulterior intention firm.

The State Project Director, ஒருங்கிணைந்த பள்ளிக்கல்வி திட்டம், (Samagra Shiksha Scheme) Directorate of State Project, Chennai-6 had issued a Proceedings to the Chief Educational Officers vide Letter No. ந.க 2863/ஆ6/ஒபக/2019, dated 30.03.2020, in which stated that

"அனுமதிக்கப்பட்ட தொகையினை பள்ளி மேலாண்மை வளர்ச்சி குழுவிற்கு விடுவித்து நிதி கொள்முதல் கையேட்டில் உள்ள நடைமுறைகள் மற்றும் விதிமுறைகளை தவறாமல் பின்பற்றி தளவாட பொருட்கள் மற்றும் இதர பணிகள் மேற்கொள்ளுவதற்க்கு பள்ளி மேலாண்மை வளர்ச்சி குழுவிற்கு அறிவுறுத்துமாறும் அவ்வாறு மேற்கொள்ளும்போது உரிய பயன்பாட்டு அறிக்கை மற்றும் பதிவேடுகள் முறையாக பராமரிக்கப்படவேண்டும் என்பதை திருச்சிராப்பள்ளி மாவட்டதிட்ட ஒருங்கிணைப்பாளர்/முதன்மைக்கல்வி அலுவலர் அறிவுறுத்தப்டுகிறது"

and had released the RMSA funds to the CEO, Tiruchirappalli for following 4 Government High Schools in Tiruchirappalli District as follows:

A-3 had issued her Proceedings to the Head Masters/Head Mistress vide Letter No. ந.க எண்.20/கட்டுமானப்பணி/ஒபக/2020–21, dated 24.06.2020, in which stated that

"பெறப்பட்ட மேலாண்மை வளர்ச்சிக் நிதியினை பள்ளி குழுவிறக்கு விடுவித்து நிதி கொள்முதல் கையேட்டில் உள்ள நடைமுறைகள் மற்றும் விதிமுறைகளை பின்பற்றி தளவாட பொருட்கள் பணிகள் மற்றும் மேற்கொள்வதற்க்கு சார்ந்த இதர பள்ளி தலைமையாசிரியர்களுக்கு இதன் வழி அனுமதித்து ஆனையிடப்படுகிறது"

and had released the RMSA funds to the SMDC Account of concerned Schools for following 4 Government High Schools in Tiruchirappalli District as follows:

The sanctioned amount of Rs.13,28,000/- have been credited to the schools concerned through PFMS / ECS.

Preliminary Enquiry reveals that the above said 4 Head Masters had procured the furniture from private firm instead of invoking procurement by way of limited tender. They utilized the RMSA Scheme funds below the limited level of invoking Tender except the Government High School, Alagagoundanpatti.

A-9 was procured the furniture from private firm instead of invoking procurement by way of limited tender. The A-3 and A-2 did not permit A-9 to entertain into the procurement transactions in his School level instead by invoking their supervisory powers in the capacity as an District Programme Coordinator and also the A-3 and A-2 with dishonest intention to commit fraud on the RMSA scheme funds instructed the A-9 as receive the furniture from whom they permitted to supply and issue the cheque in the name of private firm hand it over to the A-2. In pursuance Criminal conspiracy, the A-9 also had given his cooperation to follow the A-3 & A-2 instruction with ulterior motive during procuring in private firm, instead of invoking RMSA Scheme procurement guidelines. To avoid implementation of Limited Tender for procuring furniture to the School, the A-3, A-2 with dishonest intention wrongfully guided the Head Master(A-9) and colluded with him by procuring through private firm.

Preliminary Enquiry reveals that the guidelines issued by the State Project Director, ஒருங்கிணைந்த பள்ளிக்கல்வி திட்டம். (Samagra Shiksha Scheme), i.e. during procurement of Furniture and Lab equipments for Schools in the RMSA Scheme that the Chief Educational Officer/District Programme Co-ordinator should ensure that the above fund is properly spent as per the Samagra Shiksha MANUAL on Financial Management and Procurement.

Preliminary Enquiry reveals that as per the guidelines issued by the State Project Director, ஒருங்கிணைந்த பள்ளிக்கல்லி திட்டம், (Samagra Shiksha Scheme) that the school grant fund should not be used for any other activities and it is only for appropriate activities. The A-3 was working as Chief Educational Officer/District Programme Co-ordinator, Trichy District during the period

between 13.06.2019 and 21.10.2020, A-3 had sanctioned Rs.61,28,000/- to 10 Schools through her two proceedings in Nos. 1) ந.க.எண். 20/கட்டுமானப்பணி/ஒபக/2020 – 21, நாள்.24.06.2020 2)ந.க.எண்.71/ஓபக/கப/2019, நாள்.21.08.2019 from the total grant of Rs.1,23,51,000/-, in which the A-2 also made initial sign in the proceedings. Though they had released the funds to the Schools concerned, did not ensure the State Project Director's instruction through the Head Masters as to procure the furniture as per the Samagra Shiksha MANUAL on Financial Management and Procurement. The Preliminary Enquiry further reveals that on or before 21.10.2020, the A-3 entered into Criminal conspiracy with A-2 with dishonest intention to commit fraud on the funds of the Government. In pursuance of the Criminal conspiracy, the A-3 and A-2 did not permit the Head Masters to entertain into the transactions instead by invoking their supervisory powers. It is clearly shows that the commission of cognizable offence made by the A-3.

Preliminary Enquiry reveals that the Head Masters of Government High/Higher Secondary Schools (1) Tr.R.Rajendran, GHSS Kanakiliyanallur, (2) Tr.S.Sargunan, GHS Oonaiyur, (3) Tmt.L.K.Akila, GHS Inammathur, (4) Tmt.T.Daisy Rani, GADWHS Thuraiyur, (5) Tr.J.Jaisingh, GHSS Vembanoor and (6) Tr.S.Kannan, GHSS Alagagoundanpatti who were received the RMSA scheme funds had procured the furniture for their Schools through Private firm without following the Limited Tender procedures knowingly. Though the guidelines issued by the State Project Director and Samagra Shiksha Manual on Financial Management and Procurement, the A-4 to A-9 intentionally violated the Tender procedure during invoking of procurement at the cost of Rs.2.5 Lakhs and above with dishonest intention to swindle the Scheme funds and also came to know that they aided to the swindler.

The Preliminary Enquiry has further revealed that a mere glimpse of the invoices would apparently shows that signatures found on the revenue stamp, few invoices shows that not found the revenue stamp and in few Schools

documents shows that even quotations were also not obtained and only found. that invoice bills of the furniture. Further revealed that the Suppliers(5) of Furniture are not approved by the School Education Department.

The Preliminary Enquiry clearly makes out cognizable offence against A-1 to A-9 in which they have committed the offences u/s 120(B), 409 IPC and 13(2) r/w 13(1)(a) of Prevention of Corruption Act-1988(as amended in 2018). Prior approval u/s 17(A)(1) of the Prevention of Corruption Act-1988 (as amended in 2018) was obtained from the Secretary to Government, School Education [SE1(2)] Department vide proceedings in G.O.(1D) No.150, dated.03.11.2023 against A-1 to A-9 for taking up a regular case.

Therefore, I register a Case in Trichy V&AC Cr.No.02/2024, u/s 120(B), 409 IPC and 13(2) r/w 13(1)(a) of Prevention of Corruption Act-1988(as amended in 2018). Prior approval u/s 17(A)(1) of the Prevention of Corruption Act-1988 (as amended in 2018 on 05.02.2024 at 12.00 hrs., The Original FIR was sent to the Hon'ble Special Judge for PC Act Cases, Tiruchirappalli and other copies were sent to the Officers concerned.
