## Submitted :-

I (S.Peter Paul Durai), Deputy Supdt. of Police, Vigilance and Anti-Corruption, Thoothukudi Detachment while was on duty on 18.09.2024, I received a confidential official memorandum of Director of Vigilance and Anti-Corruption, Chennai dated

06.09.2024 instructing to register a case on the outcome of Vigilance Report.

Based on the information pertaining to the registration of F.I.R today 18.09.2024 at 14.00 hrs, as per the instruction in memorandum No.V.R.No.03/2022 (1703)/HR&CE/TK, dt.14.08.2024 of the Directorate of Vigilance & Anti-Corruption, Chennai, along with the prior permission accorded by the Principal Secretary to Government, Chennai u/s 17(A) of the Prevention of Corruption Amendment Act 2018 in Govt. Lr.(MS.) No.235/RE2-2/2023, Tourism, Culture and Religious Endowments (RE 2-2) Dept, dt.11.07.2024. Registered the case in Thoothukudi V&AC, Cr.No. 05/2024, u/s 7(a) of the Prevention of Corruption Act 1988 (as amended in Act 16 of 2018) on 18.09.2024 and submit as under:

The following information was gathered during the collection of Vigilance intelligence against the accused officer Tr.C.Kumaradurai, Joint Commissioner, Madurai Region, i/c Arulmigu Subramaniyasamy Thirukovil, Tiruchendur, Thoothukudi District.

The accused Tr.C.Kumaradurai working as a Joint Commissioner of Madurai Region, and he was holding Additional charge of Joint Commissioner

of Arulmigu Subramaniyasamy Thirukovil, Tiruchendur from 27.10.2021 to 10.05.2022.

The accused is the Public Servant within the ambit and purview of section 21 of the Indian Penal Code as well as section 2(c) of Prevention of Corruption Act 1988 (as amended in Act 16 of 2018).

During the year 2007, Tamil Nadu Government formed Six Archakar Payirchi Palli (Priests' Training School), which train priests from all communities. The Schools located in Tiruvannamalai, Madurai, Palani and Tiruchendur train the priests in Saivite tradition, and two schools in Arulmigu Parthasarathy Swamy temple in Chennai, Arulmigu Aranganathar Swamy temple, Srirangam train priests in Vaishnavite tradition. All these six schools comes under the administrative control of Commissioner, HR&CE, Chennai.

As per Rule, 7 of HR&CE Act 1959, the Executive Officer/Joint Commissioner shall be in charge of Archakar Payirchi Palli located at Arulmigu Subramaniyasamy Thirukovil, Tiruchendur and as such the accused Tr.C.Kumaradurai is the administrator of staffs of this Priests' Training School.

One Tr.M.Balamurugan, S/o.Meenatchisundaram is working as a Headmaster at Archakar Payirchi Palli located at Arulmigu Subramaniyasamy Thirukovil, Tiruchendur from the year 2007. For the past 4 years, he is 100% blind and before that he was 75% blind and as such he is a handicapped person. There are some defects in the fixation of pay under 7th Pay Commission for Tr.Balamurugan and if the fixation is rectified, Tr.Balamurugan will get about 10 Lakhs arrears. Hence Tr.Balamurugan preferred a petition to Commissioner of HR/CE to rectify 7th Pay Commission Pay anomalies and accordingly, Commissioner of HR/CE called some report from Joint Commissioner of Arulmigu Subramaniyasamy Thirukovil, Tiruchendur and it is pending.

The accused Tr.C.Kumaradurai, Joint Commissioner of Arulmigu Subramaniyasamy Thirukovil, Tiruchendur, came to know that if the pay

anomaly was rectified, Tr.Balamurugan will get 10 Lakhs arrears. The accused made Faustian bargain with Tr.Balamurugan and demanded 3 Lakhs illegal gratification as quid pro quo to give favourable reports to the Commissioner for fixation of Seventh pay scale and payment of arrears.

Tr.M.Balamurugan, a blind Headmaster who is not fit to travel freely decided to give a part of bribe to accused and also decided to record the event of giving bribe to accused for taking legal action against accused. On 17.12.2021 at about 12 hrs, Tr.M.Balamurugan met accused at the office of the Joint Commissioner with Rs.50,000/-, keeping his mobile audio recording in ON position and took Rs.50,000/- from his bag and placed it on the office table of Joint Commissioner and asked the accused to accept it for giving favourable During their conversation, accused Tr.C.Kumaradurai asked Tr.M.Balamurugan that whether Tr.Balamurugan was giving the amount as advance and Tr.M.Balamurugan also replied affirmative and in reply Tr.C.Kumaradurai took the amount from his table and gave it to Tr.Balamurugan and told that there is CCTV camera in his room and hence gave instruction to Tr.M.Balamurugan to give the illegal gratification to Siva, the Duffedar of Joint Commissioner and Tr.Balamurugan came out of Joint Commissioner room and gave Rs.50,000/- to Tr.P.Sivanandham, the Duffedar and P.Sivanandham accepted it at the next room where no CCTV camera is installed. The voice conversation made between Tr.Balamurugan and Tr.C.Kumaradurai was recorded in the mobile phone of Tr.M.Balamurugan.

The act of the accused Tr.C.Kumaradurai in demand and acceptance of undue advantage with the intention to perform public duty dishonestly and obtained the said Rs.50,000/- with an illegal motive by abusing his position as a public servant constituted offence u/s 7(a) of the Prevention of Corruption Act 1988 (as amended in Act 16 of 2018).

The above said facts prima facie discloses the accused commission of offences of u/s 7(a) of the Prevention of Corruption Act 1988 as amended Act

16 of 2018 and there are prima facie materials available for taking investigation against the accused.

Hence I am registering a case in Thoothukudi Vigilance and Anti-Corruption Crime No.05/2024, u/s 7(a) of Prevention of Corruption Act 1988 (as Amended in Act 16 of 2018).

The original F.I.R is submitted to the Hon'ble court of the Chief Judicial Magistrate cum Special Judge, Thoothukudi and as per instructions; I am sending a copy of FIR to Tmt.M.Sudha, Inspector of Police, Vigilance and Anti-Corruption, Thoothukudi for taking up investigation and other copies of the FIR are sent to officers concerned.
